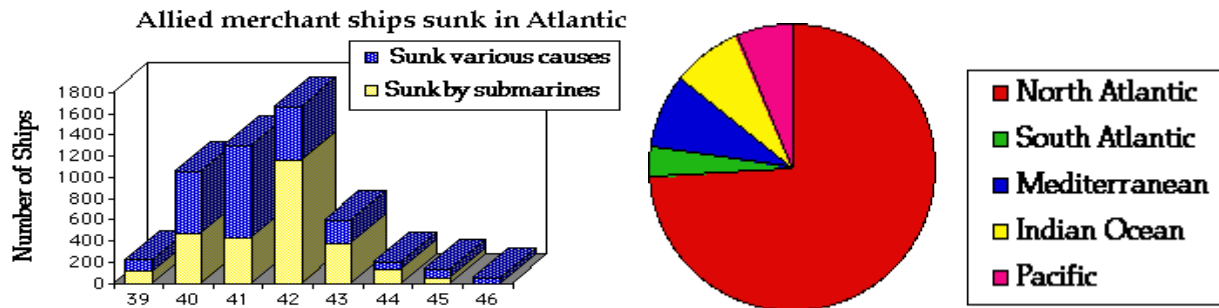

From 1939 to 1943 in four years alone 12,000 ships were lost on the allied side without counting enemy losses. By the end of the war in 1945 as mentioned previous a recorded 36,387 submarines, navy and merchant ships had been lost on both sides.

It had only been 20 years since WW1 had finished in 1918 the settlements of WW1 had not been very wise or fair on the German people. This built much resentment and hatred into the German population towards the controlling European nations who confiscated German territory and forced Germany and its people to pay for reparations. This was during hard times in Germany's own economic situations that were out of control by the 1920's. The reparations forced upon Germany were to help rebuild France and repay WW1 allied war debt to the USA. The German people never believed they had been defeated in WW1 but rather betrayed on the western front by their incompetent leaders and their own weak politicians at home. This caused Europe to become a time bomb ready to explode again due to the unresolved resentments left from WW1. There was also the Vatican agenda of political and religious involvements alliances and interests that helped contribute to the WW2 (2nd Trumpet) conflict.

Rev 17:1 -5 Then one of the seven angels who had the seven bowls came and talked with me, saying to me, "Come, I will show you the judgment of the great harlot who sits on many waters, with whom the kings of the earth committed fornication, and the inhabitants of the earth were made drunk with the wine of her fornication." So he carried me away in the Spirit into the wilderness. And I saw a woman sitting on a scarlet beast which was full of names of blasphemy, having seven heads and ten horns. The woman was arrayed in purple and scarlet, and adorned with gold and precious stones and pearls, having in her hand a golden cup full of abominations and the filthiness of her fornication. And on her forehead a name was written: MYSTERY, BABYLON THE GREAT, THE MOTHER OF HARLOTS AND OF THE ABOMINATIONS OF THE EARTH. I saw the woman, drunk with the blood of the saints and with the blood of the martyrs of Jesus. And when I saw her, I marveled with great amazement. (NKJV)

Both sides of the coin were played by the Vatican. Truly as Rev 17 states about the “Whore of Babylon” she has fornicated with the nations and has become drunk with the blood of the martyrs. The beast /Holy Roman Empire that the wicked woman/Vatican rides truly breaks the world into pieces and tramples the residue with its feet as scripture states. In Germany, the Papal Nuncio in Berlin, Mgr. Pacelli and Franz von Papen, privy Chamberlain to the Pope, advocated a ‘union with Rome’ and concentrated on the overthrow of the Weimar Republic. The German Catholics were hostile to Nazism, but were informed that the Pope himself was ‘favourably disposed towards Hitler.’ Consequently the Catholic Zentrum, axis of all parliamentary majorities, voted full rights to Hitler on January 30, 1933.

This operation was promptly followed, as in Italy, by the concluding of a Concordat which was most advantageous to the Roman church. The German Episcopate swore allegiance to the Fuhrer and Catholic Youth organizations combined with those of the Nazis. — Edmond Paris, *The Vatican against Europe*, The Wickliffe Press, page 15.

The Vatican helped Hitler to gain power and then helped him consolidate his grip on Germany. This was done in part by ‘advising’ the Catholic Party of Germany to vote for Nazi candidates. The Catholic vote gave Hitler the majority he needed to legally form a government in 1933. Further to this, the Vatican ordered Catholic members of the Reichstag Parliament to support legislation giving Hitler the power to rule by decree. This measure gave Hitler the dictatorial power he needed to destroy the German Communists. The whole Vatican-Hitler bargain had been conducted in secret before Hitler became Chancellor of Germany in January 1933. In June of the same year, Hitler and the Vatican signed a Concordat, under terms of which the church swore allegiance to the Nazi regime....

Soon afterward, Catholic Franz von Papen, the second in command to Hitler, put the essence of the Hitler-Vatican alliance very succinctly in these words: “The Third Reich,” he said, “is the first power which not only recognizes, but puts into practice, the high principles of the Papacy.” — Avro Manhattan, *The Vatican Moscow Washington Alliance*, Ozark Books, (quoted in Sydney Hunter, *Is Alberto for Real*, Chick Publications, pp. 42, 43)

“The Treaty of Paris of 1763 designated King George III “Arch-Treasurer and Prince Elector of the Holy Roman Empire.” And “according to the Encyclopedia Judaica [sic] the Rothschild’s bear the title “Guardians of the Vatican Treasury.” The Vatican Treasury, of course, holds the imperial wealth of Rome. Imperial wealth grows in proportion to its victories in war — as the Jesuit empowerment *Regimini militantis ecclesiae* implies, the Church-at-War is more necessary than the Church-at-Peace. According to H. Russell Robinson’s illustrated *Armour of Imperial Rome*, Caesarean soldiers protect themselves in battle with shields painted red. Since the soldiery is the State’s most valuable resource (the Council of Trent admitted this in preferring the Jesuits to all other religious orders), it is easy to understand why the red shield was identified with the very life of the Church. Hence, the appropriateness of the name Rothschild, German for “red shield.”

Hitler believed that Islam was a religion for real men that lacked the flabbiness of Christianity and the filthiness of Judaism. The article also says that even though Muslim people fought on both sides of WW2, the Islamists fought mainly on the side of the Nazis. The Nazis even allowed Muslim people to enroll to the SS, and the Grand Mufti of Jerusalem, a famous Nazi collaborator, was recruiting Muslims for the SS. The Grand Mufti of Jerusalem was the man who convinced Hitler to exterminate the Jews of Europe, because the Jews who were leaving Europe were ending up in Jerusalem, where the Arabs and the Jews were fighting for Palestine. The Grand Mufti of Jerusalem was one of the closest associates of Hassan al-Banna, the man who founded the Muslim Brotherhood in Egypt in 1928, and who was another famous Nazi collaborator. For al-Banna’s alliance with the Nazis see Wikipedia “Relations between Nazi Germany and the Arab world : Fundamentalist Panislamists”. The two battles that cost Hitler the Second World War were the Battle of El-Alamein (Egypt) and the Battle of Stalingrand (Russia). Therefore it was very normal that the Germans were trying to find allies in Egypt, and the Arab World in general, given that during WW1 the British had liberated the Arabs from the Ottomans, and they had very strong connections in the Arab World.

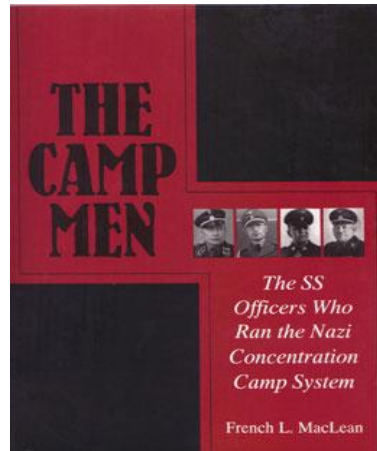

In the book “**The Camp Men: The SS Officers Who Ran the Nazi Concentration Camp System**” by French L McLean: it demonstrates with irrefutable proof from the official SS personnel file for each officer, almost half of the concentration camp officers (419) also served in *Waffen-SS* combat divisions. Sixteen fought in the *Leibstandarte*, 39 with the *Das Reich*, 159 with the *Totenkopf* (which explicitly was linked to the camp system,) 45 with the *Wiking*, 57 with the *Nord* Division and so on down the line. In fact, six former concentration camp officers actually served as division commanders in the *Waffen-SS*.

Hitler & Islam

Islam's Muslim Brotherhood was founded in Egypt in 1928 by Hassan al-Banna, a 22 year old Muslim who admired Hitler's hatred of the Jews and persistently wrote to Hitler to express his admiration for Hitler and his desire for collaboration with Hitler's Nazi Party.



When Hitler rose to power, his Nazis supported al-Banna, a school teacher, to grow the Muslim Brotherhood into its ally in the Middle East; by 1938, the membership of Muslim Brotherhood topped 200,000. During World War II, members of the Muslim Brotherhood spied for Hitler's Nazis in the Middle East and fought for Hitler as Nazi troops in two specially formed Muslim *Waffen-SS* Handschar

Divisions. 'Handschar' is German for scimitar, the curved saber used by the Islamic troops of the Ottoman empire.



Above is Hitler with Haj Amin al-Husseini, the Grand Mufti of Jerusalem and a close ally of al-Banna, in Berlin, where he lived as Hitler's VIP guest from 1941 to 1945 before joining al-Banna in Egypt in 1946. The Muslim Nazi troops of the Waffen-SS Handschar Divisions are being reviewed by Haj Amin al-Husseini (right) and by SS Reichsfuhrer Heinrich Himmler (below).



Due to their large number of volunteers, Handschar Divisions were the largest of Hitler's 38 Waffen-SS Divisions. After World War II, Muslim Brotherhood continued to grow, supported this time by the West, which saw it as a counterweight to the threat of Soviet-backed Communism in the Middle East.

Even today in Germany Chancellor Merkel has invited millions of Muslim refugees into Germany proclaiming Germany will eventually become a Muslim nation due to its historic involvement as allies to the Arab Islamic people. The above pictures give one a clue of the historic symbolism of events from ancient history into modern history signs of the times so to speak of Satan’s influences on the realms on Earth. It was Vatican Jesuit influence through the Federal Reserve banks that rebuilt and strengthened Germany under Hitler after WW1 and the European “Treaty of Versailles” that had brought it to ruin. Italy's ambassador to the Vatican City was Galeazzo Ciano whom was Mussolini's son in law. The Vatican City never publicly condemned the Nazi systematic extermination of various groups which included its own Catholics or its racism against the Jews.

Immense sums belonging to our national-bank depositors have been given to Germany on no collateral security whatever... Billions upon billions of our money has been pumped into Germany by the Federal Reserve Board and the Federal Reserve Banks... It was Benito Mussolini who was esteemed among the Jesuits to become their man of the hour who restored the Vatican City to the Papacy in February 1929 under the “Lateran Treaty” signed by Mussolini

and secretary of State Pietro Gasparri. This treaty empowered the Vatican to become its own nation under its own law the then Pope became a Pope King of its own nation further fulfilling scriptural prophecy in Rev 17 (*see chapter 40 If the Pope is not the false prophet then who is he ?*). The Vatican had been defeated as a powerful influence from the wars of Napoleon who defeated and dis-empowered it as the “Holy Roman Empire” in 1798 AD. The last reigning Pope in 1798 AD was Pope Pius VI whom Napoleons French general Berthier had arrested and imprisoned. Napoleon also changed the age old “Roman Code of Law” that had been put in place by Emperor Justinian in 529 AD designed to persecute heretics. The last ruling Holy Roman Emperor had then resigned in 1806.

It was in 2006 that the Vatican opened archives along with other church archives releasing information and documentation bringing light to its involvements of alliances of WW2. This can be seen in the excerpt below from a conversation on www.Amazon.com by author David Kertzer of the book: **“The Pope and Mussolini”**: The Secret History of Pius XI and the Rise of Fascism in Europe. This book was written from 7 years of archival research.

Perhaps the most dramatic what could even be called a kind of “smoking gun” was the three page text of a secret agreement between the Vatican and Mussolini reached two weeks before the racial laws were first announced. The trail of documents I unearthed shows the pope’s shadowy, but fascinating, Jesuit personal envoy to Mussolini, Pietro Tacchi Venturi, spending the days before the agreement going back and forth between the pope and the dictator to work out an accord. Shockingly, it states the Vatican’s agreement to make no objection to the racial laws as long as they were no more repressive than the popes’ own restrictions on the Jews in the days of the Papal States. And in fact the laws that were soon announced expelling all Jewish students from the schools, firing all Jewish teachers, forbidding Jews from holding other positions of influence were similar to those that had been in effect in Rome as long as the popes held power there.

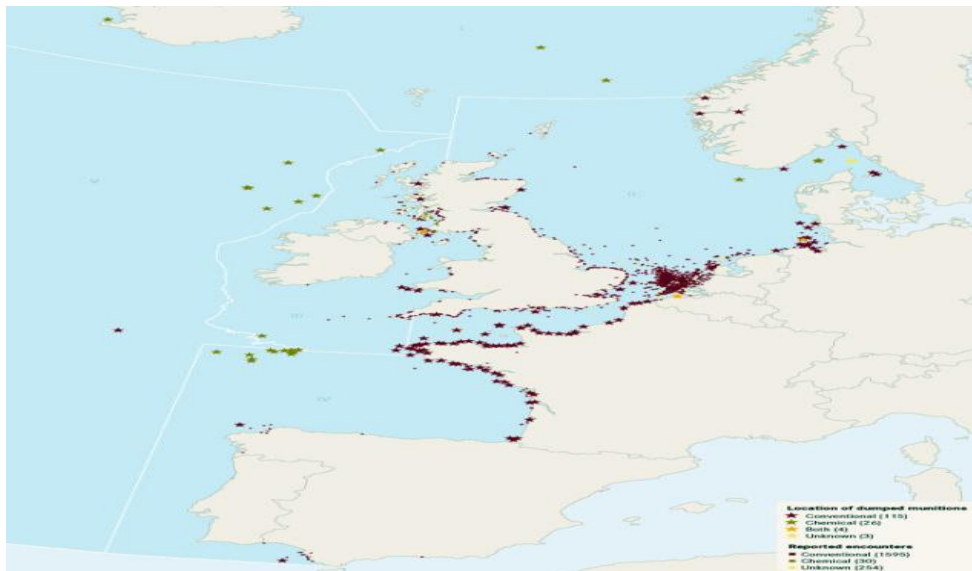

Chemical Weapon Munitions Dumped at Sea

January 29, 2013



160,000 tons of chemical weapons may be buried in Russian seas

In the decades following World War I, and even more so after World War II, at least three major powers disposed of massive quantities of captured, damaged, and obsolete chemical warfare (CW) material by dumping them in the oceans. According to U.S. Department of Defense reports, the U.S military alone dumped CW agents in waters worldwide on at least 74 occasions between 1918 and 1970. The jettisoned material consisted either of munitions containing chemicals (such as artillery and mortar shells or bombs) or chemicals encased in some manner in, for example, bulk containers made out of metals or cement.

Shells and bombs sometimes were jettisoned unfettered, but more often were loaded as cargo into ships that were sunk by opening sea cocks or holed by artillery fire or torpedoes. Sunken ships tended to settle on the ocean floor largely intact, with the result that the CW material they contained remained within a small area. Unfettered material could settle within a small area, but also might become widely dispersed by currents, tides, and other forces. As can be realized, not much consideration was given at the time to the safety and environmental implications of employing ocean-dumping disposal techniques.

Some dumping operations were carefully undertaken, including the keeping of records of where the dumping occurred, a listing of the material that was dumped, and the quantities of dumped material. Other dumping was done haphazardly with no or minimal records being written and kept. In particular, the USSR (and now Russia) has provided hardly any records to the international community of its sizeable chemical dumping activities.

The potentially enormous problem posed by Soviet ocean-dumped chemical material is demonstrated by Russia having admitted that “at least 160,000 tons of chemical weapons may be buried in Russian seas, posing a grave threat to ecology and the health of man.” For these reasons, the total quantity of CW material discarded at sea will never be known precisely, but most likely is on the order of several hundreds of thousands of tons. To demonstrate the quantities involved, after World War II 302,857 tons of CW ammunitions were left over in just Germany and the United Kingdom, most of which were eventually dumped in the oceans.

Dumped WWII Chemical Munitions Still Affecting Fish

July 13, 2014 at 22:00

Thousands of tonnes of chemical warfare agents were dumped into the Baltic Sea after the Second World War. A recent study has shown that fish caught near the dumping grounds show high levels of genetic and cell damage, revealing the long legacy of these toxic substances.

A large portion of the poisonous chemicals used in the Second World War were disposed of at sea. After the war, they were thrown overboard at designated sites, mainly in the Bornholm and Gotland basins of the Baltic Sea. These substances included sulphur mustard (blister gas); Clark and other types of arsines (e.g. Clark 1, or diphenyl arsine, is a gas which causes vomiting); arsenic-containing Adamsite (also a nose and throat irritant); and α -chloroacetophenone (tear gas). Arsenic and mustard warfare agents have been found in sediments at dumping sites, evidence that the chemicals can leak from damaged or corroded casings and contaminate the surrounding area reports thefishsite.com

This study, partly funded by the EU through the CHEMSEA project, investigated cell and genetic damage of fish living in the dumping zones in the Bornholm Basin of the Baltic Sea. The area is important as a spawning ground for commercially valuable fish species.

The researchers collected samples of flounder (*Platichthys flesus*), herring (*Clupea harengus*) and cod (*Gadus morhua*), caught with standard bottom trawls at 42 study stations in the Bornholm Basin from November 2010 to February 2012. Flounder, herring and cod samples had previously been taken from four other sites in the same area in 2003, 2004 and 2009 and these were used for comparison with the 2010-2012 samples. The 2010-2012 sampling campaign included 188 flounder from 23 stations, 307 herring from 31 stations and 127 cod from 10 stations. They then examined blood samples taken from the fish for evidence of damage to red blood cells. Abnormalities in cellular structures, such as changes in the nucleus, are indicative markers of genotoxicity and cytotoxicity – damage to cells and genetic material – caused by toxic chemicals.

Extremely high genotoxicity risk levels for flounder were found at 21 of the 23 stations, compared to reference levels taken from fish in uncontaminated areas, for herring at 29 of the 31 stations and for cod at 5 of the 10 examined stations.

The researchers also found that fish from the 42 stations in 2010-2012 had substantially higher levels of genetic damage compared to samples taken between 2003-2009. The study's authors suggest that recent undersea construction projects, for instance, the laying of gas pipelines and cables and mine clearance between 2008 and 2011, may have disturbed the dumped munitions. This suggests that the effects of such activities on marine life in the area should be closely monitored.

Although the Baltic Sea is highly contaminated with other pollutants originating from human activities, the highest genotoxicity risk areas were found in or close to known warfare dumping zones, suggesting that chemical warfare agents were the most likely cause of the cellular damage seen in the fish.

Overall, the study highlights the value of using fish as indicators of the pollution caused by chemical warfare agents dumped in the Baltic Sea, the researchers conclude.

Experts: WWII Chemical Weapons Threats to Baltic Sea Marine Life

“Our research has shown that in the Gotland Deep there are about 8,000 shells and missiles that could pollute the environment. We have now confirmed that these objects are contaminating the seabed. Until now we could only speculate this would happen.”

The above statement was released by Doctor Jacek Bedowski of the Polish Institute of Oceanography pertaining to the 65,000 tons of unused chemical weapons and chemical weapons agents dumped into the Baltic Sea sometime after the occurrence of World War II.

Even if the Baltic regions is pervaded with cold temperatures that has converted mustard gas into a massive sticky solid, the fact is, it is still highly toxic and scientists involved in the Baltic caution about the long-term and serious adverse effects it brings into the sea’s marine ecosystem.

Doctor Bedowski has pointed out that his team of researchers have already found higher fish mortality rate within the expanse of the polluted area and a number of fish species are found to have genetic defects caused by the chemicals.

Granting that the chances of people coming in contact with the mustard gas lying in the Baltic’s seabed are dim, the doctor added that what poses as a real threat is the consumption of the contaminated fishes. Additionally, though there were designated dumping zones at the time these weapons were disposed, it seems that the Russians failed to adhere to these designations and nobody knows just where all the chemical weapons lie.

WWII-Era Chemical Agents In Sea Drifting Close to Poland

October 30, 2013 at 05:45



Chemical-warfare materials dumped in the ocean after World War II have been discovered by scientists drifting closer to Polish territory than was previously known, United Press International reported on Monday. A minimum of 15,000 metric tons of German chemical armaments were demilitarized by Russian and U.K. forces by being poured into the Gotland Deep — an 800-foot-deep Baltic Sea basin positioned between the Baltic states and Sweden.

The dumped chemical agents included mustard blister agent and tabun nerve agent. Researchers with the Polish Military University of Technology carried out a comprehensive study of samples collected from the bed of the Gulf of Gdansk — a southeastern bay in the Baltic Sea — and discovered small amounts of mustard agent. They were only several hundred meters away from the Polish presidential resort near Gdynia, according to a report by the television channel TVN24.

“We found contamination in both the Gulf of Gdansk and in the Bay of Puck,” which is an inner basin of the Bay of Gdansk, said Stanislaw Popiel, who works at the military university. The university and the Polish Naval Academy are participating in the European Union’s Chemsea project, which aims to track and classify all of the Baltic Sea sites where chemical munitions were dumped.

“If this data is confirmed, you either have facilities in the Gulf of Gdansk which no one ever knew of, or there is a far greater spread of these compounds in the sediment than we thought,” Chemsea project coordinator Jacek Beldowski said.

Researchers believe the moldering chemical agent still represents a danger to the surrounding marine life as well as to nearby fishermen and beach-goers that might come across washed-up munitions.

World War II bombs, mustard gas in Gulf of Mexico need to be checked, experts warn

on September 29, 2012 at 18:00



Oil and bombs don't mix, yet there's millions of pounds of unexploded World War II munitions dumped in the Gulf of Mexico that pose a risk to offshore drilling and the environment, researchers say. The military carried out the dumping from 1946 to 1970 — including off the Pacific, Atlantic and Hawaii coasts — so it's no secret. But now that some of the containers used to store the munitions are more than 60 years old, the researchers say it's time to see them as a threat.

“The bottom line is that these bombs are a threat today and no one knows how to deal with the situation,” Texas A&M oceanographer William Bryant said in a statement ahead of a briefing he'll give at a weapons disposal conference. “If chemical agents are leaking from some of them, that's a real problem. If many of them are still capable of exploding, that's another big problem.” Photos taken during surveys show that some of the chemical weapons canisters, such as those that carried mustard gas, appear to be leaking materials and are damaged, Bryant and others on his team reported. The surveys have turned up 10 dump sites at 60 and 100 miles out — and one of them had a pipeline running through it.

Texas has the closest dump, followed by Louisiana, “not far from where the Mississippi River delta area is,” Bryant said. “Some shrimpers have recovered bombs and drums of mustard gas in their fishing nets. “No one seems to know where all of them are and what condition they are in today,” he added. “The best guess is that at least 31 million pounds of bombs were dumped, but that could be a very conservative estimate.

“These were all kinds of bombs, from land mines to the standard military bombs, also several types of chemical weapons,” he said. “Our military also dumped bombs offshore that they got from Nazi Germany right after World War II. “Is there an environmental risk? We don't know, and that in itself is reason to worry,” he said. The hazards pose even more of a risk as the Obama administration and energy companies pick up the pace of drilling after the 2010 BP oil spill. Ironically, unexploded ordnance was found in the offshore zone known as Mississippi Canyon where the BP well was drilled.

Millions of unexploded bombs found along the US coastline

Oceanographers at Texas A&M University looked at two weapons dumpsites in the Gulf of Mexico and found millions of pounds of unexploded ordinances or UXO.

Millions of pounds of unexploded bombs lurk in the Gulf of Mexico and around the US coastline new research suggests. Oceanographers at Texas A&M University looked at two weapons dumpsites in the Gulf of Mexico and found millions of pounds of unexploded ordinances or UXO. “The amount that has been dumped was unbelievable,” said study author William Bryant, according to Fox News. “No one seems to have reported seeing explosives in the Gulf. We felt it was our responsibility to report it.” The researchers estimate that at least 31 million pounds of explosives and other weapons are likely scattered around the US coastline.

Another estimate puts the weight of unexploded weapons under the world's oceans and waterways at around 200 million pounds, said Fox News. The study said that it was no surprise that the weapons ended up in the oceans. Until the early 1970s, when international treaties were signed, many countries regularly dumped munitions and chemical weapons into the water. This included chemical weapons, missiles, bombs and guns. Reuters reported that after the Second World War, the US created a number of disposal areas along the coast. However, it remains unclear how many weapons in the US were given a water burial and whether they pose a danger to the environment. "These bombs are a threat today and no one knows how to deal with the situation," said Bryant, according to Reuters.

"If chemical agents are leaking from some of them, that's a real problem. If many of them are still capable of exploding, that's another big problem." Oil companies drilling off the US coast have long been aware of the presence of unexploded bombs and other weapons of war, which could be accidentally set off by underwater drilling. In 2011, BP and Shell found the remains of a German U-boat near the mouth of the Mississippi River, said the New York Times.
