The feet and toes (Dan 2:42) the "Holy Roman" Empire re-born 2009



The prophecy for this chapter comes from Dan 2:40-45.

Dan 2:40-45 And the fourth kingdom shall be as strong as iron, inasmuch as iron breaks in pieces and shatters everything; and like iron that crushes, that kingdom will break in pieces and crush all the others. Whereas you saw the feet and toes, partly of potter's clay and partly of iron, the kingdom shall be divided; yet the strength of the iron shall be in it, just as you saw the iron mixed with ceramic clay. And as the toes of the feet were partly of iron and partly of clay, so the kingdom shall be partly strong and partly fragile. As you saw iron mixed with ceramic clay, they will mingle with the seed of men; but they will not adhere to one another, just as iron does not mix with clay.

And in the days of these kings the God of heaven will set up a kingdom which shall never be destroyed; and the kingdom shall not be left to other people; it shall break in pieces and consume all these kingdoms, and it shall stand forever. Inasmuch as you saw that the stone was cut out of the mountain without hands, and that it broke in pieces the iron, the bronze, the clay, the silver, and the gold the great God has made known to the king what will come to pass after this. The dream is certain, and its interpretation is sure." (NKJV)

The Dan 2:40-45 prophecy speaks about how the fourth and last Roman Empire (Legs of Iron) is two parts it then morphs into the Holy Roman Empire (Dan 2:42 feet of Iron and clay) to be ultimately in power prior to Christ's return. The Roman Empire first part of this Roman Empire was in full power prior to and after Christ's birth from 146 BC to 284 AD. Up until 313 AD Christians were under constant Roman Persecution until Constantine signed the treaty of Milan in 313 AD protecting Christians in Rome this started a merger of Rome and Roman Christians that eventually formed the mixed false Roman Catholic religious system.

The actual Holy Roman Empire came into being officially as a world power on December 25th 800 AD when King Charlemagne was anointed by Pope Leo 3rd as the first Holy Roman Emperor. The depiction of the feet and iron of clay represents the Holy Roman Empire coming onto the world scene as church and state political power (Rev 17). This empire would be here at Christ's return, He then destroys this last Empire. The Rev 13 beast and false prophet appear out of this last Holy Roman Empire in the end of days, prior to the great and dreadful day of the Lord the 7th Trumpet of God's wrath.

The Holy Roman Empire (Latin: Sacrum Romanum Imperium; German: Heiliges Römisches Reich) was a multi-ethnic complex of territories in Western and Central Europe that developed during the Early Middle Ages and continued until its dissolution in 1806 during the Napoleonic Wars. The largest territory of the empire after 962 was the Kingdom of Germany, though it also came to include the neighboring Kingdom of Bohemia, the Kingdom of Burgundy, the Kingdom of Italy, and numerous other territories.

On 25 December 800, Pope Leo III crowned the Frankish king Charlemagne as Emperor, reviving the title (Emperor over the Roman Empire, the Holy Roman Empire term was not used until the 13th century) in Western Europe, more than three centuries after the fall of the earlier ancient Western Roman Empire in 476. The title continued in the Carolingian family until 888 and from 896 to 899, after which it was contested by the rulers of Italy in a series of civil wars until the death of the last Italian claimant, Berengar I, in 924.

The title was revived again in 962 when Otto I was crowned emperor, fashioning himself as the successor of Charlemagne and beginning a continuous existence of the empire for over eight centuries. Some historians refer to the coronation of Charlemagne as the origin of the empire, while others prefer the coronation of Otto I as its beginning. Scholars generally concur, however, in relating an evolution of the institutions and principles constituting the empire, describing a gradual assumption of the imperial title and role.

The exact term "Holy Roman Empire" was not used until the 13th century, but the concept of translatio imperii, the notion that he—the sovereign ruler—held supreme power inherited from the ancient emperors of Rome, was fundamental to the prestige of the emperor. The office of Holy Roman Emperor was traditionally elective, although frequently controlled by dynasties. The mostly German prince-electors, the highest-ranking noblemen of the empire, usually elected one of their peers as "King of the Romans", and he would later be crowned emperor by the Pope; the tradition of papal coronations was discontinued in the 16th century.

The empire never achieved the extent of political unification as was formed to the west in France, evolving instead into a decentralized, limited elective monarchy composed of hundreds of subunits: kingdoms, principalities, duchies, counties, prince-bishoprics, Free Imperial Cities, and other domains. The power of the emperor was limited, and while the various princes, lords, bishops, and cities of the empire were vassals who owed the emperor their allegiance, they also possessed an extent of privileges that gave them de facto independence within their territories. Emperor Francis II dissolved the empire on 6 August 1806 following the creation of the Confederation of the Rhine by emperor Napoleon I the month before.

It seemed Napoleons arrest of Francis 11 the last Holy Roman Emperor in 1798 ended the empire. At the time the French army entered Rome and arrested the Pope through one of Napoleons leading generals. Francis 11 ruled the Holy Roman Empire from 1792 then resigned in 1806 the Holy Roman Empire seemed to be finished as a power all inquisitions also ceased. But the end of an Empire was not the case the Roman Catholic religion and the Vatican Papacy still thrived independently after 1806. Then 113 years later the Vatican gained independence as its own nation state in 1929 under the Lateran Treaty signed by Benito Mussolini and Cardinal Pietro Gasparri representing Vatican and Pope Pius X1.

This recognized Vatican City as an independent state the Vatican had now become its own nation state. The Popes then became Pope Kings over their own kingdom (see chapter 40) no longer having a Holy Roman Emperor of royal blood. The Holy Roman Empire Papal head as a power was re-established now having Papal Kingship creating in essence their own royalty as priests/Popes in the political arena of the world. This 1929 Lateran Treaty boosted the Papacy into establishing the Pope as the leader of a new Holy Roman Empire bringing us into the end

times we now live. The Popes were now recognized by leaders all around the world as if they were royalty to be even given such honor.

What was needed now to further consolidate influence and power for the Vatican was unification of nation states of the Holy Roman Empire, as had been in the past under Holy Roman Emperors. With the devastation of WW1 and WW2 this goal was realized through Winston Churchill who emphasized "We need European Unity (EU) or Russia and America would become the future super states". Winston Churchill gave the call for a "United States of Europe" (now taking place from 2009) he also had a vision of a one world government. Churchill became one of the founders of the modern European Union (Holy Roman Empire nations). As we progress in this chapter towards the end you will see the re—birth in modern times (2009) of the unity and strength of the Holy Roman Empire (New World Order of governance and unity of the nations).

It was Prime Minister Churchill who announced in June 1940 the 'Declaration of Union' between Great Britain and France. With the full backing of his Cabinet, Churchill stated, 'The two governments declare that France and Great Britain shall no longer be two nations, but one France-British Union... Every citizen of France will enjoy immediately citizenship of Great Britain; every British subject will become a citizen of France.'



1 January 1942 the name "United Nations" is coined. The name "United Nations", coined by United States President Franklin D. Roosevelt was first used in the Declaration by United Nations of 1 January 1942, during the Second World War, when representatives of 26 nations pledged their Governments to continue fighting together against the Axis Powers. 24 October 1945 the United Nations officially comes into existence. In 1945, representatives of 50 countries met in San Francisco at the United Nations Conference on International Organization to draw up the United Nations Charter.

Those delegates deliberated on the basis of proposals worked out by the representatives of China, the Soviet Union, the United Kingdom and the United States at Dumbarton Oaks, United States in August-October 1944. The Charter was signed on 26 June 1945 by the representatives of the 50 countries. Poland, which was not represented at the Conference, signed it later and became one of the original 51 Member States. The United Nations officially came into existence on 24 October 1945, when the Charter had been ratified by China, France, the Soviet Union, the United Kingdom, the United States and by a majority of other signatories. United Nations Day is celebrated on 24 October each year.

Comparison between Gilbert Stuart's 1796 Athenaeum Portrait and the image on the obverse of the bill. The image from the dollar bill above shows the subject flipped horizontally for ease of comparison. The portrait of George Washington is displayed in the center of the obverse of the one-dollar bill, as it has been since the 1869 design. The oval containing George Washington is propped up by bunches of bay laurel leaves. To the left of George Washington is the Federal Reserve District seal. The name of the Federal Reserve Bank that issued the note encircles a capital letter (A–L), identifying it among the twelve Federal Reserve Banks.

The sequential number of the bank (1: A, 2: B, etc.) is also displayed in the four corners of the open space on the bill. Until the redesign of the higher denominations of currency beginning in 1996, this seal was found on all denominations of Federal Reserve notes. Since then it is only present on the \$1 and \$2 notes, with the higher denominations only displaying a universal Federal Reserve System seal, and the bank letter and number beneath the upper left serial number. To the

right of George Washington is the Treasury Department seal. The scales represent justice. The chevron with thirteen stars represents the original thirteen colonies. The key below the chevron represents authority and trust; 1789 is the year that the Department of the Treasury was established. The series 1969 dollar bills were the first to use a simplified Treasury seal, with the wording in English instead of Latin.

Below the FRB seal (to the left of George Washington) is the signature of the Treasurer of the United States, and below the USDT Seal (right side) is the Secretary of the Treasury's signature. To the left of the Secretary's signature is the series date. A new series date, or addition or change of a sequential letter under a date, results from a change in the Secretary of the Treasury, the Treasurer of the United States, and/or a change to the note's appearance such as a new currency design.

On the edges are olive branches entwined around the 1s. A small plate serial number-letter combination is on the lower right, and a small plate position (check) letter is on the upper left corner of the note. If "FW" appears before the lower right plate number it indicates that the bill was produced at the satellite Bureau of Engraving and Printing facility in Fort Worth, Texas. Currency has been printed here since Series 1988A. The absence of "FW" indicates the bill was printed at the main facility in Washington, D.C..

Reverse of current \$1 bill: The reverse of the one-dollar bill has an ornate design that incorporates both sides of the <u>Great Seal of the United States</u> to the left and right of the word ONE. This word appears prominently in the white space at the center of the bill in a capitalized, shadowed, and <u>seriffed</u> typeface. A smaller image of the word "ONE" is superimposed over the numeral "1" in each of the four corners of the bill.

"THE UNITED STATES OF AMERICA" spans the top of the bill, "ONE DOLLAR" is emblazoned along the bottom, and above the central "ONE" are the words "IN GOD WE TRUST," which became the official motto of the United States in 1956 by an Act of Congress. Below the reverse of the Great Seal on the left side of the bill are the words "THE GREAT SEAL," and below the obverse on the right side are the words "OF THE UNITED STATES."

The Great Seal, originally designed in 1782 and added to the dollar bill's design in 1935, is surrounded by an elaborate floral design. The renderings used were the typical official government versions used since the 1880s. The reverse of the seal on the left features a barren landscape dominated by an unfinished pyramid of 13 steps, topped by the Eye of Providence within a triangle. At the base of the pyramid are engraved the Roman numerals MDCCLXXVI (1776), the date of American independence from Britain. At the top of the seal stands a Latin phrase, "ANNUIT COEPTIS," meaning "He favors our undertaking." At the bottom of the seal is a semicircular banner proclaiming "NOVUS ORDO SECLORUM" meaning "New Order of the Ages" that is a reference to the new American era. To the left of this seal, a string of 13 pearls extends toward the edge of the bill.

The obverse of the seal on the right features a bald eagle, the national bird and symbol of the United States. Above the eagle is a radiant cluster of 13 stars arranged in a six-pointed star. The eagle's breast is covered by a heraldic shield with 13 stripes that resemble those on the American flag. As on the first US flag, the stars and stripes stand for the 13 original states of the union. The eagle holds a ribbon in its beak reading "E PLURIBUS UNUM", a Latin phrase meaning "Out of many [states], one [nation]", a de facto motto of the United States (and the only one until 1956). Both the phrases "E Pluribus Unum" and "Annuit coeptis" contain 13 letters. In its left talons the eagle holds 13 arrows, and in its right talons it holds an olive branch with 13 leaves and 13 olives, representing, respectively, the powers of war and peace. To the right of this seal, a string of 13 pearls extends toward the edge of the bill. A plate position (check) number is normally found to the left of the eagle.

October 11, 1911, Holland Lodge No. 8, New York City. Brother Roosevelt participated in the Raising of his son Elliott (1910-1990) on February 17, 1933, in Architect's Lodge No. 519, also in New York City. He was present, but did not participate in the Degrees when two other sons, James (1907-1991) and Franklin D., Jr. (1914-1988) became Members of their brother Elliott's Lodge, on November 7, 1935. Brother and President Roosevelt was made the first Honorary Grand Master of the Order of De Molay on April 13, 1934 at the White House. He petitioned the Ancient Accepted Scottish Rite in the Albany Consistory of New York, February 28, 1929, and received his 32nd degree the same day. On March 26, 1930, he became a Shriner in Cyrus Temple, AAONOMS (Ancient Arabic Order Nobles of the Mystic Shrine), Albany, New York.

He was also a member of Greenwood Forest, Tall Cedars of Lebanon in Warwick, New York. On October 30, 1931, he was made a Prophet at Sight in Tri-Po-Bed Grotto, MOVPER (Mystic Order Veiled Prophets of the Enchanted Realm) of Poughkeepsie, New York. Franklin Roosevelt held a number of honorary memberships in various Masonic lodges, among them in the Architect Lodge, No. 519, New York, where he raised his sons, Franklin, Jr. and James, on November 7, 1935. He was also an Honorary Grand Master of Georgia, and, in 1934, was made Honorary Grand Master of the Order of De Molay.

The original Holy Roman Empire always had a spiritual leader from Italy Rome (papacy) and a Political leader from Europe (Royal Emperor) for 998 years (800 AD – 1798 AD). The Papacy is responsible for an estimated 50 -70 million Protestants deaths with up to another estimated 70 million murders of other ethnic people over a 1260 year period more than WW1 and WW2 combined. The Papacy for hundreds of years has had terrible blood on its hands as found in scripture (*Rev 17:3-6*) in Genesis God said he heard Cain's blood crying out to Him He also sees this shed blood by this immoral woman (*counterfeit Church*) as well. For example, it has been estimated by careful and reputed historians of the Catholic Inquisition that 50 million people were slaughtered for the crime of "heresy" by Roman persecutors between the A.D. 606 and the middle of the 19th century. This is the number cited by John Dowling, who published the classic "History of Romanism" in 1847 (book VIII, chapter 1, footnote 1). Only seven years after its first printing, it could be said of Dowling's book, "it has already obtained a circulation much more extensive than any other large volume ever published in America, upon the subject of which it treats; or perhaps in England, with the exception of Fox's Book of Martyrs." Clark's Martyrology counts the number of Waldensian martyrs during the first half of the 13th century in France alone at two million.

After such a survey of the persecutions, it is possible to revisit the question of how the total of 50 million was computed. Germany and Bohemia lost most of their population, and "the countries of Poland, Lithuania, and Hungary, were in a similar manner deluged with Protestant blood." Thus it is plausible to assume at least several million killed in Poland, Lithuania, and Hungary. Austria also had many slaughtered: "Taking Germany and Austria together, we may safely say that the population was reduced by one-half, if not by two-thirds." Many were probably killed in Siebenbuergen as well. Ferdinand II wanted to suppress Protestantism in the Holy Roman Empire. By the 18th century, the Holy Roman Empire consisted of most of modern Germany, the Czech Republic, Austria, Liechtenstein, Slovenia, Belgium, and Luxembourg, as well as much of modern Poland and parts of the Netherlands.

Previously, it had included all of the Netherlands and Switzerland, and parts of France and Italy.

Thus there may have been bitter persecution against Protestants in all of these countries: "Within

a few years Protestantism had been almost completely exterminated throughout the Hapsburg domains, multitudes having been slaughtered, and the rest banished or forcibly converted." The Hapsburg domains included the Holy Roman Empire as a whole: "With the one exception Bavarian Charles VII in 1742, the electors of the Holy Roman Empire almost always chose a member of the Habsburg dynasty as emperor, and the Hapsburgs, consequently, regarded the title as a family fieldom, despite the formalities of election"

All the countries of the Holy Roman Empire, excluding Germany and Bohemia, together with other areas such as Siebenbuergen could easily have had five million victims of persecution. Almost all of those killed in all of these locations would have been Protestants: "The emperor Ferdinand the second, was a great Persecutor of the Protestants in Bohemia and Germany, who after his victory over Frederick, Prince Palatine, and the Bohemian States, made it his work to root out the Protestant Religion in those Countries, and turned them into a very shambles of Blood, sparing neither Age, Sex, nor Rank that refused to abjure the Truth."

Thus there would be possibly 18 million killed in Germany and nearby areas in the thirty years' war, three million in Bohemia, four million in France, five million in other areas of the Holy Roman Empire and Europe, and fifteen million in war and the Inquisition from 1518 to 1548 making 45 million in all for one or two centuries following the Protestant Reformation. Because the Inquisition lasted a long time, the total number killed could easily have been significantly larger. At any rate, this method of computation appears to be eminently reasonable.

Even apart from the specific figures, the general context is important. The Jesuits "were soon the favorite confessors in the imperial court and in many of the royal courts of Europe" and "dictating to [rulers] the measures to be employed for the eradication of heresy." The number of Protestants that would be slain by such policies is clear from Germany, Bohemia, and elsewhere. Even where the Jesuits were not the favorite confessors, the Papacy would have motivated Catholic rulers to a similar policy. At the time of the Reformation, "multitudes of Heretics and Schismatics, as they called them, arose in all places" so there would have been multitudes of Protestants killed in all the Catholic countries of Europe, and the Catholic Church would have been directly responsible for these deaths.

Another method of computation also yields large figures. Annie Besant [The Freethinker's Text-Book. Part II. Christianity: Its Evidences. Its Origin. Its Morality. Its History, section I] writes, in the course of the Middle Ages hundreds of thousands perished; in France and Germany "many districts and large towns burned two, three, and four hundred witches every year, in some the annual executions destroyed nearly one per cent of the whole population...."

This refers only to witches, but it illustrates the attitude of the church to heretics in general. Because the church had a uniform policy in all places, one can expect similar numbers of heretics to have

been killed everywhere in Europe. There would have been many heretics throughout the Middle Ages, for Joseph Towers [Towers, Joseph, Illustrations of Prophecy ..., William Duane, Philadelphia, vol. 1, 1808, pp. 202-203] writes, The Waldenses and Albigenses, so renowned for their numbers, their virtues, and the purity of their faith, taught, in the 12th and 13th centuries, that the pope was Antichrist, and the church of Rome the Babylon of the Apocalypse.

- Footnote: Such, says Vitringa, was the language of pious men in general, during the whole of the four centuries which preceded the Reformation. In Apoc. p. 749.
- The population of Europe from 1100 to 1500 averaged about 65 million people. If one percent of the population was sometimes burnt as witches per year, one can assume that on the average half a percent of the population was slain each year as heretics altogether. This would amount to an average of about 300,000 persons killed per year for 400 years, or 120 million persons total killed during these four hundred years.
- These figures do not even consider those killed in the New World and the non-Christians killed in Europe and Asia. For example, referring to Bishop of Chiapa's account of the cruelty of the Spaniards in America, Grosvenor [Grosvenor, B., Persecution and cruelty in the principles, practices, and spirit of the Romish Church, 1735, p. 16] writes ... truly they went a great way to make this remark literally true with regard to the new world, when first found out: for, according to the account of one of their own bishops, in the space of forty years they destroyed fifty millions of people.
- Adding in these deaths might explain the commonly quoted figure of 100 million killed by the Papacy. Adding in non-Christians killed in Europe might explain some of the higher figures. Adding in the total killed assuming half a percent killed per year in Europe for four hundred years would yield about 200 million total killed. Omitting those killed in the New World would yield a total of about 150 million. This might explain where many of the commonly quoted figures come from.
- There is another computation that yields 100 million killed by the Papacy. In "Romanism in the light of prophecy and history: its final downfall, and the triumph of the church of Christ" [New York, American and Foreign Christian Union, 1854, p. 58], Brownlee quotes a figure of 68,500,000 killed by the Papacy, composed of 50 million Christians in Europe, 15 million Indians in the New World, 1.5 million Jews in Spain and elsewhere, and 2 million Moors in Spain. He then writes, And, O merciful Father in heaven, this does not include the millions of their own people, and her enemies, which fell in her crusades, and wars, and massacres! Here thirty millions and a half would be a moderate calculation! Thus, Rome papal has hurried into eternity A HUNDRED MILLION OF THE HUMAN RACE, by her bloody religion!
- Other estimates of the number of Indians killed range from 30 to 40 million; using these, one obtains a total of about 120 million instead. It is notable that discussions of the Reformation and Inquisition in modern historical works omit the religious wars from consideration and omit all

consideration of the large number of people who accepted Protestantism in the early years of the Reformation, thereby hiding the truth about the magnitude of past persecutions. However, even though much of the truth about history is being forgotten, there is still enough evidence remaining to show that the figure of 50 million killed for their faith by the Papacy in Europe is reasonable. These computations do not even include the extermination of the Heruli, Vandals, and Ostrogoths, or those who died in the Crusades. (This is only a portion of Vatican historical murders see full article Chapter)





So NAFTA as an organization in the USA was used by these powers to be to get what they want more financial and political power the TPPA encompassed 40% of the world's GDP. These ten horns representing economic trade under Obamas watch (TPPA-TTIP world trade corporate agreement deals sit under the WTO/UN) emerge out of the ten toes of clay and iron the horns come out from the modern Holy Roman Empire. 

- 1. 588 AD Constantinopolitan synod: John IV the Faster, patriarch of Constantinople, is granted the title of "oecumenical" or "universal bishop," but doesn't start using it till 595 AD.
- 2. 590 AD: Gregory I, the great, becomes Patriarch of Rome, 590-604 AD
- 3. 595 AD: John IV the Faster, starts using the title of "universal bishop" and Gregory I, denies the title even for himself. Bishop of Rome, Gregory I protests John IV the Faster's use of the title "universal bishop" saying such a claim is a sign "the antichrist is near" and calls it a "proud and profane title" and equates John IV's to the devil himself.
- 4. 595 AD: John IV the Faster dies on September 2, shortly after claiming to be pope of the world.
- 5. 602 AD Roman Emperor Maurice is murdered in a coup by Phocas, who then becomes emperor.
- 6. 604 AD Gregory, the bishop of Rome dies and is replaced by Sabinian, who reigns for two years.
- 7. 606 AD Sabinian, the bishop of Rome dies and is replaced by Boniface III. Phocas writes to the new bishop of Rome, Boniface III and through imperial decree of the Roman government, proclaims Boniface III, as the "Head of all the Churches" and "Universal Bishop". Phocas transfers the title from Constantinople to Rome. Boniface III, Bishop of Rome takes title: "universal Bishop": Catholicism is formally born in its final evolved form but the east never accepts Rome's claims and finally split fellowship with Rome in 1054 AD.
- 8. 607 AD: Boniface III dies on 19 February, shortly after claiming to be pope of the world. It is interesting that the first eastern leader (John IV) to proclaim himself as "universal bishop" and the first western (Boniface III) leader, to do the same, died within 12 months of claiming to be the "universal bishop".
- 9. In summary, when John IV, Patriarch of Constantinople, started calling himself the "Universal Bishop" Gregory I, Patriarch of Rome, did not say, "Hey that's my title, you have right to wear it." Instead Gregory said that no man should consider himself the "Universal Bishop" calling it the sign the "antichrist" was near. (see 2 Thess 2:3-4) The bishop of Constantinople, John IV. was saying, "I am over you", Gregory was saying, "we are equal", even though Gregory would readily make the false claim that he, not John, was a successor of Apostle Peter.

The 10 Horns: The Club of Rome was founded in 1968 during a meeting at Rockefellers private house in Bellagio, Italy, this is one of the Dragon elite banker families. The meeting was organized by Aurelio Peccei, an Italian industrialist who had close relations to the Olivetti Corporation and Fiat. He claimed to have solutions for world peace and prosperity, which could be accomplished through a New World Order.








The Club of Rome 10 governing economic political regions the 10 horns of the beast


NAFTA governed regions, of economics from the USA, the richest nation on Earth. Obama was president from 2009-2017 (8 years).



NAFTA "North American Free Trade agreement" came into force under President Bill Clinton in 1994 as a trade agreement between the USA, Canada and Mexico. NAFTA in 1996 then assigned the world's geographical nations into ten economic regions creating a map of these nations, the same year as the UN. This was done in alignment with the "Club of Rome" 10 regions first assigned in 1973, this reveals a connection between these organizations.

There are very slight differences in the regional assignments with NAFTA and the Club of Rome in Africa region 8 and South America region 2. The Ten Horns are also the 10 "Club of Rome" 10 "NAFTA" 10 UN regions. NAFTA is a US organisation for international trade deals. The 10 "NAFTA" regions are: 1.America, Canada and Mexico 2.South America 3.Australia and New Zealand 4.Western Europe 5.Eastern Europe 6.Japan 7.South Asia 8.Central Asia 8.North Africa and Middle East 10.The remainder of Africa.

The reforms now under way at the Vatican have come about in part because of the pressure brought to bear by banks such as Deutsche Bank, JP Morgan and Uni Credit, all of which found themselves in the sights of regulators because of their business relationships with the Holy See (Vatican). About three dozen banks, including some of the world's biggest financial institutions, were for years "correspondent" banks to the Vatican, providing services when the pope's business went beyond the boundaries of Vatican City.

With other institutional clients, the banks gave the Vatican access to foreign financial markets.

Correspondent banks moved as much as €2bn (3 billion US) a year from the Vatican's bank to

other accounts across the globe, according to a Vatican spokesman. It was the bankers' fear of being tarnished by their links with the Vatican bank after the credit crisis – and fears of fines from emboldened regulators – that led them to take steps that forced it to clean up its act.

The Institute for Religious Works issued its first annual report in early October, which showed that the bank has 19,000 clients, from around the world, 33,000 accounts and €5bn in assets. Few loans are made; the bank holds deposits, transfers money and makes investments. Half the bank's clients come from religious orders; another 15 per cent are Holy See institutions, 13 per cent are cardinals, bishops and clergy, 9 per cent are from Catholic dioceses around the world.

The rest of the clients are split among those who have, or should have, some "affiliation to the Catholic Church", the report says. Vatican insiders also revealed that the bank is awash in donations and cash, from Sunday collections and charitable giving. As much as 25 per cent of the bank's business is done in cash – a feature that regulators said raised red flags for money laundering. About a third of its business comes from donations rooted in charities.



A silver coin was also issued by a private mint in the same year of 2009 designed by Terbo Teb an artist from San Francisco. "the Hammer" Martel, Duke of the Franks and grandfather of Charlemagne, was in the process of uniting the Frankish and Germanic tribes to stand against the Muslim forces that had entered Gaul from Spain. As he conquered the Frisians, he sent Saint Willibrord, Bishop of Utrecht, to convert the people.

The Holy Roman Empire was the dominant political system for most of central Europe and Italy for nearly 900 years (from 962 until 1806). The HRE was considered a restoration and Christian continuation of the ancient original Roman Empire. In fact, the HRE can be traced back 100 years earlier, when the Frankish king Charlemagne was crowned Emperor of the Romans on Christmas Day in the year 800 by Pope Leo III. Because Holy Roman Emperors were Germanic, their traditional titles also included that of "King in Germany" or "King of Germany."

The Holy Roman Empire was intended to represent the unity of all Western Christian states within a single unified structure as the secular counterpart, working in conjunction with the Catholic Church. German princes who were elected as Emperor by the German Prince-Electors took the style of "King of the Romans" and "Emperor Elect" until they could be crowned Emperor by the Pope. Eventually the requirement for direct papal coronation was removed.

While most states of the Holy Roman Empire were Germanic, the Empire extended down into the Italian peninsula. The HRE effectively spread outside of its own primary territory through Germanic princes inheriting other crowns. For example, the Crown of Great Britain went to the Holy Roman Empire House of Orange and then to the Holy Roman Empire House of Hanover under the name of "Windsor," a House that still rules Britain to this day.

In 1024, Utrecht was established as a State of the Holy Roman Empire as a Prince-Bishopric and had spiritual and secular authority. In 1145, Utrecht was granted autonomy by Pope Eugene III. Autonomy was confirmed by the Fourth Lateran Council in 1215 and by Pope Leo X in 1520, for whom it became known as the "Leonine Privilege." In 1528, temporal authorities of the Prince-Bishopric of Utrecht were transferred to Holy Roman Emperor Charles V with permission of Pope Clement VII.

The former Utrecht holdings became part of the dominion of the Imperial and Royal House of Habsburg. In 1559, the of Utrecht was raised to the status of an Archdiocese. The Holy Roman Empire continued until its illegal dissolution, forced by the Napoleonic Empire in 1806. Old Roman Catholicism today remains a living relic of the Holy Roman Empire. The Old Holy Roman Church of the English Rite (Anglican Rite Roman Catholic Church) continues today as the English Rite Church of the Holy Roman Empire.

The church and state a few hundred years later emerged as a power in Europe with an emperor being crowned of royal blood by the Pope to rule over "The Holy Roman" empire. This began in early 800 A.D. the first emperor crowned by a Pope was King Charlemagne. This was an attempted union between church and state of politics and religion by the then ruling Pope. It happened when Pope Leo the 3rd placed the crown on the head of the secular King Charlemagne on Christmas day in 800 A.D. The so called dark ages "Inquisitions" by the Vatican powers killed an estimated 70 million people, the mix of iron (*power over people God's seed*) and

clay did not stick together very well, as prophesied in Daniel 2:42-44. Nebuchadnezzars dream "The iron and clay will be divided partly strong and partly broken they will not adhere to one another".

For example the following decree had been set forth by Rome (*Vatican*) as its agenda in the year 1229 A.D. by the "Council of Valencia" it placed the Bible on the index of "Forbidden Books" withholding doctrine of truth from the masses as seen in Vatican historical records. see decree:

"It is forbidden for laymen (common man) to read the Old and New Testaments. - We forbid them most severely to have the above books in the popular vernacular." "The lords of the districts shall carefully seek out the heretics in dwellings, hovels, and forests, and even their underground retreats shall be entirely wiped out." Council Tolosanum, Pope Gregory IX, Anno. Chr. 1229.

Interestingly it is stated according to history that 538 A.D. is the very year when the papacy began to reign freely over Europe as a "church & state" a conglomerate of religious and political power the last empire also symbolized in the book of Revelation chapter 17, as the "woman on a beast".

It is said that Vigilius whom ascended the papal chair in 538 A.D. began this supreme papal ruler ship under the military protection of Belisarius (*History of the Christian Church*, *Vol.* 3, p. 327.)

Other historians dispute this saying it actually began years earlier than this date. In the statement below the popes word or decisions are declared and considered "Rule of Law" as infallible over masses and nations. (Interestingly this is the term Obama used all the time as president he referred to the "Rule of Law" a "Holy Roman Empire "term). It was Emperor Justinian that issued his "Roman Code of Law" to punish heretics at the time they were resisting his ruler ship mainly the Arian Goths. This law became the Vatican's canon to persecute heretics for the next millennia (1260 years) until 1798 AD when it was defeated and changed by Napoleon. The last Holy Roman emperor resigned under arrest by Napoleon in 1806.

Note:

The Pope's authority is unlimited, incalculable; it can strike, as Innocent III says, wherever sin is; it can punish every one; it allows no appeal and is itself Sovereign Caprice; for the Pope carries, according to the expression of Boniface VIII, all rights in the Shrine of his breast. As he has now become infallible, he can by the use of the little word, "orbi," (which means that he turns himself round to the whole Church) make every rule, every doctrine, every demand, into a certain and incontestable article of Faith.

No right can stand against him, no personal or corporate liberty; or as the [Roman Catholic] Canonists put it—"The tribunal of God and of the pope is one and the same." - Ignaz von Dollinger, "A Letter Addressed to the Archbishop of Munich" 1871; as quoted in MacDougall, The Acton Newman Relations (Fordham University Press) pp. 119,120.

Because a pope (western world) is proclaimed infallible a popes decisions affect the lives of literally billions of people around the world this is the papal influence in the world domination of the "Holy Roman Empire". So throughout history the declarations of a papal leader have often been against God Himself due to their mixed doctrines and beliefs the Vatican system has always had its own agenda on the world scene of politics and religion.

Daniel 2:41-43

41"In that you saw the feet and toes, partly of potter's clay and partly of iron, it will be a divided kingdom; but it will have in it the toughness of iron, inasmuch as you saw the iron mixed with common clay. 42"As the toes of the feet were partly of iron and partly of pottery, so some of the kingdom will be strong and part of it will be brittle. 43"And in that you saw the iron mixed with common clay, they will combine with one another in the seed of men; but they will not adhere to one another, even as iron does not combine with pottery. (NKJV)

It may be of interest to note that the crown of the "Holy Roman Empire" of 800 A.D. under King Charlemagne includes iron and clay amongst its materials. One of Europe's great symbols of power and ruler ship is the Iron Crown of the first Holy Roman Emperor, Charlemagne. The Iron Crown, made of gold and iron and set with precious stones, is held in the Cathedral at Monza, near Milan (*Treaty of Milan 313 A.D*), in Italy. In a recent refurbishment of the crown it was discovered that its precious stones were held in place by a mixture of beeswax and clay, a common adhesive of the times.

Note:

Charlemagne was crowned the first Holy Roman Emperor, reputedly with the Iron Crown, by Pope Leo III in Rome on Christmas Night, 800 AD. He lived from (DOB 742 AD) 782-814 and, as King of the Franks, established and ruled over a kingdom that spanned virtually all the Christian States of western Europe, including what is now France, Switzerland, Belgium, The Netherlands, half of Italy and Germany, part of Austria and a small part of Spain. His role in uniting much of Europe is regarded as having an impact that remains until today'

Europe not only fits the prophecies related to the Dan 2 fourth kingdom and Revelations 17 beast, its relics do as well. Great Britain for many years sent ambassadors to hold talks with the HRE it held treaties with France and other HRE nations and eventually became integrated and inter connected to the empire through royalty. The Holy Roman Empire then continued on for another thousand years up until 1806 (*Napoleon*) it was then empowered again in 1929 (*Lateran Treaty*) and beyond.

A lot of people have said that this Empire seems to have ceased to exist to its ending by Napoleon in 1806. Napoleon devised the "Confederation of the Rhine" and sixteen German states left the Holy Roman Empire to join the Confederation, more states joined later they just moved from one place to another but remained integrated. The last "Holy Roman Emperor" Francis II ran out of steam and officially quit his job on August 6th 1806, the original Holy Roman Empire seemed to have then become history.

After WW1 (1914-1918) and then WW2 (1939-1945) the old empires of Europe lay in ashes Great Brittan (integrated into the HRE), France, Italy and all the big powers of Europe (states of

the Holy Roman Empire) were reduced to rubble financially and physically. At the time two super powers were emerging Russia and the USA.

Winston Churchill knew that a radical re-alignment of Europe had to happen or it would become non relevant, Europe needed to be unified or lose its power it would go to Russia and America. This made Winston Churchill and the region of Europe again the catalyst for the re-forming and re-emergence of "The Holy Roman Empire" onto the world scene in our modern age. As a world leaders voice Winston Churchill was also a major backer and player in the formation of the Jewish State of Israel in 1948 from Europe.

A decision was then made in 1957 by European nations for a European state nation unity, a treaty was signed called "The Treaty of Rome" a common market was created in Europe. Entities were joined together economically the first goal was to create economic union the second was Political union among nation states. This was first formed by 6 nations in Europe it was Belgium, France, West Germany, Italy, Luxembourg and the Netherlands. This worked well these were all original members of the "Holy Roman Empire" under emperor rulership up until 1806. What most don't understand is many of these European nations had colonies throughout the Middle East, India and Africa under the shadow of the "Holy Roman Empire" the colonial influences were vast up until the mid 20th century.

For instance President Obama's Father was a Kenyan colonial subject under British rule up until 1963 when Kenya finally became independent again. President Obama (*Rev 13 Beast*) was born in 1961 so effectively he came out of a "Holy Roman Empire" influenced nation. Other European nations began signing up to the "Treaty of Rome" such as Great Britain, Denmark and Ireland soon 15 nations had signed up.

Then Greece, Spain, Portugal, Austria, Sweden and Finland had all signed up. As things advanced by 1992 all economic barriers were down. A new treaty was then signed at Maastricht, Netherlands on Feb 7, 1992 it was called the "Maastricht Treaty" the goal of the treaty was to go

from economic union to Political union in Europe to become a solid world dominating influence (Holy Roman Empire revival).

The "Ecu" currency, was first conceived on March 13th 1979, by the EU as an internal accounting unit as an artificial basket currency. When the European Union printed their first money in 1987 there were EU commemoration coins in circulation a coin called the "Ecu" came out, it was the EU currency unit of the European Community member states (*replaced by the Euro on Jan 1*st 1999). The picture they put on this "Ecu" coin was "Charlemagne" (*King Charles V*) who was the first Holy Roman Emperor from 800 A.D proof the "Holy Roman Empire" was alive and well.

Before it was decided that the "Euro" would be the denomination for the new European currency, the "Ecu" was proposed, 15'000 of each silver and gold coins were made as collectables. The earliest issues, they are listed in the Standard Catalog of World Coins. They commemorate Charles V and the 30th Anniversary of the "Treaty of Rome". The "Ecu' coin, has been issued on twelve occasions in total.

Then by 1999 the EU had birthed their common money currency called the "Euro dollar". In 2004 the EU had expanded this to 25 member state nations, whom had merged their economies and adopted the Euro dollar. By 2007 they had become 27 nation states (28 by 2017) the world's number one economic power. The European Union was well on its way to becoming the "Holy Roman Empire" re-born in our modern age, out of which the Beast and False prophet emerges.

(President Obama the "Beast from the sea" in 2009 began advancement of Muslim Jihadists (Isis) who then declared an Islamic Caliphate starting on world stage mid 2013 (warring against the saints 42 months) only to be defeated by 2017 under President Trump and President Putin of Russia.

The false prophet President Erdagon of Turkey an Islamic leader as wishful head of this caliphate comes into unprecedented power in 2014. This is all the healing of the 1st wounded head the "Ottoman Empire" of the Beast of Rev 13:1-10. The US with NAFTA created the ten horns of

Rev 13:1(ten economic regions covering the Earth) the ten nations came through President Obama the TPPA deal, he loosed the placing of ten crowns onto the ten horns.

The ten horns are recognized on commemorative coins given to the Pope and other world ambassadors as seen on the pages of this chapter. The TPPA was signed in New Zealand on Feb 4th 2016 solely negotiated by President Obama with the ten Kings (US and Canada as one nation with Australia and New Zealand as one nation) to rule for one hour with the "beast" (Obama and Holy Roman Empire). At Trumps victory the US pulled out of the TPPA one year later the one hour? The TPPA has been re branded since this happened to the CPTPPA).



The twelve stars of the EU flag are now on all EU Euro money.

A "Charlemagne" Prize award exists that was first established in 1949 to recognize the greatest contribution of those serving European unification and the European community. European unification is also promoted with this prize given every year to leaders. This was the case with President Clinton who brought Yugoslavia into the EU. Clinton did this by going to war with Yugoslavia President Clinton came against the resistance of the EU by Serbian strongman Slobodan Milosevic.

President Clinton used the forces of NATO in taking Milosevic out of power bringing Yugoslavia into the EU. World leaders have been building a united Europe influenced from behind the scenes hence the popular term the "New World Order" a term of the "Holy Roman Empire". The Rothschild's are involved with this through the "World Banks" and "Federal reserve" banking systems. (Rothschild wealth and influence with other banking families such as the Rockefellers are known to be powerful positions influencing world events this is symbolic of the Dragon of Rev 13:4 they are under Satan's influence and control).

There is a very influential publication in Europe called the "Economist" owned by Lord Rothschild it comes out weekly with one page each week devoted to EU unification this special page every week is called the "Charlemagne" page it also has websites:

These pages promote the EU ideals on a weekly basis. President Obama was given power for a season to be raised up to try and bring about further unity of this empire under his reign as the "beast" of Rev 13:1-10 whom is given power by the Dragon (*Satan is the true leader heading up the Holy Roman Empire*" *spiritually*). A 1988 edition predicts worldwide economic collapse by the end of 2018 with a new one world currency to emerge only history will tell.



Obama on the cover of the Economist 2009 and the mask of Charlemagne in the Economist the original statue is located at Cathedral Treasury in Aachen. There is a special building in Brussels Germany, the capital of the EU called the "Charlemagne Building" this is where nations wanting to join the EU go to negotiate terms of membership. At this building is the statue of the woman riding the bull (*Rev 17:3 this beast also has ten horns and ten crown ten kings of economic, military and political power*) and the EU flag of twelve stars.

You could virtually say Brussels is the headquarters the office of the "Holy Roman Empire". The flag of the EU is a blue flag with twelve gold stars upon it in a circle. The flag was designed by Arsene Heitz and Paul M. G. Levy in 1955. The men who designed this flag were devout Roman Catholics. The reason they put the twelve stars on the flag is because they believed the "Holy Roman Empire" should have the Holy element in it.

This was to do with supposed divine blessing from the Bible where the woman who gave birth to the male child was clothed with twelve stars (*Rev 12:1*). It was Arsene Heitz that wrote an article explaining how he believed this was the Virgin Mother Mary in Rev 12, so he took the twelve stars and put them on the flag, the Roman Catholic Church (*Vatican*) is very much a part of the undercurrent of the EU "The Holy Roman Empire", hence the church is represented in the EU on the flag.

In 1996, a 5 Euro Coin was released that depicted Europa riding the bull. A 2 Euro coin was also released in Greece that depicts a woman riding a beast.

Holy Roman Empire Officially Re-Born:

On Nov 3rd 2009 the "Holy Roman Empire" was officially reborn with the signing by world leaders of the "Lisbon treaty" this took place live on international TV. Members of the EU (*European Union of now 29 nations as of 2017*) formed an alliance treaty that some had signed in 2007 but met with resistance from other nations in Europe.



Time Magazine published some artwork of a "United Europe" after the "Lisbon Treaty" on Nov 3rd 2009 that featured Europa riding the beast. A cover of Der Spiegel featured a picture of a woman riding a beast carrying the EU flag with the headline: "Good Morning Europe". Around the same time the Lisbon treaty was signed Herman Van Rompuy (EU presidency) the former German prime minister became the 1st president of the EU on Nov 19th 2009. Van Rompuy then went on to announce that 2009 was the first year of "Global Governance" with G20 an extension of the G7 group (7 Heads of beast Rev 13:1). The New World Order (Under the Holy Roman Empire) had now been re empowered re-born a new formation had begun and was announced from Brussels on mainstream media worldwide.

These nations all encompass the old "Holy Roman Empire" nations and even more territories are included it has increased massively.

In those days the Kings, the ten toes, will be in coalition with each other (*Rev 17:12*) the ten King alliance (*NAFTA transitioning into the TPPA*) will receive power for one hour to reign with the Beast (*Rev 13:1, 17:12*) they have one mind in unity to rule over the known economic world with finance and military power the TPPA will cover 40% of the world's economic trading GDP covering 800 million people. The TPPA will also be integrated into the TTIP the EU trading deal that Obama is also heading up.

The USA was also negotiating another deal the TTIP alongside the TPPA with the 28 state nation EU (*Holy Roman Empire*) members called the "Transatlantic Trade and Investment Partnership" (*TTIP*) it's every bit as scary as the "Trans Pacific Partnership" (*TPP 40% of world GDP*) deal, both were headed up by the Obama (*The Beast 2009-2016*) administration. The TPPA trade deal would be the largest free trade agreement ever with the United States and 11 other Pacific Rim countries spelling out new regulations covering exports and imports.

The documents that have been leaked indicate that, once we enter into this agreement, it will be virtually impossible to extricate ourselves from the TPPA. Thankfully in 2017 the newly elected President Donald Trump withdrew from the TPPA causing shock waves and confusion to the TPPA nations. Once signed and implemented any government that we elect will have no power to change things but can only renege and back out of it (as USA has with Trump in 2017 Britain also pulled out of the EU in 2016 "Brexit" a peoples vote displeasing the establishment). Not only do we need to consider the implications of the TPPA for ourselves, but also for future generations.

The TPP is a proposed Pacific Rim regional trade agreement involving 12 countries now 11 as of 2017 (formed into 10 the 10 crowns). These countries are all from the 10 economic NAFTA assigned regions, which account for 40 per cent of global trade. Included as one nation are New Zealand and Australia, the United States and Canada (now only Canada) as one nation plus eight others equaling the ten as prophesied about.

The ambition with the TPPA is to reset global trade rules and is without precedent, its repercussions include the ability for transnational corporations to dictate changes to individual countries laws (hence the overreaching Pfizer Covid vaccine contracts that came in 2021 a complete corporate corrupt set up under Obama the beast). It represents one of the greatest threats to a countries national sovereignty; it was set to hand over all power to a US "Trade Commission" handling the free trade putting the US above everyone else internationally. The TPPA was actually signed into being in Auckland in New Zealand under much protest by the nations people; it was signed on Feb 4th 2016 by 12 nation members. The TPPA has been ratified since 2017 after President Trump made the wise decision to leave.

Three main things emerge out of this last day dominating kingdom they are political union, economic union and religious union. The political leader President Obama of the US a Muslim inaugurated from 2009 and remained as US President until 2016 is the "Beast" (*Antichrist Rev 13 7 year reign*) he set up platforms politically and financially to bring about fulfillment of prophecy in the Bible.

The spiritual religious leader (2nd beast false prophet of Rev 13 "Erdogan") is the head of the Muslim religion termed as a King of a nation the so called re-formed Caliphate (healed wounded head of 1st beast Rev 13:3) in the Middle East. It was "Abu Bakr al-Baghdadi" born a Sunni Muslim that launched Isis from Syria into Iraq he was an Iraqi a leader a supposed direct descendant of Muhammad himself. This man was released from Bucca Camp prison in southern Iraq after 4 years of imprisonment by the Obama administration in 2009.

The Obama administration was involved directly and indirectly in the building up and advancement of Isis and Muslim terrorists in the Middle East and around the world through bad deals, foreign policy, weapons supply and financial support in the billions of dollars such as the Iran nuclear deal against Israel. Thank God for grace with President Trump 2017, getting in (Dan 7:22 favor of God) reversing a lot of Muslim President Obama's bad deals and corruption that hurt many people.

On the world scene it is another man who is coming forth positioned as the false prophet (false religious leader over nations follow on from Obama) caliph (Islamic King) "Erdogan" of Turkey who is positioning himself for the Ottoman Empire re-birth he was in close partnership and friendship with President Obama both being Muslim Brotherhood supporters. Erdogan has also built himself a \$350 million dollar presidential palace in Turkey dedicated to the old Ottoman Empire resurrection. Erdogan in April 2017 won the Turkish referendum giving him greater authority unprecedented power as

president and ultimate leader of Turkey abolishing the prime minister role. President Erdogan of Turkey in June 2017 also set up an image to the beast (*Rev 13:14-15 the worship an antichrist beast religion and false God*) a statue fulfilling Prophecy of the first beasts wounded head (*Rev 13:3-4 Trumpet 2 of WW2 the Ottoman Empire defeat head wound*) it stands over a hundred feet high outside Erdogan's palace. Erdogan even called allegiance to it saying he will be head all his enemies' that's Sharia law 666: see chapter 41, Rev 13 The false Prophet. As of mid-2019 Erdogan was also heading up the anti Islamophobia anti hate speech law in the United Nations. along with Jacinda Adern of New Zealand and Pakistan. This anti hate speech law of the UN is to control any one that disagrees with the establishment, they can call it hate speech and arrest you, this will affect the preaching of the gospel it's a mark of the beast law against God given freedoms.

(according to scriptural historical fulfillment the Pope is not the false prophet see chapter 40) at the same time as the 1st Beast of Rev 13:1-10 (*Obama*) and the false prophet (*Erdogan*) of Rev 13:11-18. The Pope (*Francis* 2nd) is the "one and who was who wasn't and is" the 8th king of the "Woman that rides the Beast" the Holy Roman Empire fornicates with the nations Rev 17:1-6.





"The Beast" a Muslim 2009 onwards, the "False Prophet" a Muslim.

Both the beast and the false prophet have been under the influence and empowerment of the Holy Roman Empire (they come from this empires influence and governance) through money and weapons from Europe and the USA, the Romanic kingdom of our modern age. The key we need to remember is the Christian Church of Rome consummated with Rome (The Bull Beast) under Constantine in 313 A.D. legalizing Christianity stopping Christian martyrdom at the time. This created a mixture of paganism, politics and religion "Iron and Clay" forming the Roman Catholic Religion which is a false Christianity of pagan idolatry. The Catholic Church refers to herself as the mother of the worldwide Christian Church a complete deceptive statement. The true spiritual re born again church is not under this system but under Christ Himself in relationship with Him alone spiritually no mixture.

It's very interesting in Islam the only historical evidence they have of the 1400 year old Quran is the modern day Quran it's said by Muslims to have not been added to in 1400 years, but all original historical 1500 year old texts dating back to Muhammad have been lost. There is no historical evidence at all of the Qurans original texts yet it's received by millions as the revelation of God written by one man. The Quran is regarded as the finest work in classical Arabic literature; 1.7 billion Muslims believe it is the revelation of God. Historians have found no evidence of its actual formation creation except what the Quran says within itself. There is one other interesting source from an ex Jesuit priest who became a Christian then wrote a book about Islam's formation published by "Chick publications" a Christian organization the man was killed for his testimony. This testimony may be the missing link the key to understanding the birth of Islam and why.

In comparison the Bible has huge amounts of documented historical archeology with evidence and historical references by ancient writers apart from the Bible it has ancient scrolls and documents dating back over 3500 years that prove its been unchanged over thousands of years. Many prophecies have been fulfilled throughout thousands of years down to specific details as recorded in the Bible proving its volatility and worth the most sold book of all time. 



The report in question has the bland title, "Scenarios for the Future of Technology and International Development." It was published in May 2010 in cooperation with the Global Business Network of futurologist Peter Schwartz. The report contains various futurist scenarios developed by Schwartz and company. Then the scenario gets very interesting: "During the pandemic, national leaders around the world flexed their authority and imposed airtight rules and restrictions, from the mandatory wearing of face masks to body-temperature checks at the entries to communal spaces like train stations and supermarkets. Even after the pandemic faded, this more authoritarian control and oversight of citizens and their activities stuck and even intensified. In order to protect themselves from the spread of increasingly global problems — from pandemics and transnational terrorism to environmental crises and rising poverty — leaders around the world took a firmer grip on power."

June 7, 2020 Holy Trinity Sunday

Mr. President,

In recent months we have been witnessing the formation of two opposing sides that I would call Biblical: the children of light and the children of darkness. The children of light constitute the most conspicuous part of humanity, while the children of darkness represent an absolute minority. And yet the former are the object of a sort of discrimination which places them in a situation of moral inferiority with respect to their adversaries, who often hold strategic positions in government, in politics, in the economy and in the media. In an apparently inexplicable way, the good are held hostage by the wicked and by those who help them either out of self-interest or fearfulness.

These two sides, which have a Biblical nature, follow the clear separation between the offspring of the Woman and the offspring of the

Serpent. On the one hand there are those who, although they have a thousand defects and weaknesses, are motivated by the desire to do good, to be honest, to raise a family, to engage in work, to give prosperity to their homeland, to help the needy, and, in obedience to the Law of God, to merit the Kingdom of Heaven. On the other hand, there are those who serve themselves, who do not hold any moral principles, who want to demolish the family and the nation, exploit workers to make themselves unduly wealthy, foment internal divisions and wars, and accumulate power and money: for them the fallacious illusion of temporal well-being will one day – if they do not repent – yield to the terrible fate that awaits them, far from God, in eternal damnation.

In society, Mr. President, these two opposing realities co-exist as eternal enemies, just as God and Satan are eternal enemies. And it appears that the children of darkness – whom we may easily identify with the deep state which you wisely oppose and which is fiercely waging war against you in these days – have decided to show their cards, so to speak, by now revealing their plans. They seem to be so certain of already having everything under control that they have laid aside that circumspection that until now had at least partially concealed their true intentions. The investigations already under way will reveal the true responsibility of those who managed the Covid emergency not only in the area of health care but also in politics, the economy, and the media. We will probably find that in this colossal operation of social engineering there are people who have decided the fate of humanity, arrogating to themselves the right to act against the will of citizens and their representatives in the governments of nations.

We will also discover that the riots in these days were provoked by those who, seeing that the virus is inevitably fading and that the social alarm of the pandemic is waning, necessarily have had to provoke civil disturbances, because they would be followed by repression which, although legitimate, could be condemned as an unjustified aggression against the population. The same thing is also happening in Europe, in perfect synchrony. It is quite clear that the use of street protests is instrumental to the purposes of those who would like to see someone elected in the upcoming presidential elections who embodies the goals of the deep state and who expresses those goals faithfully and with conviction. It will not be surprising if, in a few months, we learn once again that hidden

behind these acts of vandalism and violence there are those who hope to profit from the dissolution of the social order so as to build a world without freedom: Solve et Coagula, as the Masonic adage teaches.

Although it may seem disconcerting, the opposing alignments I have described are also found in religious circles. There are faithful Shepherds who care for the flock of Christ, but there are also mercenary infidels who seek to scatter the flock and hand the sheep over to be devoured by ravenous wolves. It is not surprising that these mercenaries are allies of the children of darkness and hate the children of light: just as there is a deep state, there is also a deep church that betrays its duties and forswears its proper commitments before God. Thus the Invisible Enemy, whom good rulers fight against in public affairs, is also fought against by good shepherds in the ecclesiastical sphere. It is a spiritual battle, which I spoke about in my recent Appeal which was published on May 8.

For the first time, the United States has in you a President who courageously defends the right to life, who is not ashamed to denounce the persecution of Christians throughout the world, who speaks of Jesus Christ and the right of citizens to freedom of worship. Your participation in the March for Life, and more recently your proclamation of the month of April as National Child Abuse Prevention Month, are actions that confirm which side you wish to fight on. And I dare to believe that both of us are on the same side in this battle, albeit with different weapons.

For this reason, I believe that the attack to which you were subjected after your visit to the National Shrine of Saint John Paul II is part of the orchestrated media narrative which seeks not to fight racism and bring social order, but to aggravate dispositions; not to bring justice, but to legitimize violence and crime; not to serve the truth, but to favor one political faction. And it is disconcerting that there are Bishops – such as those whom I recently denounced – who, by their words, prove that they are aligned on the opposing side. They are subservient to the deep state, to globalism, to aligned thought, to the New World Order which they invoke ever more frequently in the name of a universal brotherhood which has nothing Christian about it, but which evokes the Masonic ideals of those want to dominate the world by driving God out of the courts, out of schools, out of families, and perhaps even out of churches.

The American people are mature and have now understood how much the mainstream media does not want to spread the truth but seeks to silence and distort it, spreading the lie that is useful for the purposes of their masters. However, it is important that the good – who are the majority – wake up from their sluggishness and do not accept being deceived by a minority of dishonest people with unavowable purposes. It is necessary that the good, the children of light, come together and make their voices heard. What more effective way is there to do this, Mr. President, than by prayer, asking the Lord to protect you, the United States, and all of humanity from this enormous attack of the Enemy? Before the power of prayer, the deceptions of the children of darkness will collapse, their plots will be revealed, their betrayal will be shown, their frightening power will end in nothing, brought to light and exposed for what it is: an infernal deception.

Mr. President my prayer is constantly turned to the beloved American nation, where I had the privilege and honor of being sent by Pope Benedict XVI as Apostolic Nuncio. In this dramatic and decisive hour for all of humanity, I am praying for you and also for all those who are at your side in the government of the United States. I trust that the American people are united with me and you in prayer to Almighty God.

Daily we sense the attacks multiplying of those who want to destroy the very basis of society: the natural family, respect for human life, love of country, freedom of education and business. We see heads of nations and religious leaders pandering to this suicide of Western culture and its Christian soul, while the fundamental rights of citizens and believers are denied in the name of a health

emergency that is revealing itself more and more fully as instrumental to the establishment of an inhuman faceless tyranny.

A global plan called the Great Reset is underway. Its architect is a global élite that wants to subdue all of humanity, imposing coercive measures with which to drastically limit individual freedoms and those of entire populations. In several nations this plan has already been approved and financed; in others it is still in an early stage. Behind the world leaders who are the accomplices and executors of this infernal project, there are unscrupulous characters who finance the World Economic Forum and Event 201, promoting their agenda.

The purpose of the Great Reset is the imposition of a health dictatorship aiming at the imposition of liberticidal measures, hidden behind tempting promises of ensuring a universal income and cancelling individual debt. The price of these concessions from the International Monetary Fund will be the renunciation of private property and adherence to a program of vaccination against Covid-19 and Covid-21 promoted by Bill Gates with the collaboration of the main pharmaceutical groups. Many people – as we well know – are annoyed by this reference to the clash between Good and Evil and the use of "apocalyptic" overtones, which according to them exasperates spirits and sharpens divisions. It is not surprising that the enemy is angered at being discovered just when he believes he has reached the citadel he seeks to conquer undisturbed. What is surprising, however, is that there is no one to sound the alarm. The reaction of the deep state to those who denounce its plan is broken and incoherent, but understandable. Just when the complicity of the mainstream media had succeeded in making the transition to the New World Order almost painless and unnoticed, all sorts of deceptions, scandals and crimes are coming to light.

Until a few months ago, it was easy to smear as "conspiracy theorists" those who denounced these terrible plans, which we now see being carried out down to the smallest detail. No one, up until last February, would ever have thought that, in all of our cities, citizens would be arrested simply for wanting to walk down the street, to breathe, to want to keep their business open, to want to go to church on Sunday. Yet now it is happening all over the world, even in picture-postcard Italy that many Americans consider to be a small enchanted country, with its ancient monuments, its churches, its charming cities, its characteristic villages. And while the politicians are barricaded inside their palaces promulgating decrees like Persian satraps, businesses are failing, shops are closing, and people are prevented from living, traveling, working, and praying. The disastrous psychological consequences of this operation are already being seen, beginning with the suicides of desperate entrepreneurs and of our children, segregated from friends and classmates, told to follow their classes while sitting at home alone in front of a computer.

In Sacred Scripture, Saint Paul speaks to us of "the one who opposes" the manifestation of the mystery of iniquity, the kathèkon (2 Thess 2:6-7). In the religious sphere, this obstacle to evil is the Church, and in particular the papacy; in the political sphere, it is those who impede the establishment of the New World Order.

As is now clear, the one who occupies the Chair of Peter has betrayed his role from the very beginning in order to defend and promote the globalist ideology, supporting the agenda of the deep church, who chose him from its ranks.

Mr. President, you have clearly stated that you want to defend the nation – One Nation under God, fundamental liberties, and non-negotiable values that are denied and fought against today. It is you, dear President, who are "the one who opposes" the deep state, the final assault of the children of darkness.

The adversary does not know how to love, and it does not understand that it is not enough to assure a universal income or to cancel mortgages in order to subjugate the masses and convince them to be branded like cattle. This people, which for too long has endured the abuses of a hateful and tyrannical power, is rediscovering that it has a soul; it is understanding that it is not willing to exchange its freedom for the homogenization and cancellation of its identity; it is beginning to understand the

value of familial and social ties, of the bonds of faith and culture that unite honest people. This Great Reset is destined to fail because those who planned it do not understand that there are still people ready to take to the streets to defend their rights, to protect their loved ones, to give a future to their children and grandchildren. The leveling inhumanity of the globalist project will shatter miserably in the face of the firm and courageous opposition of the children of Light. The enemy has Satan on its side, He who only knows how to hate. But on our side, we have the Lord Almighty, the God of armies arrayed for battle, and the Most Holy Virgin, who will crush the head of the ancient Serpent. "If God is for us, who can be against us?" (Rom 8:31).

Mr. President, you are well aware that, in this crucial hour, the United States of America is considered the defending wall against which the war declared by the advocates of globalism has been unleashed. Place your trust in the Lord, strengthened by the words of the Apostle Paul: "I can do all things in Him who strengthens me" (Phil 4:13). To be an instrument of Divine Providence is a great responsibility, for which you will certainly receive all the graces of state that you need, since they are being fervently implored for you by the many people who support you with their prayers.

With this heavenly hope and the assurance of my prayer for you, for the First Lady, and for your collaborators, with all my heart I send you my blessing.



The Rothschilds and the Vatican

Early in the 19th century [1800s] the Pope came to the Rothschilds to borrow money. The Rothschilds were very friendly with the Pope, causing one journalist to sarcastically say "Rothschild has kissed the hand of the Pope...Order has at last been re-established.

"The Rothschilds in fact over time were entrusted with the bulk of the Vatican's wealth. The Jewish Ency., Vol. 2, p.497 states, "It is a somewhat curious sequel to the attempt to set up a Catholic competitor to the Rothschilds that at the present time (1905) the latter are the guardians of the papal treasure." Researcher Eustice Mullins writes that the Rothschilds took over all the financial operations of the worldwide Catholic Church in 1823.

Today the large banking and financial business of the Catholic Church is an extensive system interlocked with the Rothschilds and the rest of the International Banking system. Viz the Vatican's Bank of America in the United States which recently acquired the Wall Street investment giant Merrill Lynch.

The great wealth of the Russian Czars was entrusted at that time to the Rothschilds, \$35 million with the Rothschild's Bank of England, and \$80 million in the Rothschild's Paris bank. The Rothschilds then financed the Russian Revolution which confiscated those fortunes plus vast portions of the Orthodox Church's wealth.

They were able to prevent (due to their power) the legitimate heirs of the Czars fortune to withdraw a penny of the then mere millions deposited in a variety of their banks. The Mountbatten's, who are related to the Rothschilds, led the court battles to prevent the claimants from withdrawing any of the fortune. Until this year Rothschild's Bank of America was the largest bank in the United States. Then, last week, it was given ownership of the failing Washington Mutual bank, that nation's largest Savings and Loan.

Lehman Brothers, the other financial house collapse which shook the world, is apparently to be acquired by Rothschild Barclays PLC Bank in London, under the direction of the US bankruptcy court.

The total assets of the Rothschild financial empire now surpass 165 Trillion Pounds Sterling.

Pope Francis, aware of the fast-growing global wealth inequality between the ultra-wealthy and the rest of society, has proposed a challenge to corporate executives and public sector leaders to adopt a more inclusive, fair and transparent economic system that is equipped to address the dire challenges plaguing humanity and Earth.

"The world is rich, and yet the number of poor people is swelling all around us," said Pope Francis. With the increasing wealth inequality, the pope pointed to the current challenges facing humanity, "Hundreds of millions of people are struggling in extreme poverty, and are lacking food, housing, healthcare, schooling, electricity, and drinkable water.

In response to the pope's exhortation, business and public sector leaders formed an historic partnership with the Vatican. The Council for Inclusive Capitalism will serve as a movement to address the economic and environmental needs of the planet and its inhabitants. The council "boasts over more than \$10.5 trillion in assets under management, companies with over \$2.1 trillion of market capitalization and 200 million workers in over 163 countries."

It should be noted that these extremely wealthy executives are not adversaries of capitalism, citing that the system has helped billions of people abscond poverty. However, the group acknowledges that capitalism has perilously left people behind, while also taking a toll on the planet. Ultimately, the partnership calls for a moral redress.

The "Guardians," as the council members are called, are top executives of the world's leading corporations who have promised to take bold actions toward creating inclusive capitalism. The Guardians will hold themselves accountable, committing to a list of intended actions involving

environmental, social and governance matters. The Guardians, at their respective companies, have said they plan to hire and promote more women, increase diversity hires, commit to clean energy by purchasing 100% renewable electricity, reduce greenhouse gas emissions, promote the reuse and recycling of water and other initiatives.

The list of Guardians is lengthy and continues to grow. Here are some examples of the business leaders who have joined this mission:

- Ajay Banga, president and CEO, Mastercard
- Oliver Bäte, chairman of the board of management, Allianz SE
- Marc Benioff, chair, CEO, and founder, Salesforce
- Edward Breen, executive chairman, Dupont
- Lady Lynn Forester de Rothschild, founder and managing partner, Inclusive Capital Partners
- Kenneth Frazier, chairman of the board and CEO, Merck
- Alex Gorsky, chairman of the board and CEO, Johnson & Johnson
- Alfred Kelly, chairman and CEO, Visa
- William Lauder, executive chairman, Estée Lauder
- Bernard Looney, CEO, BP
- Brian Moynihan, chairman of the board and CEO, Bank of America
- Ronald P. O'Hanley, president and CEO, State Street Corporation
- Rajiv Shah, president, the Rockefeller Foundation

According to the New York Times, "There are reasons to be both hopeful and skeptical of the initiative. The corporate pledges are meaningful, but some aren't new: BP, for example, restates a commitment to achieve net zero carbon emissions by 2050 that it announced in February. And while the council has posted the pledges publicly, there's not much to hold the companies accountable (aside from the risk of disappointing the pope)."

- While we applaud the people who try to make the world a better place, there is an irony that can't be ignored. The same people who are calling for an end to wealth and income inequality are extraordinarily wealthy. Of course, the noted leaders like capitalism, it's been very good to them.
- According to Forbes, Marc Benioff, the CEO of Salesforce, is worth nearly \$90 billion. William Lauder, the executive chairman of Estée Lauder, has a net worth of \$3.5 billion.
- Lady Lynn Forester de Rothschild, the founder and managing partner of Inclusive Capital Partners, has her own wealth, but is also married to Sir Evelyn De Rothschild. He is the scion of one of world's wealthiest family dynasties and is estimated to be worth \$20 billion.
- According to salary.com, Ajay Banga, the CEO of Mastercard, earned \$23.2 million in total compensation for 2019. Bank of America CEO Brian Moynihan reaped \$25.4 million in total compensation for 2019. These numbers don't include any accumulated stock that they may own in their respective companies or their entire net worth.
- There is nothing wrong with the Guardians being in the top 1%. However, these business leaders are the people that the pope points to when he calls out wealth inequality. Their massive wealth begs the question, since they have the financial means, why aren't they personally leading by example? Why not write a large personal check, without claiming it as a tax write-off? When their corporations take actions, the monies don't come out of the pockets of the executives, but are indirectly supported by the shareholders.
- The wealthy elites could consider getting their own houses in order before trying to change the world. The CEOs are able to ask for and accept significantly less compensation and wave all of their stock options and lavish bonuses. They could certainly live on a \$5 million salary and the other \$20 million could be shared with their workers. Instead of accumulating all of the stock options, the executives should offer them to their employees, so that they have equity in their companies.
- The titans of industry have the power to provide enhanced health insurance, additional vacation days, flexible work schedules, pensions, access to mental health resources and longer maternity and paternity leave. Who will be the first CEO to step down and replace himself with a person of color or woman?
- The Guardians can exert peer pressure on fellow industry chief executive officers. They could ask Amazon's Jeff Bezos, Facebook's Mark Zuckerberg, Apple's Tim Cook, Google's Sundar Pichai and others to relinquish the fortunes they've accumulated during the Covid-19 pandemic and redistribute it to this initiative.

The glaring concern is that this partnership ends up as a public relations bonanza for the executives involved. They'll bask in the glory of favorable media attention and virtue signal how wonderful and caring they all are. I'll follow up in the New Year to report their progress—if any.

Lady de Rothschilds road to the Vatican

Oliver Balch interviews the financier leading the Coalition for Inclusive Capitalism, which has partnered with the Vatican in its drive to reform markets and companies to meet the unprecedented social and environmental challenges ahead

"Listen to the cry of the Earth and the cry of the poor." Five years on from Pope Francis's call for mankind to take heed of the climate crisis and care for our "common home", his message has landed in the highest echelons of global capitalism.

Last week, a group of 27 titans of global business representing the Council for Inclusive Capitalism inked a partnership with the Vatican and pledged to help build a fairer and "more trustworthy"

economic system, a year after travelling to meet the Pope in Rome last November (see main photo).

In a virtual address to these self-styled "guardians of inclusive capitalism" – among them COP26 special envoy for finance Mark Carney, and the CEOs of Salesforce, Johnson & Johnson, Mastercard, BP, Visa, State Street, Bank of America, as well as State of California treasurer Fiona Ma and OECD secretary-general Angel Gurría – Pope Francis urged them to make capitalism an "instrument for integral human wellbeing".

- Three years in the making, this epochal virtual event was the work of an individual who, until a decade ago, described herself as an ardent free-market capitalist.
- After all, as systems go, it worked well for Lady Lynn Forester de Rothschild. A successful corporate lawyer turned even more successful entrepreneur, American-born de Rothschild (the honorific derives from her husband, the British financier Sir Evelyn Robert de Rothschild) rose to prominence during the early telecoms boom of the 1980s and 1990s. Successful exits from various startup ventures made her a millionaire many times over.
- "Basically, I was a money-is-good, neo-liberal person who believed in the sanctity and sanity of free markets. A rising tide lifts all boats, and all that," she says.
- Today, this same disciple of the Wall St school of unfettered capitalism is to be found standing shoulder to shoulder with the Pope, leading her corporate colleagues up the aisle of inclusive capitalism. So, what happened?
- For an answer, it's necessary to wind back the clock to the financial crisis of 2007/2008. Appalled by the sub-prime mortgage fiasco and its implications for the 99% who operated outside the corridors of corporate powers, she found her convictions unexpectedly challenged.
- Capitalism might cause some boats to rise, the crisis revealed, but not all by any means. Could it be fair that monster tankers plied the high seas, while dinghies languished in the shallows? So, when the Occupy movement appeared a short while later, railing against the "1%", she listened.
- For a Rothschild, a name intrinsically linked to international banking, that's no small step. At the time, she was chief executive of EL Rothschild, a private investment house set up by her and her husband ('E' for Evelyn; 'L' for Lynn). The firm's portfolio includes The Economist Newspaper Ltd, among other prize assets.

"My two sons were leaving university at the time and I just became shocked by the prospects facing them and other young people their age compared to the prospects I had when leaving law school back in the early 1980s," she said.

At global consulting firm McKinsey, the then chief-executive, Dominic Barton, shared her concerns. The pair convened a taskforce of leading thinkers from business, policymaking, and academia with a two-fold objective: to determine where capitalism had gone wrong, and to ask how businesses might help put it right.

The taskforce's final report in 2012, Towards a More Inclusive Form of Capitalism, defines the term as a system in which "everyone – all stakeholders, not just shareholders – derive benefits from business" – in line with contemporary interpretations of stakeholder capitalism.

She went on to set up the Coalition for Inclusive Capitalism, an interdisciplinary network of leaders that endeavours to advance the case for "broad and sustainable prosperity". Out of this came the Embankment Project, which, with considerable input from professional services firm EY, put forward a list of proposed criteria in late 2018 for measuring the value of human capital. The list includes metrics such as voluntary turnover, diversity at all levels of a company, and participation in wellbeing programmes.

Sustainability-minded investors are frustrated by the absence of comparable data on non-financial issues, she states. Her hope is that the Embankment Project's proposals, which <u>have the</u> <u>endorsement</u> of the influential Sustainability Accounting Standards Board (SASB), may go some way to providing investors with what they want.

"Benchmarking and the whole idea of a 'race to the top' are really important, but I think they are hindered until there are standardised, comparable ways for companies to report on non-financial issues," she says.

- At one point, the Coalition for Inclusive Capitalism taskforce counted President Obama's chief economic adviser Larry Summers and former Hewlett Packard chief executive Carly Fiorina. The participation of two such prominent political figureheads one Democrat, the other Republican speaks to Lady de Rothschild's fierce belief in bipartisanship.
- But Lady de Rothschild isn't interested in convening big names for the sake of it, not even the Pope. Like the Pontiff, achieving tangible, hard-hitting outcomes from multi-party coalitions takes a delicate balance of push and pull, she says, plus plenty of listening.
- My idea of success is that no one is 100% happy. I want some people to feel we went too far and others to feel we haven't gone far enough
- "With the Coalition for Inclusive Capitalism, it's not about what I think should happen. It's about setting a goal and working with people who are willing to make that goal stretch as far as we can. So, my idea of success is that no one is 100% happy. I want some people to feel we went too far and others to feel we haven't gone far enough."
- She is taking that same approach to another of the coalition's new projects, which focuses on the design of rules and guidelines for the booming ESG (environmental, social and governance) investment market among asset managers.
- The project remains in its early stages, but Lady de Rothschild isn't shy about voicing her feelings about the market's failure to deliver a substantive response to the world's most pressing social or environmental problems.
- Her strongest criticisms are directed at exchange traded funds [ETFs], which see investors passively follow a pre-determined index of supposedly "sustainable" stocks. Speaking at a recent Reuters Events Sustainable Business webinar, she argued that most ESG-oriented index-linked funds have "90% the same stocks as are in regular ETFs".

Instead of generating meaningful impact by directing capital to sustainability innovators in high-carbon sectors, she added, ESG investors typically opt for "safe" stocks such as big tech firms, which generate high returns but make little material difference on carbon emissions or on other critical sustainability issues. "They [ESG funds] have done well because when you've invested in Apple and Amazon and Microsoft, then your ETF has done well. [But] have these companies really moved the needle towards a fairer society or a cleaner environment? The answer is probably 'no'."

The alternative, she suggests, is to take a more active stance. So, not just going through a checklist with a sustainability officer and "checking the box", but actually "digging into companies and influencing their behavior". Her new investment fund, Inclusive Capital Partners, which she joined in the summer with veteran activist investor Jeffrey Ubben and two other partners, will aim to take majority positions in publicly listed firms that are proactively (and profitably) seeking to provide answers to the big sustainability challenges of the day. The fund has so far attracted \$1.4bn.

There are many efforts to make capitalism inclusive and sustainable, but what we have been missing is a moral base – the poetry to the prose of our action

The number of global corporations genuinely transitioning to a more inclusive model of business are still few and far between, de Rothschild concedes, but the roster of companies involved in the Vatican partnership shows that what would have been a hypothetical argument even five years ago is now a genuine, here-and-now possibility.

The partnership also opens up a conversation about global capitalism's moral underpinnings. In an age of Covid-19 and climate crisis, even arch-market capitalists can no longer ignore the very real ramifications of treating markets as answerable only to cold numbers and hard logic.

"There are many efforts to make capitalism inclusive and sustainable, but what we have been missing is a moral base for the movement – the poetry to the prose of our action," she reflects. "The guidance of Pope Francis provides that poetry to the movement, but humanity's need to be responsible to each other is inspired by the social teachings of all faiths."

Almost 10 years on from de Rothschild's Damascene moment, the world is facing an even more frightening economic crisis. The idea of inclusive capitalism has never been more prescient. After a decade taking root, now is its time to take leaf and bloom.
