HE WHITE-BEARDED, HEAVYset man with the deeply sunburned face and the mild Southern baritone is a study in earnest authority. Richard Rives is explaining how the Ark of the Covenant, sacred receptacle of the Ten Commandments, was smuggled by the prophet Jeremiah out of the First Temple in Jerusalem before its destruction

"Sometime around 600 BCE, due to abominations," he tells The Report, "the Glory of God departed from the 'Mercy Seat' [the cover of the Ark]," and Jeremiah saw fit to move it to safety. The prophet, Rives continues - his account reflecting the theology espoused by the Protestant archaeological group he leads - brought the Ark from the Holy of Holies, through a tunnel under the city walls, to a cave at the Garden Tomb, where Protestants believe Jesus was later buried. And so, "in 586, when the Babylonians captured the city, the

Ark was missing." Safe in the cave, just to the northwest of the present day Damascus Gate, the Ark survived the destruction of the Temple, Rives asserts

Six centuries later, his group's theology further holds, Jesus was crucified on the hill directly above the cave, and his blood miraculously filtered through a crack in the rock and purified the Ark below. And there it remained for nearly 2,000 years, until Rives's predecessor, the late Ron Wyatt, discovered it on January 6, 1982, at the triumphant conclusion to years of digging at the Garden Tomb.

Also found by Wyatt at the site, accord-ing to this account: the Temple's sevenbranched candelabra, a golden altar, an ephod, or breastplate, and, in the Ark itself, the scrolls on which Moses presumably had written the "Book of the Law." Wyatt did not emerge with the astonishing finds to show the world, but promised to reveal their precise location when the time was deemed ripe.

This tale accords with neither the tenets of modern archaeology nor any mainstream faith. There has been no shortage of theories about the Ark's purported survival including a bestseller on its location in a church in Ethiopia. But most Biblical

scholars believe it was incinerated at the time of the Babylonian destruction, says Jim Fleming, director of the Biblical Resources Study Center in Jerusalem, who has also lectured in archaeology at the Hebrew University. And, according to Fleming, the assertion that Jesus was crucified above the Garden Tomb is not widely held, either,

Yet Rives expounds the unorthodox theory not at an offbeat Christian gathering, but at an Israeli government-authorized dig at Zedekiah's Cave, near Damascus Gate, beneath the Old City wall - on the very route he asserts that Jeremiah and the Ark took. Under the formal auspices of the Israel Antiquities Authority (IAA), the two-week dig earlier this summer was carried out by Rives and 37 of his supporters from around the world, intent on finding Jeremiah's tunnel. It was funded by their donations and those of other supporters of his group, the Cornersville, Tennessee-based Wyatt Archaeological Research foundation (WAR).

Over the years, WAR and its founder Wyatt, who died of colon cancer in 1999, claim to have discovered not only the Ark of the Covenant and other Temple treasures, but also proof that Jesus was crucified directly above the cave in which the astounding cache was "found." Further afield, they also claim to have found the fossilized remains of Noah's Ark in Turkey, the site of the Israelites' Red Sea crossing and the Biblical cities of Sodom and Gemorrah. These claims have generally been dismissed by mainstream archaeologists.

So how did WAR come to be digging in Zedekiah's Cave - just a few hundred vards from the ultra-sensitive Temple Mount - with the sanction, indeed encouragement, of the Israeli government's archaeological authorities? (False rumors that Israel was tunneling under the Temple Mount in 1996 prompted the so-called Hasmonean Tunnel riots in East Jerusalem and the West Bank, in which some 60 Palestinians and 15 Israeli soldiers were killed. In fact, Israel was opening a second exit, in the Christian Quarter of the Old City, to an ancient water system that ran alongside but not under the Mount.)

And why would the IAA have agreed to the dig when, according to the IAA itself, the Wyatt track record in Jerusalem is disturbing? Although WAR claims that Wyatt's work in Jerusalem in the late 1970s and early 1980s was carried out in compliance with the Israeli authorities, the IAA's Jerusalem Region Archaeologist,

YATT ARCHAEOLOGical research was founded in 1993 as a non-profit foundation, committed to uncovering evidence of the historicity of Biblical events. Wyatt, a Tennessee nurse-anesthesiologist and amateur archaeologist, had made headlines a decade earlier when he claimed to have discovered a fossilized Noah's Ark — complete, according to WAR's website, with hard fossilized deck timber — near the

silized boat; an article published in 1996 by the respected American Journal of Geoscience Education credits Wyatt with reviving interest in the site in the 1980s, but explains that the site's peculiar formations, as well as objects mistaken for petrified wood or iron fittings, are the products of nearby volcanic activity and other geological processes.


For Wyatt Archaeological Research, such scientific conclusions are insignificant. It still sells videos today, for instance, hailing the discovery of "Noah's Ark"; according to WAR's website, the \$30 tape includes "graphics explaining the processes which preserved the remains" and documentation of "scientific testing as it took place."

In a WAR newsletter published in 1994, Wyatt's wife Mary Nell Wyatt, compares those who reject his findings to contemporaries of Jesus who refused to accept him as the Messiah. She also admiringly quotes Rives — who began working with Wyatt in the early 1990s, was named curator of

have been sold, nor give figures for donations to WAR or sales of other WAR materials — including videos and books on other purported discoveries. (Other sourcesestimate WAR's annual revenues and donations at \$140,000 or more.) But Rives says that all "proceeds from sales and donations go straight into the work" of the group, and that "there is a great interest in the work of Wyatt Archaeological Research in all parts of the world." He adds that the elegant website — with its accounts of the various adventures and "discoveries," and its online catalogue of WAR products — "has been visited by hundreds of thousands" of people.

Such visitors are also given the opportunity to make tax-deductible contributions to WAR. As of early August, the site also offers a 15-minute video on the just completed dig at Zedekiah's Cave "as a gift to those who would like to contribute \$50 or more." The website describes the WAR team as having completed "a seemingly insurmountable task": "In an unprecedented

In a WAR newsletter in 1992, Wyatt expressed his delight that he had been privileged to discover archaeological proof of the veracity of the Bible. Mankind was nearing the end of history, he asserted. And the findings demonstrated that God was now choosing to reveal His past supernatural actions on man's behalf.

In fact, the "Noah's Ark" site at which Wyatt dug had attracted archae-ological interest for many years. As long ago as 1960, Life magazine had described a scientific expedition which had failed to reach definitive conclusions over the origins of a curious, boat-shaped rock formation there. Subsequently, geologists concluded that the formation was not a fos-

WAR's museum in Tennessee in 1997, and became president of WAR after Wyatt died — as dismissing scientists and other academics who believe in evolution.

Gate. The cave, which extends far beneath the crowded Moslem Quarter, is a relatively little-known archaeological site — but critically, for WAR's concerns, it lies on a direct line from the Temple Mount to the Garden Tomb.

As the two-week dig neared its conclusion, Rives and his team of volunteers were an enthusiastic, and dusty, crew — but prevented by the terms of a non-disclosure agreement with WAR from discussing its specifics. They were plainly delighted to be in the Holy Land and participating in what they indicated they thought was work of immense potential importance. They had come mainly from the U.S., but some were from further afield, including Scandinavia, Eastern Europe and Australia. All had

signed up in response to an appeal for volunteers on the WAR website. One American volunteer, who grew up in a Jewish household before joining the Seventh-Day Adventist Church at the age of 25, spoke of the thrill of visiting Israel for the first time.

Bidding the group farewell at the conclusion of the final day's work, Yehiel



and fundraising activities.

He has continued to keep tabs even after the end of his 25-year tenure at the IAA, for whom he still works as an independent consultant. In the process, Zias has accumulated a thick file full of press clippings, End-of-Days pamphlets published by WAR and various groups which accept entire project — managed the site, documented the findings and ensured that all excavation proceeded according to standard archaeological practice. Furthermore, Seligman notes, while WAR cannot be prevented from issuing sensational claims about any finds there, it must not imply that such claims are in any way corroborated by

WAR still sells \$30 videos of its 'Discovered Noah's Ark'

Zelinger, the IAA archaeologist who supervised the dig, told them: "Although we do not believe in the same things, we have worked together, and it was quite nice."

Archaeologist Joe Zias, for one, however, considers it scandalous that WAR was here at all. As the former curator of the IAA's collections at the Rockefeller Museum — just down the road from Zedekiah's Cave — Zias has followed Wyatt and WAR closely for 15 years, and believes that the IAA, by sanctioning and supervising the dig, is damaging its own reputation and credibility, and providing unwarranted legitimacy for WAR.

Zias says his interest in Wyatt, and his sensational claims, was particularly stirred in the late 1980s: Three Christian ministers from the American Midwest came to see him at the museum to discuss Wyatt, who had been fundraising at their churches. They told him that the fundraising was highly effective, and they wanted to be sure that the money from the members of their congregations — which might otherwise have been donated for church work with the homeless, the hungry and other disadvantaged parishoners — would be properly used. Zias says he was unable to offer such confirmation, and began keeping an intense watch on Wyatt's archaeological

Wyatt's findings, and other documents detailing the WAR enterprise.

And Zias has reached the firm conclusion that the IAA should be steering well clear of, rather than sanctioning, digs by WAR. "Under the guise of religion, you can get away with anything," Zias muses. But when a respected archaeological body such as the IAA cooperates with such groups, he says, "it seriously damages archaeology, and makes us look like a bunch of Indiana Joneses."

It was Seligman, the IAA'S Jerusalem Region Archaeologist, who enabled the two-week July dig after receiving a proposal from WAR for excavations at Zedeki-ah's Cave. And he did so, he says, in full knowledge of WAR's unorthodox beliefs and unsubstantiated claims — and even though, Seligman himself asserts, Wyatt's 1982 dig was carried out without IAA sanction. "There is a correlation of interests," Seligman explains. When WAR contacted the IAA and proposed a dig at the cave, the IAA saw an opportunity to learn a great deal about the technology and lifestyles of the Hellenistic and early Roman periods. Besides, Seligman notes, "Wyatt is dead. We're talking about different people now."

Seligman stresses that the actual dig permit was granted not to WAR, but to IAA archaeologist Zelinger, who supervised the the IAA — thus, says Seligman, ensuring that there can be none of the damage Zias fears to the IAA's credibility.

And indeed, WAR's dramatic account of the dig stands in some contrast to Seligman's bland summary. It was a "small dig," he says, and far from posing any unusual technical challenges or dangers, was "simple" and "easy."


Seligman says he sees Rives and his colleagues simply as members of a religious community whose beliefs diverge from his own. And if, in time, it turns out that they misrepresent what they were doing here — "if they say [in their publications] that they managed the dig, [rather than that they dug under IAA supervision] — I will send a letter: 'Sirs, you have violated the contract.'"

AN BAHAT, AN ARCHAEOLogist currently at Bar-Ilan University, was the IAA's Jerusalem Region Archaeologist in 1982, when Wyatt "discovered" the sacred Ark of the Covenant and the other astonishing Temple treasures.

Like Seligman, Bahat says that dig was carried out without the IAA's permission. Eventually, he recounts, the site's Anglican caretakers even refused to let the self-

Bahat, a leading expert on Jerusalem's archaeology, agreed to visit, and used his influence to get Wyatt into the site one last time — otherwise, he feared, Wyatt and his supporters might have charged, damagingly, that "the Israeli government has something to hide there." He says he reassured

The unnamed Israeli archaeologist was so excited by the event, continues the account, that he committed on the spot to provide all the necessary permits and cooperation not to mention accommodation, food and even laundry services - for Wyatt to return and uncover the Ark. And so began the four-year effort which would culminate with the "discovery in 1982

as early as 1978, knows of no divine revelation, and therefore could not, and would
not, have been inspired by it to lend his
assistance to Wyatt's efforts.

But whether or not Wyatt ever did receive the response which the WAR newsletter describes from an unidentified Israeli official, Bahat insists on two facts: coveries. Reflecting ruefully on his assurance to the Anglican authorities, back in 1982, that Wyatt would not misrepresent his findings, Bahat says, "I came out of it cheated."

Yet Bahat shares Seligman's tolerance for Wyatt and his successors, and sees no need to exclude them from IAA-run digs. Ron Wyatt was a man who decided he knew where the Temple treasures were to be found," Bahat states indulgently. While this claim was, according to Bahat, an innocent delusion, it was "done with a pure heart." And his followers continue to provide welcome sponsorship for the cause of legitimate archaeology in Israel. In the case of this summer's dig, he says approvingly, "the IAA has cooperated because it's been an opportunity to study Zedekiah's Cave on someone else's dollar." And Bahat offers another consideration in favor of this summer's cooperation with WAR, echoing his 1982 decision to come to Wyatt's assistance. If Israel hadn't said yes, "they could have said 'these Jews have a campaign against us.

Zias, though, is thoroughly unimpressed. Wyatt Archaeological Research, as far as he is concerned, is raising funds from well-meaning supporters by making unwarranted claims about its "discoveries." And the IAA, by enabling WAR to keep on digging, is facilitating that process. Time after time, Zias returns to a quote which he attributes to the Roman senator Seneca: "Academics should be lawyers for the masses."

HE IAA-WAR DIG NEAR DAMascus Gate concluded on July 24.
Its goal, Rives told The Report, was to explore "an anomaly" in the cave which had earlier been detected by WAR's ground-

the Anglican authorities that Wyatt's intentions were honest: "I said to them, 'If there's nothing here, he'll say there's nothing." And as Bahat expected, "Wyatt took me to see something in a pit near the Garden Tomb, and there was nothing. I told him I didn't see anything."

WAR offers a more colorful story about the dig at the Garden Tomb. According to a WAR newsletter published in 1994, for example, the story of the dig begins in 1978, when Wyatt took a walk along the "Calvary Escarpment," in the area of the Garden Tomb, with the head of the Israeli Antiquities Department. In the course of this walk, the newsletter claims, a divine force took over Wyatt's body. Wyatt's arm was

In 1982, when he was the Jerusalem Region Archaeologist and Wyatt was digging in East Jerusalem, Wyatt did not have a license to dig there. And, moreover, Wyatt could not have received such a permit, even had an Israeli official wished to grant it, because he wasn't qualified. Seligman confirms that Israel's antiquities laws require that a permit-holder for a dig hold at least a bachelor's degree in archaeology, be affiitated with a recognized archaeological institution which can take upon itself the responsibility to publish the dig's results, and be approved by a committee. Wyatt did not meet these criteria.

Nor does Bahat give the least credence to Wyatt's claims regarding the dig's dispenetrating radar. And this goal was achieved. The WAR website says that the "anomaly" turned out to correspond to a hollow, which had at some point been filled in. The team's excavations, it adds, have provided new support for Ron Wyatt's account.

Although there are no firm plans at present, Rives says he hopes that WAR will soon be back in East Jerusalem, digging again with the IAA: "We are hoping to find a true void, an open area indicating the existence of an ancient passageway"—through which, presumably, Jeremiah smuggled the Ark to its hiding place. The IAA's Seligman, too, says he sees no reason why the fruitful cooperation should not continue.


This crack in the bedrock then continued up the side of the hill near Jeremiahs Grotto rock face ledges believed to have happened at Christs death. This same blackened substance had fallen onto the stone sarcophagus lid where it had split in the middle from an earthquake. 


Satelite view; Temple Mount & SHIN **


The Lamb that was slain the "Prince of Peace" His own blood seeped down through a bedrock crack to land on the Ark of the Covenant mercy seat lid. This Ark of the Covenant hidden away in a cave in the very place of God's name "El Shaddai" meaning "God Almighty" written into the earth. As already stated, the word SHIN w also means "Peace" for Jesus is the "Prince of Peace" Is 9:6. This entire

There was a 40-foot chiasm below his dig spot. Ron had dug a tunnel route up to 100 feet going down into the hill from beneath Jeremiahs Grotto. You can see this chasm dug out that was full of rubble with cross holes found in the Grotto where the Israel Antiquities Authority created a table and chairs construction site on next few pages. Ron didn't know fully where to dig, he just kept digging and looking for the Ark of the Covenant for nearly 4 years with 21 trips to the site until it was found.



During the excavations Ron dug down the cliff face he removed debris uncovering three cut out ledges in the rock face at Jeremiahs Grotto, these sat directly above his excavation hole. The carved-out ledges with the curved top ledges as seen in these pictures were a common practice in ancient times as found in other archaeological dig sites. Ron strongly believed the signs of Jesus crucifixion were possibly placed here also put on crosses as well. The Romans were very public with crucifixions and signage to intimidate the locals, this spot in ancient times was next to a main road. On the next page is an artist's impression of the cut outs. Four cross holes were found 14 feet beneath these cut outs through tunnels Ron had excavated under piles of rubble.

Some errant critics will say Ron Wyatt never even conducted a dig, or that he never found a chamber. Here are exact quotes from the IAA web site:

"The excavation was conducted south of a natural bedrock outcrop that was identified by General C. Gordon in 1883 as Golgotha (Fig. 1). During the 1980s, R. Wyatt excavated several underground chambers at the site. The current excavation cleaned and documented the former chambers and additional chambers were excavated."

"R. Wyatt conducted an excavation in the 1980s, which revealed a number of subterranean cavities. In the wake of the excavation carried out in 2005, which cleaned and documented the cavities (HA-ESI 118), a square (5 × 7 m) was opened for the purpose of exposing the remains from surface to the underground cavities."

Some critics, influenced by darkness and ignoring video testimony, will say Ron never even conducted an excavation. This evidence shows something different.

The three cut out ledges found in 1979 at ground level at Jeremiahs grotto have since been altered chiselled back for construction, with some of the walls smoothed out (see next page pics). The Ark of the Covenant cave is 40 or so feet directly below these cut outs. Rons dig hole into the hill was positioned directly beneath these cut out ledges the cross holes found were 14 feet below the ledges. This area now has a table chairs and deck built there near Jeremiahs grotto for tourists to rest. Ron found the first cross hole on an elevated six-foot ledge then he dug down another four feet in front of this ledge to find three more cross holes in a row, the fourth cross hole on the ledge above had the bedrock crack in it the cross hole of Christ. The fourth cross hole on the elevated bedrock ledge years later has been destroyed dug up. Even the Place of the Skull itself has suffered much erosion in the last several years.





Above is the 2005-2006 construction area with the chasim beneath Rons dig site hole, now uncovered and cleaned out by the Israel Antiquities Authority they knew of Ron Wyatts discoveries here. They cleaned out the dig site then built a small building with a tourist rest area and chairs called the "deck" over the top of it covering it up. The cross holes were destroyed, the alter and the foundation walls removed from an anchient old building they then covered part of the alter ledges on the site, they filled Rons dig tunnel up with reinforced concrete. Rons dig site is no longer accessable its all covered over and locked up. In later years specialised detector testing for gold was done over 30 times on this very spot signalling a lot of gold sits directly below the ledges beneath the chasim below.

By 2025 the IAA had built a small fully enclosed roof and glass building over the top of this very spot, this seems to be a lot of effort to cover over something they deny even took place with Ron Wyatt. There is no way any one else will get access to Rons past dig site it has been completely closed down and cut off by the IAA. For some reason the IAA have completely changed and protected this area I wonder why? As Ron Wyatt himself said the IAA actually have another access tunnel into Jeremiahs Grotto cave through Zedekiahs cave.


when you sit here you sit directly above the crusifixation site of Christ and the Ark of the Covenant hidden below in Jeremiahs cave.







Ron Wyatt found a manmade stone wall and worship alter stone set into a stonewall with a fourth cross hole, covered over with a square stone lid directly in front of the alter on an elevated platform. This cross hole had an inch wide crack in it that ran down 20 feet into Jeremiahs cave below. The alter stone elevated ledge and rock face were once part of an ancient building that had been built over this crucifixion site. Three other cross holes were found in front of the elevated platform a further four feet down under rubble. Rons excavations partly uncovered a large (13 feet) round two feet thick flat stone in front of the three cross holes in a row believed to be the Garden Tomb seal-stone. Ron was convinced this was the crucifixion site of Christ.





Above you see an artist impression of a side view of the wall where the three sign ledges were beneath was the alter and elevated cross hole with three other cross holes at Jeremiahs grotto dig site. You can also see the tomb stone that was moved several feet from Jesus actual Garden Tomb site Ron partially uncovered it. This round tomb stone was located by ground penetrating sonar it was several feet underground and 13 feet across at Jeremiah's Grotto excavation site, the round tomb stone was never fully excavated by Ron. The Garden Tomb of Christ was only discovered in 1867.






Ron discovered the cut outs first in the wall then the four cross holes. The cross hole on the elevated ledge according to Rons son had a Tiberius coin in the bottom of the hole. This elevated cross hole had the bedrock crack an inch wide running through it on the left side of the hole. Ron later excavated in the cave where he found the Ark of the Covenant 20 feet below these cross holes (cross holes were 13 by 14 inches wide) this is where this crack emerged in the cave roof. Ron Wyatt also found several other Roman coins in a cave tunnel chamber behind the cross holes. One coin had Tiberius Julius Ceasor Augustus on it dated 14-37 AD an identical authentic crucifixion era coin, see an example below.



The pictures below are of the fourth elevated cross hole on the platform under the stone alter believed to be Jesus cross hole. Other photos are passed around of this, but these are the correct photos of the elevated cross hole discovered and taken by Ron Wyatt himself. The fourth cross hole was destroyed by the 2005-2006 construction and building of the tourist platform table and chairs at the grotto.



One day, in 1978, Ron Wyatt was walking in the vicinity of Golgotha and The Garden Tomb. As Ron Wyatt walked past the Calvary Escarpment he was talking to a Jerusalem antiquities authority about Roman antiquities which Ron had just discovered. Suddenly Ron Wyatt pointed to a site being used as a rubbish dump and said, "That is Jeremiah's Grotto, and the Ark of the Covenant is in there."

The Garden Tomb site Without realising it, Ron Wyatt was prophesying, under the anointing of the Holy Spirit. The official with Ron immediately said, "That is wonderful! We want you to excavate. We will grant you your permits, put you up in a local hotel, and even provide your meals!"

Ron knew that this was a supernatural event, but he also knew that not all such events originate from God, and was naturally cautious. So, Ron returned home to the USA, and began to research the history of the Ark of the Covenant, to see if the Ark could be hidden in this area in the North of Jerusalem.

After 4 years of digging 90 feet of tunnels beneath Jeremiahs Grotto wall Ron eventually found a 16-inch stalactite hanging from a small enclosure roof. This was prior to the new cave he later named as Jeremiah's Cave. Ron then broke the stalagmite from the roof of the tunnel in behind the stalactite was hiding a small fist sized hole; this went through a solid stone wall into another chamber as Ron soon found out.









The three top photos are CGI re creation bottom photo is the actual stalagmite that Ron broke off. On the next page are the actual photos of the shaft hole leading to the Ark cave Ron broke into with all the rocks on top. Items such as this stalagmite shown in this chapter were in Ron Wyatts Museum in the USA.

Ron began working on that small hole behind the stalactite to open it up, this hole led Ron into what he called Jeremiahs Cave. Ron opened up the hole big enough to fit a small body through into this new chamber. At first Ron sent in a young Arab man but that man got spooked terrified and came out saying what's in there? he took off running and he would not go back in. Ron enlarged the hole so he himself went in this time to where he saw a lot of large stones piled up to the roof of this new cave chamber.

Ron had to crawl across the top of rocks close to the roof of the cave. Looking down from being on top of these rocks was when Ron could see further by torch light he spotted gold reflecting from his torch. Ron then realised in the midst of these rocks was a solid stone box and lid covering a sarcophagus.

Ron gained excavation permission and licenses from the Israeli government in 1978 four years later in 1982 on Jan 6th at 2pm the Ark of the Covenant was discovered. Once Ron could see solid gold under the split lid of the sarcophagus he realised, he had found the Ark of the Covenant. Ron then saw a black substance on the cave roof around a crack above the stone lid and on the sarcophagus lid. When Ron realised this was the centuries old aged dried blood of Jesus Christ, he fainted for about 45 mins at the revelation and magnitude of what he had discovered.

Inside Jeremiahs cave chamber along with the Ark of the Covenant was also found (10 commandment stones, jar of manna Arons rod) the sword of Goliath, 7 branched candlestick an incense burner and pomegranate, an ephod, tabernacle tent poles and gold covered boards, the alter of burnt offerings, brass ring, table of show bread, some Old Testament scrolls on animal skins in very good condition, several oil lamps and other gold furniture. All of these temple items were covered in old animal skins under the rocks (Picture are CGI descriptions of the discovery). According to eye witness testimony there is video taken of this cave and bits at the time of the initial find yet this resides with a trusted friend of Ron Wyatts, if this ever comes to light we will never know deepening the mystery.



Ron also found 7 ancient Hebrew oil lamps in this cave he gave 6 to the Israeli antiquities department and kept one for himself see pic on next pages. The oil lamp Ron kept had a ram engraved upon it caught in a thicket seemingly depicting Abraham's sacrifice of Isaac and Gods provision. This very dig sight was next to Mount Moriah the traditional place of Abrahams alter of sacrifice with Isaac. Ron reported his find all to the Antiquity Authorities they could hardly believe what he had found and ordered him not to tell anyone about it, but it was too late Ron confessed he had already let some people know. Ron had a

very close friend with him at the time that also peered into the cave chamber as a witness to the find. Ron also ran a tape measure up through the crack in the chamber roof above the Ark it came out through the elevated cross hole 20 feet above into his assistants hand an exact measurement.





Rons oil lamp on the left he kept from the 7 oil lamps found in Jeremiahs Cave Ark of the Covenant discovery showing us the ram caught in the thicket, Gods provision also became the Lamb Christ for our sins. The lamp on the right is 1700 years old t iwas found in Jerusalem during Israel Antiquities Authority excavations. Rons lamp pre dates the lamp on the right by 900 years to Jeremiahs time before 587BC. This lamp has black smoke marks on it as did the others from when they were used to enter the cave.

The stones packed into Jeremiahs cave were blocking the way in and out of the cave where the Ark was found. The stones were placed there by Jeremiah and his men 2604 years ago in 587BC safely hidden away for two and a half millennia. These stones covered the temple furnishings, under the stones were animal skins and boards protecting the temple furnishings. Ron later drilled a hole in the side of the stone sarcophagus box containing the Ark of the Covenant to take pictures as he tried to film it. The gold Ark reflected his torch light so much it kept blurring the pictures, so no clear pictures emerged only blurred pictures from the glare. Ron had taken nearly 600 pictures of the Ark all were blurred due to reflection issues from the gold and Gods desire to keep it hidden for now. Ron got only 2-3 clear pictures of the Ark but God had told Him he was not allowed to reveal them to the world "it's not time" this situation of obedience deeply hurt Ron. Ron gave these clear pictures to another friend for safe keeping in his later this friend is known by Kevin Fischer whom promotes Ron, maybe one day these will come to light.

Inside Jeremiahs cave Ron Wyatt also found the original entrance to Jeremiahs Cave that entered from Zedekiah's Cave system. This entrance was on the far side from where Ron had broken though the wall from Jeremiah's grotto direction. It was in 587 B.C the Babylonians had surrounded Jerusalem then the eventual Babylonian captivity came in 605 BC, the Ark of the Covenant was hidden away by Jeremiah.







Blurred picture taken through Rons drill hole of the Ark you can make out an angel priest holding a staff on top of the Ark lid in the cave (pic on right CGI). Jeremiahs original cave entrance leading into where the Ark was placed after being transferred from Solomon's Temple came through Zedekiah's Cave. Zedekiah's Cave is a well-known tourist spot as part of the infamous Mines of Solomon. A shaft

travelling 40 metres away from Jeremiah's cave underground then connected across to a 375-foot tunnel leading to Zedekiah's cave. Zedekiah's cave itself then went further back by another 400 meters or so to its entrance at the surface (tourist spot see next few pages).







Zedikiahs Cave is in the red above opposite the Place of the Skull and bus terminal it is connected across to Jeremiahs Grotto cave via a smaller shaft tunnel where the Ark was found. Left of the red arrow is the place of the Skull at the bus terminal, right of the arrow is Jeremiahs Grotto.







Above is Zedikiahs cave entrance opposite the Place of the Skull along with the cherubum sign that was found found in 1874 deep inside the cave. Zedekiah's cave system goes back 740 metres from its entrance with tunnel links across to Jeremiahs Ark cave. An offshoot tunnel had connected to Jeremiahs cave where the Ark was blocked off by a manmade stone wall. There was a cherubim carving marked in the wall by the Zedekiah cave connecting entrance to Jeremiah's Cave. This carving was removed in 1874 and taken to a museum in London where it now resides held by the Palestine Exploration Fund.







The spot in the wall where the cherubim (right cherubim CGI) was removed deep inside Zedekiah's Cave is close to the entrance of the shaft that led to the Ark in Jeremiahs cave near Jeremiahs Grotto. This

cherub was deemed to secretly mark the way to the Ark of the Covenant as a symbol. For obvious reasons this off shoot tunnel is off limits to the public walled off. Where the cherubim hole was there was a wall constructed that blocked the way through to Jeremiahs Cave tunnel. This manmade wall was 50-60 further in from the cherubim hole cut out. In the later years after the Ark discovery Ron would come to this wall and an angel or man would say to him "remove the stones and go forward" or "you cannot enter". Ron would then access Jeremiahs Cave and the Ark of the Covenant from the Zedekiah Cave connecting tunnel behind the wall, he knew the right pathway to take.





Years later Rons sons Dannie and Ronnie found in Zedekiah's cave part of this wall had been excavated, they found a green locked steal door with a long dark cave tunnel in behind the door not far from the cherubim hole in the wall. One of Rons sons said you went down a steep dip then out a sort of hole up to a ledge where the door was located. Ron Wyatt said he was very surprised and happy that his boys had seen the tunnel in Zedekiah's cave that led to Jeremiahs Cave.

In the mid to early 2000's further excavation and readings were done on this back wall in Zedekiah's cave catacombs near the cherub carving site. In behind this wall is the linking tunnel that goes back 375 feet to Jeremiahs Cave where the Ark of the covenant resides according to Ron Wyatt. This wall had been built to block the way into the access tunnel to Jeremiahs Cave, these people did not go through the wall.




Measurements of the space in behind this wall were taken via radar equipment.



Re Cap: Jeremiahs cave that Ron had broken into was situated beneath Jeremiahs grotto through several feet (20) of solid stone. Not far beneath Jeremiahs Grotto is the current location where Ron found the Ark of the Covenant in the stone sarcophagus. The earthquake that took place at Jesus death tore the 2nd temple veil in two as found in Math 27:51 where it also split the rocks. The crack in the rock started above the Ark in the roof of Jeremiah's Cave that then went 20 feet straight up connecting to the centre cross hole above at Jeremiah's Grotto, where the four cross holes where found. The crack is actually on the left side of the centre cross hole Ron found.

At the moment of Jesus death in scripture it states an earthquake took place Math 27:50-51, Mark 15:33 this would have formed the downward 20-foot crack from the cross-hole Ron had found at Jeremiahs. This downward crack in solid rock opened up into the cave chamber of the Ark an incredible situation. The split in the rock came out directly above the Ark in the cave roof above the stone sarcophagus lid. The split in the sarcophagus lid had pushed one part of the lid eastward opening up the sarcophagus exposing its contents. God had arranged miraculously for the Ark with its mercy seat to be placed directly below Christs crucifixion cross hole. The Ark had been placed in that position in Jeremiah's cave 600 years before in 586 B.C. Jesus blood had landed on the left side of the mercy seat lid.





The actual date of the 33 AD Passover earthquake can be found in written history from historical recorded evidence by four differing historians of the day, whom were all outside the Bible as authors. The four ancient historians were Phlegon (137 AD), Thallus (52 AD), Africanus (221 AD) and Tertullian (160-220 AD). The earthquake is said to have occurred on April 3rd in 33AD, then after 3 hours of darkness from mid-day onwards Jesus died this was at 3pm and the earthquake hit. This was not an eclipse as they only last 10 mins or so this was 3 hours of supernatural darkness.

The time and accuracy of Jesus death can be found in history through the Artaxerxes decree in 457 BC (Ezra 7:7) where he authorised Jews to return to Jerusalem from the 70 years of Babylonian captivity. The Jews were authorised to also rebuild the walls and the city of Jerusalem. If we calculate from 457 BC to 27 AD it is the end of 483 years as found in the Dan 9:24-27 seventy-week prophecy. Jesus began His ministry at 30 years of age Lk 3:23, in the 484th year from 457 BC at the beginning of the 70th week of Dan 9:25. Jesus ministry would last for 3.5 years then he was "cut off" crucified for mankind's sins.

Know therefore and understand that from the going forth of the command to restore and build Jerusalem (Artaxerxes 457 BC decree) until Messiah the Prince. There shall be seven weeks and sixty-two weeks (69 weeks completed or 483 years until Jesus begins His ministry as Messiah the Prince, 27 BC becomes the 484th year the beginning of the 70th week). (NKJV)

After 3.5 years of ministry from 27 AD Jesus reached the age of 33 and a half years old at His death on the cross. In the Daniel 9 prophecy He was "cut off" mid-way through the 70th week or midway through the final 7 years of Dan 9:24-27 (See also chapter Zech 11 the staff of beauty broken in two). Jesus was crucified on the cross He was "cut off" Dan 9:26-27 to "finish transgression" Dan 9:24 as He confirmed a covenant for one week or the last 7 years of Daniels 70-week prophecy Dan 9:27. It was in the middle of the 70th week when Jesus was "Cut off" He was crucified 3.5 years into His ministry in 30-31 AD. This was the midway point of the Dan 9 seventieth week. A cosmic shift in realms took place as darkness came for 3 hours then an earthquake hit splitting rocks at His death as the 4-inch-thick veil in Herod's 2nd Temple was torn in two by an invisible hand Math 27:51.

The dead saints of old Jerusalem in Christ rose from their graves and were seen in the streets of Jerusalem at Christ's death and resurrection. This was the beginnings of the first resurrection Math 27:52-53, as Caiaphas had said "one man should die instead of the nation" Jn 11:50-51. Jesus went into the heart of the earth He took the first part of His bride/wife out of Abrahams Bossom to go with Him into heaven at His resurrection. Jesus had preached with signs and wonders for 3.5 years until his death proclaiming the Kingdom has come, for all to repent and be saved through Himself. It was after the cross that His


disciples continued to preach in Jerusalem to the lost sheep of Israel for another 3.5 years until Stephen's death in 34 AD completing the final 7 years of Daniels 70-week prophecy.

During the crucifixion when the Roman solder pierced Jesus side at his death, blood and water had gushed down into the split in the rock below the cross hole from the earthquake that hit. This split in the rock occurred at the moment of Jesus death, blood gushed 20 feet down through split rock onto the mercy seat lid below. This was Gods final miracle act where He fulfilled the Old Covenant and began the New Covenant with the shed blood of His only begotten Son Christ. God through the lambs shed blood of "Jesus" literally anointed the most Holy Place once and for all. The Holy place in the natural realms on earth was Gods Ark of the Covenant. The Ark was Gods throne on earth Ps 99:1, it was symbolic of His Holy place in heaven Gods throne His seat of power Rev 11:19.






Recap:

Jeremiah at Gods direction took the Ark of the Covenant from Solomons Temple 600 years (587 BC) before the crucifixtion of Christ in 30-31 AD. Jeremiah hid the Ark deep inside underground caverns entering through Zedekiahs cave system. A connecting tunnel then branched out into Jeremiahs Cave 375 meters deep from the back of Zedekiahs cavern system beneath. This cave was situated 40 feet below jermiahs Grotto dig site. Above right is just an artists impression in short form of this occurance over 2600 years ago. Jesus own blood fell onto the left side of the hidden Ark of the Covenant mercy seat lid where Ron was shown the black substance. The right side was only used by the priests to sprinkle animal blood 7 times for sin (Lev 16:14). The left side of the mercy seat lid in this situation was reserved for Christ's blood alone. Just the magnitude of this alone is enough to make the hairs stand up on the back of your neck. Ron Wyatt's finding of the "Ark of the Covenant" and this unveiled revelation of what actually happened that day over 2000 years ago is monumental. Truly as scripture states "It's the Glory of God to hide a matter and the Glory of kings to search it out" Prov 25:2.

The next few pictures are what the Ark of the Covenant actually looks like according to Ron Wyatts testimony.







In the anchient past the Ark would be moved around apon the shouldes of levite priests. The 10 commandments, Arons rod and a container of manna was inside the Ark. The Ark box is said to be one metre long and half a metre high then you have the angels attached, it had a drawer in the back for scrolls.

Making the Ark

Exodus 37:1 - 9

Then Bezalel made the ark of acacia wood; two and a half cubits (Israeli cubit 44.4cm to 51.8cm) was its length, a cubit and a half its width, and a cubit and a half its height. He overlaid it with pure gold inside and outside, and made a molding of gold all around it. And he cast for it four rings of gold to be set in its four corners: two rings on one side, and two rings on the other side of it. He made poles of acacia wood, and overlaid them with gold. And he put the poles into the rings at the sides of the ark, to bear the ark. He also made the mercy seat of pure gold; two and a half cubits was its length and a cubit and a half its width. He made two cherubim of beaten gold; he made them of one piece at the two ends of the mercy seat: one cherub at one end on this side, and the other cherub at the other end on that side. He made the cherubim at the two ends of one piece with the mercy seat. The cherubim spread out their wings above, and covered the mercy seat with their wings. They faced one another; the faces of the cherubim were toward the mercy seat.

Scripture describes exactly what Ron Wyatt found in Jeremiahs Grotto cave in 1982. Two cherubim angels of solid gold one at either end on the sides as one piece with the mercy seat. Their wings spread out covering the mercy seat, facing one another looking down toward the mercy seat where the blood was sprinkled. This was designed in the shape of a seat a throne for God to rest upon on the earth His earthly throne.

The blood of sacrificed animals would be sprinkled on the eastward side of the Arks mercy seat lid by Levitical prieists, to atone for the sins of the people Lev 16:14. This was a pre curser to the lamb who was to come slain for the sins of all mankind Jesus Christ, whose own blood landed upon the mercy seat lid anointing the most Holy Place the Ark of the Covenant. The gold angels looked down upon the mercy seat lid where Gods physical supernatural Glory would manifest.



As said already the day Jesus was crucified His blood ran down a bedrock crack 20 feet below onto this mercy seat in Jeremiahs cave Jn 1:29-34, Math 3:13-17, Dan 9:24.



Below is an artists impression of the overview of Jesus blood travelling down through 20 feet of solid bedrock onto the Ark of the Covenants mercy seat lid anointing the "Most Holy" Dan 9:24.



In the Old Testament the most Holy place was the Ark of the Covenant where Gods presence dwelt between the two cherubim on the mercy seat lid, His throne on earth as in heaven. According to Ron Wyatts discoveries Jesus's blood on the mercy seat became a phenomenal miracle of God prepared 600 years before the crucifixion. God literally anointed the most Holy Place with the precious shed blood of the lamb whom was slain before the foundations of this world Rev 13:8 the Messiah Christ Jesus. 








The ancient dried blood from the Ark of the Covenant mercy seat lid was scientifically tested in Jerusalem, Germany and America it was found to be alive having 23 chromosomes from the mother and one Y (Yahweh) chromosome from the father. Normal human blood has 46 chromosomes 23 each from both parents 2 chromosomes determine the sex the "X" and the "Y". 

As seen in the pictures above dried anchient blood specimens were also taken from the crack near the centre cross hole under the cut outs of Jeremiahs Grotto in 1981. The black shape next to Rons hand is a film canister.

The dried blood was put into a film container (dark cylinder on each pic -left pic in Rons hand) the light brown substance Ron points too in these pictures is dried blood on the rock and dirt near the rope. Then right below this dried blood is the crack crevis that goes down to Jeremiahs cave 20 feet below through a split in solid rock.



Brown dried blood is where Ron points just above the film canister down to the crevis just inches below.









The cross hole blood specimins in the film canister sat for many years untouched they were later put under new methods of microscophy. This happened in 1996 at Rons home in Nashville USA when a visisting scientist did some experiments in the basement of his home. The blood particles were put under this new microscope technowlegy (1000 X magnification) it then lit up thousands of living indestructable particals less then a quarter of a micron in size. This was human blood as was suspected, yet there is no proof of whose human this blood is the chromozones were not looked at. As said this dried blood was taken from the cross hole above a separate area to the sarcophagus lid in Jeremiahs Cave.

The actual design of the Ark of the Covenant is amazing created out of Ron's description of the Ark, from what he witnessed in the cave and photos. The lid is solid gold fashioned and connected to angel priests holding a staff in one hand with the tips of their wings touching in the centre of the lid, all created as part of the lid. The Ark lid is made of solid gold weighing about 900 pounds which is way too heavy for one man to lift. The details around this discovery speak for itself one would have to have a huge imagination to make all of these details up. Ron was actually a seven-day Adventist Christian he had no reason at all to lie about what he had discovered. Even though a lot of the evidence around this discovery was over 43 years ago and is now hidden away including the Ark by the Israeli government it's an amazing story. On the next page Ron also found a first temple ivory pomegranate (Solomons Temple) at Jeremiahs grotto cave the only one ever found as seen in pics.

Ron removed this pomegranate from Jeremiahs Grotto during his excavations in 1979, it now sits in the Israeli museum whom once acknowledged Ron Wyatt found it. This pomegranate was later stolen from the museum and then purchased back again from a French antiquities dealer for \$550 thousand dollars, as the museum knew it was real. Insignia on the top of this pomegranate in Hebrew reads "Holy to the priests in the temple of Yahweh". It had an entire room dedicated to it with a spot light directly on the pomegranate for visitors to see. Yet controversy came at the museum over whether or not this was an

ancient counterfeit item pre dating Solomons temple. Later studies under microscope seemed to neither deny no confirm this, all of this is either real or false as many will debate. To make up such a story would be very unlikely, with the evidence presented the cross holes the sign ledges Jeremiahs cave the Ark the blood on the Ark lid the split in the rocks above the design of the Ark it all makes perfect sense.

"The Ark, I suspect is in Jeremiah's grotto. [The] Jews have a tradition it is under the [Dome of the] Rock, but I think it is under the true Altar, the Skull, where tradition places Jeremiah's writing of Lamentations."

"Here at Skull Hill, close the Slaughter House of Jerusalem was Titus 1 to 2m. The Roman Eagle took the heart of Zion by throat, for close was the breach. Jeremiah wrote Lamentations in the cave. The Ark of the Covenant is there." p 55.

The Israeli Antiquites authorities website as seen on previouse page according to testimony at one stage acknowleged Ron Wyatts excavations at Golgotha. This same excavation area was identified by General Gordan in his book above in 1883 as Golgotha the crusifiction site of Christ. General Gordon in 1883 also stated he believed the Ark of the Covenant was some where in Jeremiahs Grotto under the place of the Skull. Yet General Gordon only had time to excavate within 10 feet of where Ron excavated at the site. Extra biblical cannon about the Arks disapearance can be found in 2nd Maccabees written in 100-150 BC a book included in the Apocrapha. There is a very interesting chapter and verses in 2nd Maccabees 2:4-10 about the Ark of the Covenant that it was moved by Jeremiah to a mountain connected to Moses.

"Jeremiah found a cave-dwelling; he carried the tent, the ark, and the incense-altar into it, then blocked up the entrance. Some of his companions came to mark out the way, but were unable to find it. When Jeremiah learned of this he reprimanded them. 'The place shall remain unknown', he said, 'until God finally gathers his people together and shows mercy to them. Then the Lord will bring these things to light again,..." 2 Maccabees 2:4-8

In Jerusalem God took King David and His Ark next to the hill of Golgotha where Davids son Solomon eventually built a temple on Mount Moriah the Temple Mount where Abraham went to sacrifice his sin Isaac. The Jews have continued to practice the passover connected to Moses and the 10 commandments

given on Mount Sinai over 3000 years ago. In 2nd Maccabees 2:4-10 it then stated the Ark, implements and tent were placed into a cave and sealed up, men tried to mark the way but were repremanded by Jeremiah exactly as discovered by Ron Wyatt. It seems the Arks true hiding place is the hill of Golgotha next to Mount Moriah the mountain of Abraham in Jerusalem. With the cherubum carving marked in the wall of Zedekiahs cave (Solomons mines) just as 2nd Maccabees 2:4-20 states. Moses came through the bloodline of Abraham Isaac and Jacob of the tribe of Levi, Moses is connected to Mount Moriah through his forefather Abraham. A pathway that was marked leading to Jeremiahs grotto, in Zedekiahs cave leads to the Ark itself all connected to the mountain of Moses (Sinai) where the Ark was created. The angels gaurding the Ark no matter where its been have done so since the days of Moses on Mount Sinai, all connected to its original creation at Mount Sinai.

The Apocrapha book of 2nd Maccabees is over 2100 years old in its context. In 605 BC the Ark was moved by Jeremiah the prophet during that invasion of Israel by the babylonians. It was in 587 BC around 19 years later when the babylonians destroyed Jerusalem and Solomons Temple 2400 years ago. 2nd Maccabees was written 200-300 years after this historical event took place (605-587 BC) placing 2nd Maccabees authorship around 100-150 BC at the end of the Maccabean revolt. Such a break in time could have altered the story to which mountain/hill and cave it refers to, to then connect it symbolically to the mountain of Moses throwing men off the trail (who really knows). With the Ark you have Moses creating it at Mount Sinai then you have Abraham Isaac and Jacob Moses fore fathers directly connected to Mount Moriah the Temple Mount and Golgotha. Certainly the second part of 2nd Maccabees 2:4-10 verses about the Ark hidden away in a cave sealed up and the way marked by men, lines up with Ron Wyatts discovery at the mountain/hill of Golgotha. These things are not mere conicidences use common sense. In another extra biblical acnnon book from the Apocrapha is the book of Baruch 2 Cahpter 6:1-9 discribes the disapearance of the Ark pre the Babylonian invasion in 587BC. It states the Ark of the Covenant was to remain hidden underground untill Israel is restored as a nation in the end times at the return of the Messiah.

The Apocalypse of Baruch, a two-part book written between the late first and early second centuries BC, is framed as Baruch receiving visions and revelations from God. Its themes include the fate of Israel, the end of times, and the coming of the Messiah. The Book of Baruch 2, Chapter 6, states that he saw an angel remove the Ark from the Second Temple, allowing it to be 'swallowed by the Earth' before the Babylonian invasion, where it would remain hidden until Israel is restored. Baruch ben Neriah was a scribe to the prophet Jeremiah he has traditionally been credited as the author. Still, scholars believe he did not write the book as he lived centuries before the text was written. Because the text is a pseudepigraphal work it was not considered canonical by the Jewish and Christian communities and omitted from the Bible.

According to Ron Wyatt at Gods direction the original blood test results done in Israel and the Ark of the Covenant video filmed in the cave under the angels guidance, were both placed in Jeremiahs Cave chamber on a ledge with the stone 10 commandments near the Ark for safe keeping. Ron also had certificate copies of the blood test results in a blue binder authenticated by a specialist according to eye witness testimony. God is gaurding His Ark untill He is ready to unveil it, Ron Wyatt was the only person allowed near the Ark from 1982 onwards. According to Rons testimony and sons there were six men whom had entered about 75 feet into the tunnel from Zedekiahs cave end heading to Jeremiahs Cave chamber after 1982.





These 6 men worked for the Antiquities Department (IAA) of the Israeli governement trying to get to the Ark of the Covenant. All six men died in the cave tunnel from double brain hemorrhages according to Ron Wyatt. Ron was brought in by the Israeli government to retrieve the bodies. They gave Ron a body basket with a rope tied to it Ron had to put each body in the basket as it was hauled out through the cave. Rons own sons also testify to this taking place on one of Rons visits to Israel and the cave site. Upto 16 people have died mysteriously connected to interferring with the Ark find according to Ron Wyatt. The Ark remains untouched untill this day sitting where it was found in 1982 gaurded by supernatural angels.

A few years before Ron died, Jewish leaders sent six men, who were descendants of the tribe of Levi, into Zedekiah's Cave and into the 375' tunnel which leads to the cave containing the Ark. Their motive was to remove the Ark and destroy Christ's blood to begin their own sacrifices. After traveling 75 ft. through the tunnel, all were killed by angels guarding the ark. These men were in communication with others in Zedekiah's cave who were waiting for them. They refused to enter the tunnel to check on the men, as they had heard terrible cries from the dying men over two-way radios. Mr. Wyatt was asked by the Israel Antiquities Authority to retrieve the bodies. God is protecting the Ark to be a witness of His Son and will not allow men to interfere.





Foreword

Around the world, we are seeing a disturbing groundswell of xenophobia, racism and intolerance – including rising anti-Semitism, anti-Muslim hatred and persecution of Christians. Social media and other forms of communication are being exploited as platforms for bigotry. Neo-Nazi and white supremacy movements are on the march. Public discourse is being weaponized for political gain with incendiary rhetoric that stigmatizes and dehumanizes minorities, migrants, refugees, women and any so-called "other".

This is not an isolated phenomenon or the loud voices of a few people on the fringe of society. Hate is moving into the mainstream – in liberal democracies and authoritarian systems alike. And with each broken norm, the pillars of our common humanity are weakened.

Hate speech is a menace to democratic values, social stability and peace. As a matter of principle, the United Nations must confront hate speech at every turn. Silence can signal indifference to bigotry and intolerance, even as a situation escalates and the vulnerable become victims.

Tackling hate speech is also crucial to deepen progress across the United Nations agenda by helping to prevent armed conflict, atrocity crimes and terrorism, end violence against women and other serious violations of human rights, and promote peaceful, inclusive and just societies.

Addressing hate speech does not mean limiting or prohibiting freedom of speech. It means keeping hate speech from escalating into something more dangerous, particularly incitement to discrimination, hostility and violence, which is prohibited under international law.

The United Nations has a long history of mobilizing the world against hatred of all kinds through wide-ranging action to defend human rights and advance the rule of law. Indeed, the very identity and establishment of the Organization are rooted in the nightmare that ensues when virulent hatred is left unopposed for too long.

Today, I fear, we have reached another acute moment in battling this demon, and so I have asked my Senior Advisers to explore what more we can do. This Strategy and Plan of Action is the result. It points to concrete ways in which the United Nations can play its part in addressing hate speech around the world while upholding freedom of opinion and expression, in collaboration with Governments, civil society, the private sector and other partners.

By enhancing global resilience against this insidious phenomenon, we can strengthen the bonds of society and build a better world for all.

What is hate speech?

There is no international legal definition of hate speech, and the characterization of what is 'hateful' is controversial and disputed. In the context of this document, the term hate speech is understood as any kind of communication in speech, writing or behaviour, that attacks or uses pejorative or discriminatory language with reference to a person or a group on the basis of who they are, in other words, based on their religion, ethnicity, nationality, race, colour, descent, gender or other identity factor. This is often rooted in, and generates intolerance and hatred and, in certain contexts, can be demeaning and divisive.

Rather than prohibiting hate speech as such, international law prohibits the incitement to discrimination, hostility and violence (referred to here as 'incitement'). Incitement is a very dangerous form of speech, because it explicitly and deliberately aims at triggering discrimination, hostility and violence, which may also lead to or include terrorism or atrocity crimes. Hate speech that does not reach the threshold of incitement is not something that international law requires States to prohibit. It is important to underline that even when not prohibited, hate speech may to be harmful.

The impact of hate speech cuts across numerous existing United Nations areas of operations, including: human rights protection; prevention of atrocity crime; preventing and countering terrorism and the underlying spread of violent extremism and counterterrorism; preventing and addressing gender-based violence; enhancing protection of civilians; refugee protection; the fight against all forms of racism and discrimination; protection of minorities; sustaining peace; and engaging women, children and youth. Addressing hate speech, therefore, requires a coordinated response that tackles the root causes and drivers of hate speech, as well as its impact on victims and societies more broadly.

Strategic vision

The UN Strategy and Plan of Action on Hate Speech aims to give to the United Nations the room and the resources to address hate speech, which poses a threat to United Nations principles, values and programmes. Measures taken will be in line with international human rights norms and standards, in particular the right to freedom of opinion and expression.

The objectives are twofold:

- Enhance UN efforts to address root causes and drivers of hate speech
- Enable effective UN responses to the impact of hate speech on societies

Convening relevant actors	When relevant to the context, the UN should support convening of key actors; reframe problems in ways that make solutions more attainable; introduce independent mediation and expertise; and build coalitions.
Engaging with new and traditional media	The UN system should establish and strengthen partnerships with new and traditional media to address hate speech narratives and promote the values of tolerance, non-discrimination, pluralism, and freedom of opinion and expression.
Using technology	UN entities should keep up with technological innovation and encourage more research on the relationship between the misuse of the Internet and social media for spreading hate speech and the factors that drive individuals towards violence. UN entities should also engage private sector actors, including social media companies, on steps they can take to support UN principles and action to address and counter hate speech, encouraging partnerships between government, industry and civil society.
Using education as a tool for addressing and countering hate speech	UN entities should take action in formal and informal education to implement SDG4, promote the values and skills of Global Citizenship Education, and enhance Media and Information Literacy.
Fostering peaceful, inclusive and just societies to address the root causes and drivers of hate speech	The UN System should raise awareness about respect for human rights, non-discrimination, tolerance and understanding of other cultures and religions, as well as gender equality, including in the digital world. It should promote intercultural, interfaith and intrareligious dialogue and mutual understanding.

Engaging in advocacy	The UN should use advocacy, both private and public, to highlight hate speech trends of concern as well as to express sympathy and support to targeted individuals or groups.
Developing guidance for external communications	Communications should be strategically used to address, counter and mitigate the impact of hate speech, as well as counteract its bearing, without restricting the right to freedom of expression.
Leveraging partnerships	The UN should establish / strengthen partnerships with relevant stakeholders, including those working in the tech industry. Most of the meaningful action against hate speech will not be taken by the UN alone, but by governments, regional and multilateral organizations, private companies, media, religious and other civil society actors.
Building the skills of UN staff	UN staff's skills at leadership and working level to understand and address hate speech should be enhanced across relevant UN entities, including via existing programmes.
Supporting Member States	Upon request, the UN should provide support to Member States in the field of capacity building and policy development to address hate speech. In this context, the United Nations will convene an international conference on Education for Prevention with focus on addressing and countering Hate Speech which would involve Ministers of Education.



Researchers used the Centers for Disease Control (CDC) and Prevention Wonder Database to assess the incidence of CRC from 1999 to 2020. They divided individuals into 5-year age groups, starting at 10-14 years of age up to 40-44 years. All age groups experienced notable increases in the incidence of CRC between 1999 and 2020 (Vaccine mandate):

- 500% increase in individuals 10-14 years of age,
- 333% increase in individuals 15–19 years of age,
- 185% increase in individuals 20–24 years of age,

Exporting Blasphemy Restrictions, The Organization of the Islamic Conference and the United Nations

Twenty years ago, few in the West were concerned with matters of blasphemy, apostasy, or insults towards Islam. But the 21st century has seen eruptions of violence worldwide in reaction to, for example, Theo van Gogh's film Submission, the Danish and Swedish cartoons, Pope Benedict XVI's Regensburg speech, Geert Wilders' film Fitna, and the false Newsweek story on Qur'an desecration. Some events, such as the declaration by Terry Jones, a pastor in Florida with a congregation of less than 50, that he would burn a Qur'an during prime time on September 11, 2010, dominated several news cycles. The December 11, 2010 bombing in Stockholm was partly a response to Lars Vilks' Swedish cartoons of Mohammad. Other 2010 events received less attention: in September, Iranian pastor Youcef Nadarkhani

was sentenced to death for apostasy, and in November, Pakistani Aasia Bibi was sentenced to death for blasphemy.

There are many reasons for the increasingly public acts of violence purportedly carried out in defense of Islam. These include broad structural factors such as the growth of international communications, which amplifies events and reactions to events. But another major reason is the ongoing campaign by the Saudibased Organization of the Islamic Conference (OIC), which has given the anti-blasphemy movement weight and traction. The OIC, a 57 member body headquartered in Jeddah, was founded in 1969 to respond to the Israeli—Palestinian conflict. Particularly since the OIC's "Extraordinary Summit" in 2005 in Saudi Arabia, when its campaign over the Danish cartoons helped ignite a global uproar, the OIC's leadership has grown vociferous in denouncing and campaigning against what it indiscriminately and promiscuously calls "Islamophobia."

While religious freedom is traditionally understood as the right of persons rather than religions per se, the OIC has campaigned to redefine religious freedom as enforced respect for religion itself, and especially for Islam and everything Islamic. The OIC and its members have been responsible for placing "defamation against religions"—code for Islamic blasphemy restrictions—on the human rights agenda of the United Nations. This was done in an attempt to shape a new international human rights regime that would supplant existing laws protecting individual freedoms and would instead ostensibly protect religions, particularly Islam. While there were a multiplicity of actors, motives, and agendas in scores of countries during the 2005–2006 Danish cartoon backlash, the OIC lent heft to a decades-long, multiparty campaign—a campaign aimed to export restrictions on "insulting Islam" and blasphemy to the rest of the world.

The OIC Campaign

Today, OIC member countries are demanding that all countries curb the intertwined freedoms of religion and expression. Western countries have been dilatory and confused in their responses to the OIC's demands, not least because the West lacks clarity about what dangers the demands entail and what lies behind them. Recently, most of the discussion has focused naively on questions of how to curb "hate speech," how to identify what are more generally thought to be insults to religion, and how to accommodate such demands within free societies. However, a survey of the two-decade-long OIC campaign reveals that its goals go far beyond banning what is customarily called "hate speech"; its goals include banning criticism of OIC countries and their governments.

The first major attempt to silence writers in the West was the February 14, 1989, decree by Iran's Supreme Leader Grand Ayatollah Khomeini for "all zealous Muslims to execute quickly wherever they find them" the British author Salman Rushdie and all others involved with his book The Satanic Verses. Khomeini wanted to ensure that "no one will dare to insult Islamic sanctity" ever again. As Iran's highest official, he also needed to shore up his political legitimacy following the end of an inconclusive and devastating war with Iraq.

Khomeini's decree triggered the assassination of the novel's Japanese translator, the stabbing of its Italian translator, the shooting of its Norwegian publisher, the burning to death of 35 guests at a Turkish hotel hosting its Turkish publisher, and the lifelong need for security for Rushdie. It heralded a worldwide

movement to curb freedoms of religion and speech by attempting to export and internationalize the blasphemy rules that were already suppressing religious minorities and Muslim dissenters in many Muslim-majority countries. One of the major arenas in this effort has been the United Nations.

Attacks on UN Rapporteurs and NGOs

In 1994, Gaspar Biro, a young Hungarian lawyer and the UN Special Rapporteur on Sudan, concluded that Sudan was violating international human rights agreements due to what Sudan claimed was its sharia-based penal code. Under this code, convictions for adultery, theft, and apostasy meant harsh penalties, including amputation or execution for anyone over the age of seven. Biro reported to the UN Human Rights Commission: It does not matter in this context who the drafter is nor what the sources of inspirations of these norms are. In terms of human rights, the only question is whether or not the national legislation is compatible with the existing international instruments to which Sudan is a party.

Sudan's UN delegation responded by calling Biro's report "flagrant blasphemy and a deliberate insult to the Islamic religion, for which the author of the report must be interrogated and condemned by all States and Organizations that respect human and peoples [sic] rights" and "brought to justice." When asked why Biro was not permitted back into Sudan to collect information for a subsequent report, the Representative replied with a thinly veiled threat: "We don't want to speculate about his fate if he is to continue offending the feelings of Muslims worldwide." The Sudanese official added that the General Assembly, "take the necessary remedial measures to comfort the feelings of Muslims worldwide for the unwarranted challenge to Islam posed by those references, otherwise no one would be in a position to guarantee that he would not face the fate of Mr. Salman Rushdie." In 1998, Biro was replaced as Special Rapporteur to Sudan, while the Sudanese government continued many of its atrocities, now widely recognized as genocide, in the south and commenced new crimes in Darfur.

In 1997, Indonesia's delegate, acting for the OIC, accused the UN Special Rapporteur against Racism of blasphemy for a passage in his report dealing with anti-Semitism. The Rapporteur had included the statement, "Muslim extremists are turning increasingly to their own religious sources, first and foremost the Qur'an, as a primary anti-Jewish source." After Pakistan called it "an insult to Islam" and other states complained, the Commission adopted—without a vote—a resolution, in which it protested the reference to the Qur'an and requested that it be deleted. Subsequent reports on anti-Semitism mentioned only Eastern Europe and the former Soviet Union as specific problem areas. Also under OIC pressure, the Commission suspended its monitoring of Iran in 2002. As in the Sudanese case, Iranian human rights abuses have continued apace.

Meanwhile, following a protracted struggle in the UN with human rights non-governmental organizations (NGOs), OIC states also demanded and obtained a de facto ban on mentioning Islamic institutions in the Commission. Despite the fact that these same governments had sought to promulgate a specifically Islamic declaration of human rights within the UN—in many cases also citing Islam as a source in national laws and constitutions, and even organizing themselves in the OIC as a self-proclaimed Islamic voting bloc—their sudden contradictory contention that Islam is not a proper topic for discussion won over the Commission's leadership.

OIC member states used this implied ban as a means to silence their NGO critics within UN human rights fora. Sudan charged in August 1997 that Christian Solidarity International (CSI)—an NGO that had spoken and worked against slavery in that country—had "offended Islam, … by implying that [Islam] condoned an ideology of genocide, and by alleging that what CSI termed an 'Arab-Islamic State' could order the collective punishment of communities that resisted its programs by consigning them to slavery." This practice of declaring an offense any mention of Islam made by a country or representative other than the OIC members themselves has continued. Pakistan, representing the OIC, used the Human Rights Council to declare in September 2006 that "[t]he recent reference by Pope Benedict XVI to the Prophet Muhammad had hurt the sensibilities of Muslims." Since matters pertaining to Islam were not supposed to be mentioned, discussions of "hurtful" pronouncements by Islamic leaders remained off limits. "I

The UN as Blasphemy Monitor

Beginning in 1999 in the UN Human Rights Commission, OIC members began a coordinated campaign of blanket condemnation of any commentary they could construe as a "defamation" of Islam. Resolutions to this effect have since been adopted regularly. Meanwhile, Western countries moved from unsuccessfully seeking compromise resolutions in 1999 and 2000 to opposing such resolutions altogether. In 2004, the UN General Assembly (GA) itself took up the question of "Islamophobia," while the Human Rights Council, which replaced the discredited Human Rights Commission in 2006, continued its predecessor's practices.

In 2007, the Council adopted a resolution titled "Combating Defamation of Religions," co-sponsored by Pakistan (for the OIC) and Venezuela. Not surprisingly, it mentioned specifically only the situation of Islam and Muslims and noted the 2005 OIC Mecca summit. The resolution drew strong protests from Western NGOs, including the Jubilee Campaign, the Becket Fund, Amnesty International, Human Rights Watch, and Freedom House. However, that year UN Secretary-General Ban Ki-Moon appeared to endorse criminalizing "defamation of religions" by declaring, "A trend is emerging towards amending Criminal Codes to reflect the existence of the different phenomena constituting defamation of religions. The persistence of these phenomena, however, proves that further efforts need to be made." OIC members abstained from a Council resolution on religious freedom, because while it guaranteed the right to convert, it made no mention of protecting religions from "defamation." The Saudi delegation said it could not "accept texts which go against the Islamic sharia." However, the OIC did not succeed in gaining EU or US approval for the concept of "defamation of religions."

By 2008, though resolutions on "defamation of religions" continued to be adopted, albeit with decreasing support, the center of gravity in the UN shifted to "religious hate speech." Europeans saw resolutions against hate speech as putting the emphasis properly on individuals rather than religions. The OIC, however, still viewed them as a convenient pretext to declare allegedly Islamic institutions off-limits for criticism, and, thus, really a proxy for religious defamation. The 2008 resolutions also tried to conflate racial and religious issues. They argued that a ruling by the Committee on the Elimination of Racial Discrimination, permitting bans against "the dissemination of all ideas based upon racial superiority or hatred," should be equally applicable to speech inciting religious hatred. [4]

In March 2008, the Human Rights Council further circumscribed freedom of expression by adopting, with overwhelming support, an amendment introduced by Egypt (for the Group of African States), Pakistan (for the Organization of the Islamic Conference), and the Palestinians (for the Group of Arab States). This amendment changed the mandate of the Special Rapporteur on Freedom of Expression so that it reported on the "abuse" of the right of freedom of expression by a purported act of racial or religious discrimination. The US Ambassador to the UN correctly stated that the revision "attempts to legitimize the criminalization of expression" and aims to place "restrictions on individuals rather than to emphasize the duty and responsibility of governments to guarantee, uphold, promote, and protect human rights." The Canadian delegate likewise argued that the resolution "would turn the [Special Rapporteur's] mandate on its head." 16

In response to the Council's amendment, on December 10, 2008, four Freedom of Expression monitors—from the UN, the Organization for Security and Cooperation in Europe (OSCE), the Organization of American States (OAS), and the African Commission on Human and Peoples' Rights (ACHPR)—adopted an extraordinary joint declaration that emphasized the importance of "open debate about all ideas and social phenomena in society and the right of all to be able to manifest their culture, religion, and beliefs in practice" and lauded the abolition in many countries of laws "used to prevent legitimate criticism of powerful religious leaders and to suppress the views of religious minorities, dissenting believers and non-believers...." They argued that, although prohibitions on "incitement to hatred, discrimination, or violence" were acceptable, "open dialogue that exposes the harm prejudice causes" should be the primary means of combating bigotry. Their declaration pointed out that the "defamation of religions" framework was unacceptable because it "does not accord with international standards regarding defamation, which refer to the protection of reputation of individuals." [17]

International Treaties: Exceptions Become the Rule

International human rights treaties, the foundation for global human rights for nearly half a century, are turning out to be weak bulwarks against the OIC's push for restrictions on negative commentary on Islam. The International Covenant on Civil and Political Rights (ICCPR, effective 1976) is the main treaty protecting individual rights to freedom of religion and of expression. Its guarantees of free expression also contain vaguely worded limits to those rights. These limits are now being interpreted expansively, including by many Western countries, to erode the Covenant's core freedoms of both religion and expression.

For example, Article 18 establishes one's "freedom to have or to adopt a religion or belief of his choice, and freedom, either individually or in community with others and in public or private, to manifest his religion or belief in worship, observance, practice and teaching." Furthermore, Article 19 protects freedom of expression, including "freedom to seek, receive and impart information and ideas of all kinds, regardless of frontiers, either orally, in writing or in print, in the form of art, or through any other media of his choice." But, in addition, the ICCPR also sets forth "necessary" restrictions on these freedoms, in order to protect "the rights or reputations of others," "national security," or public order, health, or morals (Paragraph 3). Also, Article 20 (included by the then-Soviet Bloc states over strong Western opposition) explicitly obliges states to prohibit "[a]ny advocacy of national, racial or religious hatred that constitutes incitement to discrimination, hostility or violence." This provision is the one now used in Western countries to apply religious hate speech laws and limit the rights found in articles 18 and 19.18

The OIC's strategy is to stretch these limits on rights into a supposed new right for Islam not to be insulted. The UN's "defamation of religions" resolutions seek to legitimize this idea by suggesting that speech criticizing religious beliefs is a human rights violation rather than the exercise of a protected human right. This "defamation" push attempts to redefine human rights in five ways, by:

- 1. treating religious matters as if they were akin to racial matters;
- 2. granting rights to religions themselves rather than to individuals;
- 3. creating a new right not to be offended in matters of religion;
- 4. claiming that freedom of religion stands in opposition to freedom of expression; and
- 5. giving an expansive interpretation to the exceptions to the right of freedom of expression.

An additional problem is that there is no clarity about what specific forms of expression the OIC countries seek to limit within Western countries. There are no clear definitions of religious defamation or religious hate speech. Similarly, no common practice regarding blasphemy crimes exists within the OIC membership. Many OIC expectations are based upon amorphous rules expressed in practices that vary from country to country and evolve and expand over time. Within countries that have such restrictions, definitions are generally left to case law, commonly unwritten, and often determined by the subjective and sometimes self-serving opinions of local authorities. The nature of what is being asked of non-Muslimmajority societies, or of Muslim-majority societies for that matter, is obscure. Also, within most Western countries, discrimination and incitement to violence against Muslims, as well as other people, are already understood to be crimes. The bans on speech against Islam that the OIC is pursuing must include far broader restrictions.

Conclusions

The freedom to debate, reject, criticize, and/or refuse to respect religious ideas, and the freedom to worship according to one's conscience, are essential elements of religious freedom. In contrast, prohibitions on "defamation of religions" reflect the view that, in the realm of belief, government should serve as the arbiter and regulator of ideological orthodoxy rather than as the defender of individual freedom. This is the same principal operative behind many OIC states' own domestic laws against blasphemy and apostasy. Many OIC countries have limits on speech regarding Islam that control not only ridicule and mocking language, but also what can be expressed, analyzed, and argued in the political, cultural, social, economic, and religious realms; in fact, these limits are major means of social and political control. They coerce religious conformity and forcibly silence criticism of dominant religious ideas, especially when those dominant ideas support, and are supported by, political power.

Even when the state is not repressing critics directly, such laws create an atmosphere in which purported blasphemers are subject to vigilante attacks or mob violence instigated by radical preachers. Perhaps the most striking recent examples are the murders of the courageous Salman Taseer, Governor of Punjab Province in Pakistan, and of Shahbaz Bhatti, Pakistan's Minister of Minority Affairs. Taseer was killed on January 4, 2011, by one of his guards, who deemed him a blasphemer solely because he wanted the abolition of Pakistan's blasphemy laws. Bhatti, the only Christian in Pakistan's cabinet, was killed on March 2, 2011, also for opposing the blasphemy laws.

Where religion and power are intertwined, states invariably draw on laws restricting speech critical of religion for other than purely religious purposes. Many OIC members silence their domestic opponents and critics through a wide variety of repressive measures, but one prominent tactic, especially predominant in Iran, is to accuse such critics of "insulting Islam" or the "Islamic regime." These accusations enable both the crushing of political dissent and the silencing of Muslims who question the official and dominant versions of Islam—including those who advocate versions of Islam that promote human freedom.

As the late Abdurrahman Wahid, former President of Indonesia, the world's largest Muslim country, and head of Nahdlatul Ulama, the world's largest Muslim organization, has written:

Rather than legally stifle criticism and debate—which will only encourage Muslim fundamentalists in their efforts to impose a spiritually void, harsh and monolithic understanding of Islam upon all the world—Western authorities should instead firmly defend freedom of expression, not only in their own nations, but globally, as enshrined in Article 19 of the Universal Declaration of Human Rights." 19

Those who are humble and strive to live in genuine submission to God (i.e., islâm) do not claim to be perfect in their understanding of the Truth. Rather, they are content to live in peace with others, whose paths and views may differ."²⁰

The United Nations first International Day to Combat Islamophobia serves as a chance to bring anti-Muslim hatred to a halt, the organisation's Secretary-General António Guterres said on Monday. "The first International Day to Combat Islamophobia is a call for action to stamp out the poison of anti-Muslim hatred. Discrimination diminishes us all. We must stand up against it," Guterres said in a Tweet. "Today and every day, we must counter the forces of division by reaffirming our common humanity," the UN chief added. Tuesday marks the first time the UN observes the international day following the unanimous adoption of a General Assembly resolution last year. Guterres has previously noted that nearly two billion Muslims globally "often face bigotry and prejudice simply because of their faith."

"It [Islamophobia] is an inexorable part of the resurgence of ethno-nationalism, neo-Nazi white supremacist ideologies, and violence targeting vulnerable populations including Muslims, Jews, some minority Christian communities and others," Guetteres said last week. During a high-level event co-convened by Pakistan, its Foreign Minister Bilawal Bhutto Zardari highlighted the increased hatred towards Muslims in the wake of the September 11 attacks in the United States. "Since the tragedy of 9/11, animosity and institutional suspicion of Muslims and Islam across the world have only escalated to epidemic proportions. A narrative has been developed and peddled which associates Muslim communities and their religion with violence and danger," Zardari said.

Quran burning incidents reveal Europe's 'deep-rooted' Islamophobia: analysts. The Pakistani official added that the anti-Islam narrative is widely spread and "has found acceptance by sections of mainstream media, academia, policymakers and state machinery." Following the deadly 9/11 attacks, the West has waged a so-called "War on Terror" that has been widely seen as a guise under which Islamophobia is rolled out globally, where many, particularly in the west, associated Islam with the "terrorism".

Islamophobia in Europe

Muslims in certain parts of Europe and North America face widespread Islamophobia and a rise in hate speech towards Islam that has only increased over the years. The alarming rise of Islamophobia in Europe continues to raise concerns globally, particularly among the Muslim community. Since the start of the year, several European countries have witnessed attacks on those who follow the religion with a series of incidents involving the burning of the Quran, the holy Muslim scripture.

(This is all the Muslims say some of our books have been burned and the UN say we must protect Islam, they do not say Muslims are being killed because they are not. Yet Muslims are persecuting 200 million Christians across 60 nations killing tens of thousands of Christians every year unreported. It's well-known Islamic terrorist attacks have increased massively in the last few years around the world in many non-Islamic nations)

The incidents, all of which were carried out by far-right figures, were seen in Denmark, the Netherlands and Sweden. Last year, the Collective for Countering Islamophobia in Europe (CCIE) reported a "remarkable rise of Islamophobia and the policies that it inspires", as quoted by Anadolu Agency.

(This Quran burning is potentially due to protests against Muslim immigrant raping gangs causing terrible violence and harm to non-believing locals in these European communities and countries this is also unreported. Everything is biased in favour of Muslims and against everyone else in these reports. Several European countries have also had enough they are now removing Muslim immigrants sending them back to their own countries to practice Islam there.)

CCIE, a Belgium-based anti-Islamophobia group, attributed the spike in incidents to the rise of nationalism with governments downplaying its risks. Quantifying the incidents, CCIE said that it received 787 incidents of Islamophobia throughout 2022, including 527 Islamophobic acts. Other incidents out of the total figure included 467 acts of discrimination, 128 of provocation, 71 of insults, 27 of physical violence along with other harrowing cases.

(The cases reported of Muslim persecution are minor nothing in their 2 billion population. Yet Muslims are killing tens of thousands of Christians ethnic cleansing began in Syria by Muslims against Christians at Assads fall in Dec 2024. Isis destroyed 2.3 million Christians from Iraq and Syria in under 4 years from 2013 – 2017, they destroyed thousands of churches and burned thousands of bibles. Once again, the scales are deeply unbalanced by the powers to be whom hate Christianity this is a spiritual war. Now we have the UN anti – islamophobia legislation anti hate speech mark of the beast law)

The United Kingdom and France were described by the report as "the main spots of anti-Muslim hatred and Islamophobic incidents." The European Islamophobia Report 2021 warned of the rise of anti-Muslim hate in the region, detailing policies adopted by some countries that have fuelled the animosity. In France there were 213 anti-Muslim incidents recorded in 2021, half of which were carried out in the form of harming places of worship and cemeteries. A total of 22% of the incidents involved attacks on Muslims. Meanwhile in the UK, there was a 9% year-on-year increase in cases, with 45% of those reported involving "religiously aggravated" hate crimes. In Sweden, there was a disturbing figure of 996 cases between 2017 and 2021.

(Europe has been invaded by millions of Muslim immigrants from other countries with their own cultural and Islamic beliefs foreign to Europeans. Now they are pushing their own agenda from the Middle East upon European nations no wonder there is some push back even though it's very minor. Yet the power to be favour Islam over emphasising the destruction of Muslims, they are using Islam to strip away the freedoms of the common man).

"However, most complaints of religious discrimination were directly related to ethnic discrimination numbering 4,298 during this period," the report noted. Qatar was also subjected to Islamophobic rhetoric since it made history in 2010 when it won the bid to host the FIFA World Cup as the first Muslim and Arab country to do so. Western media commentary and a campaign heavily criticising Qatar spread in the lead up to the event and as it took place. This was also seen following the victories of Morocco's team, the first African and Muslim country to reach the semi-finals in the World Cup's history. Incidents involved comparing the Atlas Lions to monkeys during their heartfelt moments of celebration with their mothers along with other hateful remarks.


