The Knights Templar Origins (1118 A.D)



The **Knights Templar** began in 1118 A.D when 9 French Knights came to Jerusalem, King Baldwin 11 granted their request (1118 A.D) to be an order of Knights to protect pilgrims from robbers and murderers this was all historically recorded. Pope Eugenius decreed that the Knights Templar and only the Knights Templar would wear a special red cross with blunt wedge-shaped arms called the cross patee on the left breasts of their white robes, so that they could be quickly recognized at any time by Christians and by other Templars on the field of battle. The white robes with red crosses became their required dress. The warrior-knights fought bravely in the Middle East, and were highly respected by their Moslem counterparts for their strategy and bravery.




The Pope with the Order of the Knight of Malta

Knightly symbolism in Freemasonry

The earliest documented link between Freemasonry and the Crusades is the 1737 oration of the Chevalier Ramsay. This claimed that European Freemasonry came about from an interaction between crusader masons and the Knights Hospitaller. This is repeated in the earliest known "Moderns" ritual, the Berne manuscript, written in French between 1740 and 1744. In 1751 Baron Karl Gotthelf von Hund und Altengrotkau began the Order of Strict Observance, which ritual he claimed to have received from the reconstituted Templar Order in 1743 in Paris. He also claimed to have met two of the "unknown superiors" who directed all of masonry, one of whom was Prince Charles Edward Stuart. The order went

into decline when he failed to produce any evidence to support his claims, and was wound up shortly after his death.

In 1779 the High Knights Templar of Ireland Lodge, Kilwinning, obtained a charter from Lodge Mother Kilwinning in Scotland. This lodge now began to grant dispensations to other lodges to confer the Knights Templar Degree. Sometime around 1790 the Early Grand Encampment of Ireland was formed, which began to warrant Templar Lodges, and evolved into the Supreme Grand Encampment in 1836. The Early Grand Encampment chartered several Scottish "encampments" one of which, having been chartered in 1805 as the "Edinburgh Encampment No. 31", then became the "Grand Assembly of Knights Templar in Edinburgh". who then sought a charter from the Duke of Kent, Grand Master of the Order in England. It seems that the Templar degree had filtered into the lodges of the Antients from Ireland about 1780, and was recorded at York about the same time. In the five degree system developed by the York Masons, the Knights Templar degree sat between the Master Mason and the Sublime Degree of Royal Arch.



Jesuit Origins (1540)





First established in 1540 the Jesuits are a religious military order of the Roman Catholic Church that serve the Pope and the Vatican. Jesuits swear oaths in their order to protect the Pope at all costs they are sworn enemies of true Christian's protestant reformers and swear to destroy them. It was the Jesuits in the mid 1550's after the Martin Luther reformation that were ordered by the Vatican to come up with false teachings to decieve the protestant movement. Historically, preterists and non-preterists have generally agreed that the Jesuit <u>Luis de Alcasar</u> (1554–1613) wrote the first systematic preterist exposition of prophecy—Vestigatio arcani sensus in Apocalypsi (published in 1614)—during the Counter-Reformation.

Two Catholic Jesuit writers, Manuel Lacunza (1731-1801) and Francisco Ribera (1537-1591), proposed the futurist view (during the counter-reformation). Lacunza wrote under the pen name "Ben-Ezra", and his work was banned by the Catholic Church. It has grown in popularity in the 19th and 20th centuries, so that today it is probably the most readily recognized. The futurist view assigns all or most of the prophecy to the future, shortly before the Second Coming; especially when interpreted in conjunction with Daniel, Isaiah 2:11-22, 1 Thessalonians 4:15–5:11, and other eschatological sections of the Bible.

This "gap" theory promoted at the turn of the 19th century as an end time's doctrine and other theories associated with it (*futurism*, *dispensationalism*, *rapture theory*) are taught in the mainstream Bride of Christ worldwide. that was nailed to the church door at the "All Saints Church" in Wittenberg. After several years of study and inner searching Luther came to reject Catholic false teachings and practices especially indulgences for sin and lost loved ones. After his ordination as a priest in 1507 Martin Luther went on to more studies earning a Bachelor degree in biblical studies then his Doctor of Theology he eventually became Vicar of Saxony in 1515. It was Luther's encounter with Johann Tetzel in 1516 the papal commissioner for indulgences that sparked Luther to began to teach that salvation didn't come through good works or indulgences (paying the Vatican for a get out of jail/hell free card) but only through God as a gift through grace by a believing in Christ through faith.

Luther taught that the Bible was the only source of divinely revealed knowledge the word of God not the Papacy. So by 1517 Luther's protests against indulgences and other Catholic papacy teaching began his 95 thesis the rest is history as one could say. This launched the Council of Trent to come against the reformation of the church against free thinking, the waking up of those hoodwinked by Catholic doctrines and practices, to come against a return to the truth and origins of the scriptures.

The Council of Trent (Latin: Concilium Tridentinum), held between 1545 and 1563 A.D in Trent (or Trento, in northern Italy), was the 19th ecumenical council of the Catholic Church. Prompted by the Protestant Reformation, it has been described as the embodiment of the Counter-Reformation. The Council issued condemnations of what it defined to be heresies committed by proponents of Protestantism, and also issued key statements and clarifications of the Church's doctrine and teachings, including scripture, the Biblical canon, sacred tradition, original sin, justification, salvation, the sacraments, the Mass, and the veneration of saints. The Council met for twenty-five sessions between 13 December 1545 and 4 December 1563 A.D.

In 1545, the Catholic Church convened one of its most famous councils in history. It took place north of Rome in a city called Trent. The Council of Trent continued for three sessions ending in 1563. One of its main purposes was to plan a counterattack against Martin Luther and the Protestants. Thus, the Council of Trent became a center for Rome's Counter Reformation. Up to this point, Rome's main method of attack had been largely frontal: openly burning Bibles and heretics. Yet this warfare only confirmed in the minds of Protestants the conviction that papal Rome was indeed the Beast power that would "make war with the saints" (Revelation 13:7). Therefore a new tactic was needed, something less obvious. The sought after solution was found in the Jesuit Order.

Eleven years earlier, on August 15, 1534, Ignatius Loyola founded a secret Catholic order called the Society of Jesus, also known as the Jesuits. At the Council of Trent, the Catholic Church gave the Jesuits the specific assignment of bringing Protestantism back to the "Mother Church." This was to be done not only through the Inquisition and through torture, but also through theology and deception. The Jesuits have had a dark history of intrigue and sedition. That is why they were expelled from Portugal (1759), France (1764), Spain (1767), Naples (1767), and Russia (1820). Jesuit priests have been known throughout history as the most wicked political arm of the Roman Catholic Church.

The Society of Jesus was founded in 1540 by St. Ignatius Loyola and since then has grown from the original seven to 24, 400 members today who work out of 1,825 houses in 112 countries. In the intervening 455 years many Jesuits became renowned for their sanctity (41 Saints and 285 Blesseds), for their scholarship in every conceivable field, for their explorations and discoveries, but especially for their schools. The Society is governed by General Congregations, the supreme legislative authority which meets occasionally. The present Superior General Fr. Peter-Hans Kolvenbach, S.J. is Dutch. Ignatius Loyola was a Spanish Basque soldier who underwent an extraordinary conversion while recuperating from a leg broken by a cannon ball in battle.

He wrote down his experiences which he called his Spiritual Exercises and later he founded the Society of Jesus with the approval of Pope Paul III in 1540. Jesuits were called the schoolmasters of Europe during the 16th, 17th and 18th centuries, not only because of their schools but also for their pre-eminence as scholars scientists and the thousands of textbooks they

composed. During their first two centuries the Jesuits were involved in an explosion of intellectual activity, and were engaged in over 740 schools.

Freemasonry was established approximately 480 years after the Knights Templar was formed in 1118 A.D in Jerusalem. Historical figures such as Mozart, Winston Churchill, King Henry 8th and Napoleon Bonaparte, were freemasons. Many high ranking Freemasons have been saved in Christ revealing testimony of the secret rituals and ceremonies of freemasons that are demonic in nature.

In Christian realms once saved generational freemasonry curses become very real with a need of breaking those curses with deliverance in one's life. Early Masonic sources

The earliest Masonic texts each contain some sort of a history of the craft, or mystery, of masonry. The oldest known work of this type, The Halliwell Manuscript, or Regius Poem, dates from between 1390 and 1425. This document has a brief history in its introduction, stating that the "craft of masonry" began with Euclid in Egypt, and came to England in the reign of King Athelstan (born about 894, died 27 October 939). Shortly afterwards, the Cooke Manuscript traces masonry to Jabal son of Lamech (Genesis 4: 20–

22), and tells how this knowledge came to Euclid, from him to the Children of Israel (while they were in Egypt), and so on through an elaborate path to Athelstan. This myth formed the basis for subsequent manuscript constitutions, all tracing masonry back to biblical times, and fixing its institutional establishment in England during the reign of Athelstan (927–939).

Shortly after the formation of the Premier Grand Lodge of England, James Anderson was commissioned to digest these "Gothic Constitutions" in a palatable, modern form. The resulting constitutions are prefaced by a history more extensive than any before, again tracing the history of what was now freemasonry back to biblical roots, again forging Euclid into the chain. True to his material, Anderson fixes the first grand assembly of English Masons at York, under Athelstan's son, Edwin, who is otherwise unknown to history. Expanded, revised, and republished, Anderson's 1738 constitutions listed the Grand Masters since Augustine of Canterbury, listed as Austin the Monk. William Preston's Illustrations of Freemasonry enlarged and expanded on this masonic creation myth.

In France, the 1737 lecture of Chevalier Ramsay added the crusaders to the lineage. He maintained that Crusader Masons had revived the craft with secrets recovered in the Holy Land, under the patronage of the Knights Hospitaller. At this point, the "history" of the craft in Continental Freemasonry diverged from that in England.

HERMETIC ORDER OF FREEMASONRY



There are approximately 5 million members worldwide, mostly in the United States and other English-speaking countries. With adherents in almost every nation where Freemasonry is not officially banned, it forms the largest secret society in the world. There is no central Masonic authority; jurisdiction is divided among autonomous national authorities, called grand lodges, and many concordant organizations of higher-degree Masons. In the United States and Canada the highest authority rests with state and provincial grand lodges. Custom is the supreme authority of the order, and there are elaborate symbolic rites and ceremonies, most of which utilize the instruments of the stonemason the plumb, the square, the level, and compasses and apocryphal events concerning the building of King Solomon's Temple for allegorical purposes.

The principles of Freemasonry have traditionally been liberal and democratic. Anderson's Constitutions (1723), the bylaws of the Grand Lodge of England, which is Freemasonry's oldest extant lodge, cites

religious toleration, loyalty to local government, and political compromise as basic to the Masonic ideal. Masons are expected to believe in a Supreme Being, use a holy book appropriate to the religion of the lodge's members, and maintain a vow of secrecy concerning the order's ceremonies.

The basic unit of Freemasonry is the local Blue lodge, generally housed in a Masonic temple. The lodge consists of three Craft, Symbolic, or Blue Degrees: Entered Apprentice (First Degree), Fellow Craft (Second Degree), and Master Mason (Third Degree). These gradations are meant to correspond to the three levels apprentice, journeyman, and master of the medieval stonemasons' guilds. The average Mason does not rise above Master Mason. If he does, however, he has the choice of advancing through about 100 different rites, encompassing some 1,000 higher degrees, throughout the world. In the United States, the two most popular rites are the Scottish and the York. The Scottish Rite awards 30 higher degrees, from Secret Master (Fourth Degree) to Sovereign Grand Inspector General (Thirty-third Degree). The York Rite awards ten degrees, from Mark Master to Order of Knights Templar, the latter being similar to a Thirty-third Degree Scottish Rite Mason.

Other important Masonic groups are the Prince Hall Grand Lodge, to which many African-American Masons belong; the Veiled Prophets of the Enchanted Realm (the "fraternal fun order for Blue Lodge Masons"); and the Ancient Arabic Order of the Nobles of the Mystic Shrine (Thirty-second degree Masons who, as the Shriners, are noted for their colorful parades and support of children's hospitals). There are also many subsidiary Masonic groups, including the Order of the Eastern Star, limited to Master Masons and their female relatives; De Molay, an organization for boys; and Job's Daughters and Rainbow, two organizations for girls. Many of the orders maintain homes for aged members.

The order is thought to have arisen from the English and Scottish fraternities of practicing stonemasons and cathedral builders in the early Middle Ages; traces of the society have been found as early as the 14th century. Because, however, some documents of the order trace the sciences of masonry and geometry from Egypt, Babylon, and Palestine to England and France, some historians of Masonry claim that the order has roots in antiquity.

The formation of the English Grand Lodge in London (1717) was the beginning of the widespread dissemination of speculative Freemasonry, the present-day fraternal order, whose membership is not limited to working stonemasons. The six lodges in England in 1700 grew to about 30 by 1723. There was a parallel development in Scotland and Ireland, although some lodges remained unaffiliated and open only to practicing masons. By the end of the 18th century, there were Masonic lodges in all European countries and in many other parts of the world as well.

The first lodge in the United States was founded in Philadelphia (1730); Benjamin Franklin was a member. Many of the leaders of the American Revolution, including John Hancock and Paul Revere, were members of St. Andrew's Lodge in Boston. George Washington became a Mason in 1752. At the time of the Revolution most of the American lodges broke away from their English and Scottish antecedents. Freemasonry has continued to be important in politics; 13 Presidents have been Masons, and at any given time quite a large number of the members of Congress have belonged to Masonic lodges. Notable European Masons included Voltaire, Giuseppe Mazzini, Giuseppe Garibaldi, Franz Joseph Haydn, Johann von Goethe, Johann von Schiller, and many leaders of Russia's Decembrist revolt (1825).

Because of its identification with 19th-century bourgeois liberalism, there has been much opposition to Freemasonry. The most violent in the United States was that of the Anti-Masonic party. Freemasonry's anticlerical attitude has also led to strong opposition from the Roman Catholic Church, which first

expressed its anti-Masonic attitude in a bull of Pope Clement XII (1738). The Catholic Church still discourages its members from joining the order. Totalitarian states have always suppressed Freemasonry; the lodges in Italy, Austria, and Germany were forcibly eradicated under fascism and Nazism, and there are now no lodges in China.


SERPENT WORSHIP IN FREEMASONRY

Another Masonic author, George Oliver, also noted Freemasonry's connection with the Druids. "The Druids had a high veneration for the Serpent. Their great god, Hu, was typified by that reptile; and he is represented by the Bards as 'the wonderful chief Dragon, the sovereign of heaven'." [George Oliver, Signs and Symbols, New York, Macoy Publishing and Masonic Supply Company, 1906, p. 36; Emphasis and capitalization in the original] At least, this Satanic view of the serpent and the dragon being identical beings is consistent with the Bible, as the Scripture says they both are symbols of Satan [Revelation 12:9]

When Masonic authors Pike, Hutchinson, Churchward, and Oliver identify Masonry as coming from the Druid religion, this admission is extremely damning. "Masons.. admire the Druids and some of them even claim that Masonry came from Druidism. Of course, the Druids were occultic priests, practiced astrology, and offered human sacrifices." [Dr. C. Burns, Masonic and Occult Symbols Illustrated, p. 28] Wonderful. This statement means that Freemasonry practices both White Magic and Black Magick witchcraft. - 4) "The portals of the Egyptian Temples are decorated with the hierogram of the Circle and the Serpent"
- 5) The serpent "is found upon the Temple of Naki-Rustan in Persia, on the triumphal arch at Pechin, in China, over the gates of the great Temple of Chaundi Teeva, in Java; upon the walls of Athens ... The Mexican hierogram was formed by the intersecting of two great Serpents, which described the circle with their bodies, and each a human head in its mouth." [NOTE: Pike capitalized Serpent, above, to denote Deity] While we may think it abhorrent for a snake to be swallowing a human, we discover that the Satanist had a different point of view. A Satanic book of symbols, entitled, Magic Symbols, says that a snake swallowing a human being symbolizes "the process of initiation. 

Located at number 19 Hill Street, Mary's Chapel isn't a place of worship. It's a Masonic lodge. And, with its records dating back to 1599, it's the oldest proven Masonic lodge still in existence anywhere in the world.

That might come as a surprise to some people. Ask most enthusiasts when modern Freemasonry began, and they'd point to a much later date: 1717, the year of the foundation of what would become known as the Grand Lodge of England. But in many ways, Freemasonry as we know it today is as Scottish as haggis or Harris tweed.

From the Middle Ages, associations of stonemasons existed in both England and Scotland. It was in Scotland, though, that the first evidence appears of associations – or lodges – being regularly used. By the late 1500s, there were at least 13 established lodges across Scotland, from Edinburgh to Perth. But it wasn't until the turn of the 16th Century that those medieval guilds gained an institutional structure – the point which many consider to be the birth of modern Freemasonry.

Take, for example, the earliest meeting records, usually considered to be the best evidence of a lodge having any real organization. The oldest minutes in the world, which date to January 1599, is from Lodge Aitchison's Haven in East Lothian, Scotland, which closed in 1852. Just six months later, in July 1599, the lodge of Mary's Chapel in Edinburgh started to keep minutes, too. As far as we can tell, there are no administrative records from England dating from this time.

The dream of an independent Scotland had been achieved the Templers had brought themselves back for the point of destruction never again would they allow themselves to be destroyed.

This time the Templers would control the country be controlling its Kings. In order to protect their secret order the name the Knights Templers would have to die more precisely the name would have to die. The Templers who had escaped Europe were finally laid to rest in Rosslyn Chapel Scotland which stands to this day as a sign of their presence in Britain. The Templers descendants became the true power of Scotland. In 10603 the death of Queen Elizabeth the 1st left England without an heir to the throne. 






The Owl of Minerva perched on a book was an emblem used by the Bavarian Illuminati in their "Minerval" degree.

was created in 1791, a few years after Freemasonry assumed the leadership of the New World Order, in 1782.

In Europe, occult leaders were told by their Familiar Spirits as early as the 1740's that the new American continent was to be established as the new "Atlantis", and its destiny was to assume the global leadership of the drive to the New World Order. 

With all that as background, let us now begin our study of Governmental Center, Washington, D.C.

The Satanic Symbol & the Layout of Washington D.C.

In the street layout of Washington D.C., the fifth point is the White House, a symbol placement which represents the intention that the spirit and the mind of Lucifer will be permanently residing in the White House. The map I found isn't all that accurate as far as the streets are concerned, but it will have to do.

In the map above, beginning from top left to top middle:


- 1. Dupont Circle, Logan Circle, and Scott Circle in the middle, form the top three points of the Devil's Goathead of Mendes, one of the most important types of the Five-pointed Devil's Pentagram.
- 2. Washington Circle forms the extreme left-hand point of the Goathead.
- 3. Mt. Vernon Square forms the extreme right-hand point of the Goathead.
- 4. The White House forms the fifth and bottom point of the Goathead.

There is a 666 evident in the most important top three circles of the Goathead, Dupont Circle, Scott Circle, and Logan Circle. Each of these streets has six major streets coming into them from all angles of the circle. This type of encoding is so typical of the occultist.

Everything was deliberately planned to stamp the power of Freemasonry and the symbols of its plans for America indelibly upon Government Center in Washington D.C.

The combination of the the Goathead of Mendes, Devil's Pentagram, and the practical existence of the number 666 within the three upper points of the Pentagram, unmistakably shows that Lucifer is planned to be the ultimate master of Governmental Center.


Now look for a moment at the circles which comprise the points of the Pentagram. Washington Circle, Dupont Circle, Scott Circle, and Logan Circle comprise four of the six points of the Pentagram. The only point which is not a circle or a form of a circle is Mt. Vernon Square. We shall return to the discussion of the importance of the square to the occultist, but let us now concentrate upon the circle.

It is no secret as to why the Masonic architect chose to use circles as four of the points of the Pentagram. As Goodman states in his book, Magic Symbols, "without doubt, the circle is the most important of all units in magic symbolism, and in almost every case where it is used, the circle is intended to denote spirit, or spiritual forces". Therefore, we can know with certainty that these circles of this Pentagram were used to denote powerful spiritual forces. And, of course, these spiritual forces are from Lucifer.

But, there is much more symbolism expressed by the circle in occultic thought. The circle has also been used as a halo above a person's head, denoting that "he or she is in direct communication with the spiritual world".

The circle has also been utilized to represent the Sun, especially in spiritual terms, denoting spiritual light. But, the circle also is utilized as a symbol of the All-Seeing Eye. Remember the All-Seeing Eye atop the pyramid on our One-Dollar bill? This eye is within a triangle, but the important factor to realize is that the eye is atop a pyramid. Of course, a pyramid is nothing more than a triangle. Look again at the triangles formed by the Goathead Pentagram.

Four out of five triangles of the Goathead has a circle, representing the All-Seeing Eye atop each triangle. However, the architect had a problem with the triangle at the far right, because he chose the square as the anchor point; the solution is to place Thomas Circle at one of the points, thus giving that triangle an All-Seeing Eye. In fact, I believe this is the reason why Thomas Circle was placed in the odd position it was; it is the only circle which was not placed as an anchor of the Pentagram. Even the Southern Point of the Goathead Pentagram, the one which ends at the White House, has a circle at its top. Notice the Ellipse located just to the south of the White House lawn.(below)

Thus, the FreeMason architect who drew this pattern intended to show that Governmental Center was planned to be ruled by Satan. Further, the Goathead Pentagram was placed so the Southernmost point, the spiritual point, is precisely centered on the White House.

Notice that I did not arbitrarily draw these lines to center on the White House; rather, the White House is the precise point where the two lines formed by Connecticut Avenue flowing from Dupont Circle, and by Vermont Avenue flowing from Logan Circle, intersect. The meaning is all too clear. Occultists planned for the White House to be controlled by Lucifer in accordance with his occultic power and doctrine.

But, there is still more meaning expressed by this Goathead Pentagram. Quickly look again at the photocopy of the Devil's Pentagram, as copied from Goodman's Magic Symbol book. Protruding from the middle top of the Pentagram is a lighted candle, which is producing light. This physical light represents spiritual illumination. If this representation were made on a map, this illuminating candle would be thought of as being North. North is a very important direction, because it is the place of Governmental control. In I Ching, for example, North is the "place one reports to the master on accomplishments". (New Age Dictionary). This is again a fulfillment of Scripture.

Remember in Isaiah 14:12-14, where God recalls Lucifer's original sin of pride and rebellion? Lucifer had every intention of taking God's throne by force and establishing his own reign. In verses 13 and 14, Lucifer vowed, "I will ascend to Heaven; I will exalt my throne above the stars of God; I will sit upon the mount of assembly in the uttermost north..." Did you see that North is apparently the direction in which God's throne is situated, and Lucifer planned to take it over. North is the place, occultists believe, where Governmental authority dwells.


Now look at the Goathead Pentagram again. Scott Circle is precisely located at the middle of the Goathead, and 16th Street proceeds directly north. As you look directly north on 16th Street, you will immediately see the House Of The Temple, which is the North American Headquarters of Freemasonry.

Even the number 16 is significant to the occultist; it is 4x4 (Remember that the four upper points of the Goathead Pentagram represent the Four Elements of which the earth is constructed). Number 16 literally means "felicity", which, according to my Webster's Dictionary, means blissful happiness or anything which will produce such a state. Certainly, blissful happiness is the stated goal of any Satanic system. A corollary meaning of 16 is love. The number 16 also pops up in an encoded manner. Both Dupont Circle and Logan Circle, which form the top two most important points of the Goathead Pentagram, are located on "P" Street. "P" is the 16th letter of the English alphabet.

Sixteenth Street emanates north from Scott Circle, which is itself the precise middle of the Goathead Pentagram. This street represents the candle of the photocopy. The illuminating light of the candle is represented by the House Of The Temple, which begins on "R" Street. The architect is literally saying that Freemasonry is the spiritual light of this Goathead Pentagram; of course, this Goathead Pentagram is rooted at the White House. One quick word on "R" Street. The letter "R" is the 18th letter of the English alphabet, and 18 is critically important to the occultist because it is 6+6+6.

The House Of The Temple is also located 13 city blocks north of the White House. Count them yourself, beginning with the first city block north of Lafayette Square. Of course, the number 13 represents rebellion against God's authority, and is generally thought of as Satan's number. It is no accident the House Of The Temple is located 13 blocks north of the White House. The meaning occulticly transmitted is that the control of the White House would be spiritual and would emanate from the House Of The Temple. Certainly, many American Presidents have been Freemasons. The most famous is George Washington, but the most influential was Franklin D. Roosevelt, who did more to advance the cause of the New World Order than anyone else in American history.



The critical importance of this symbolism pointed out above, namely, that the Presidency of the United States is to be controlled by Freemasonry, is thoroughly documented by Christian author, Ralph

Epperson, in his book, "The New World Order". On page 171, Epperson quotes testimony given in March, 1867, before the House Judiciary Committee, by General Gordon Granger. General Granger related a meeting between himself, President Andrew Johnson, who was a Mason, and Albert Pike, the most famous of all Masons. General Granger reported his surprise that President Johnson considered himself to be subordinate to Albert Pike.

This subordination is detailed in the oath the initiate takes during the Third Degree, called the Master Mason's degree, inside the Blue Lodge. This oath states, "I do promise...that I will obey all...summonses..given..to me from the hand of a Brother Master Mason ..." Presidents who are Masons are obligated to take orders from their Master Masons. But why should we be surprised? This is the meaning of the symbolization contained by the House Of The Temple being precisely 13 city blocks north of the White House.

Now, let us quickly examine the importance of the square to the occultist. We need to understand this because the Eastern point of this Goathead Pentagram is a square, not a circle. The square is comprised of two (2) vertical lines and two (2) horizontal. According to Goodman in his book, "Magical Symbols," the vertical line symbolizes spirit. This spiritual force may move either from Heaven to Earth or from Earth to Heaven, or even from Heaven to Hell. The horizontal line symbolizes matter and movement from west to east. It also describes movement in time, as a direction in which one is traveling. This point is very critical, because the Freemason is committed to taking America in the direction of the New World Order. Since the square combines the vertical and the horizontal, it becomes a symbol of the material, physical realm which is enmeshed with spirit and time. The passage of time within an occultic spiritual context is what is in view here. In this instance, the United States of America is the physical realm which is moving in time toward the desired direction of the New World Order.



Mason Headquarters (Mt. Vernon Square)

This square also contains one more piece of occultic meaning. In this Goathead Pentagram, Mt. Vernon Square is the Eastern point. In occultic doctrine, East is the direction from which a person receives spiritual knowledge and guidance. This belief originated in the Pagan worship of the Sun, and it is very much alive in Freemasonry today.

Now, let us look at the symbol contained in the lower right hand portion of your Washington, D.C., city street map. This combination of symbols runs South and East from the White House to the United States Capitol. These are the symbols which clearly stamp Freemasonry upon this city, and which



unmistakably reveal that the brand of Luciferic worship which we see in the Goathead Pentagram is the brand practiced by Freemasonry. Let us look at these Freemasonry symbols. The three most sacred symbols of Freemasonry are the Compass, the Square, and the Rule or straight-edge. Look at the United States capitol, and you will see that it is laid out in the form of a circle. This represents the top of a professional compass of that era, which was circular. Pennsylvania Avenue, running from the Capitol to the White House, represents one leg of the compass. Maryland Avenue, running from

the Capitol to Thomas Jefferson Memorial(left), represents the second leg of the compass. In this instance, you will have to lay out a ruler and draw a solid line from the Capitol to the Jefferson Memorial

to get the full effect, because Maryland does not run straight through. It runs for a while and then disappears only to reappear again further toward the Memorial. However, you can easily see that the general direction runs precisely toward the Jefferson Memorial.

This is the compass of Freemasonry.

The Freemason's Square begins at Union Square, with Louisiana Avenue forming one arm and Washington Avenue the other. Again, you will have to draw a line down Louisiana Avenue and Washington to see the fully-formed square, because Louisiana ends at Pennsylvania and Washington ends at Maryland. The critical 900 angle of the square is pictorially missing; however, once you draw the natural continuation of Louisiana and Washington beyond their termination points you will see the 900 square perfectly formed.

The Freemason's Rule, or straightedge, is clearly seen if you draw a straight line south from the White House center to the base of the Washington Monument and then straight East to the Capitol.

Thus, all three of the sacred instruments of Freemasonry are depicted in the layout of these streets. As I stated earlier, the deliberate planning of these Governmental Buildings so that they would be laid out so as to represent these three sacred tools of Freemasonry, coupled with the Luciferic Goathead Pentagram, clearly tell us that the brand of Luciferic control and worship planned for this capitol city was Freemasonry. This clearly shows that the New World Order for which FreeMasonry has labored for so many years is Luciferic, their vigorous protestations to the contrary notwithstanding.



But there is more. Look again at the United States Capitol(above). At the extreme Eastern side of the Capitol, you can see two cul-de-sacs which are irregularly shaped. In fact, when you draw a bold black line carefully around these cul-de-sacs, and continue the black line around the Capitol, you get the appearance of a fat bunny's head, with the cul-de-sacs as his ears. This is not accidental, either. The head and ears of the bunny attach to the stick figures of the legs of the compass, which are meant to be the legs of the bunny. Further, the Mason's Square form stick-figure arms of the bunny. This representation is critically important, because ancient Satanists drew Satan in just this stick figure way, including the fat bunny head and his ears. This is another way of representing Satan.

And, just as the White House forms the southern point of the Goathead Pentagram, so the Capitol forms the head of Satan. Shockingly, the meaning is also the same. The Southern point of the Goathead Pentagram represented the spirit of Satan reaching into the mind of the goathead, the bunny's head

represents the same meaning. In other words, both the Executive and the Legislative Branches of Government are to be controlled by Satan.

In commemoration of the 190th anniversary of the birth of George Washington, 48 American flags representing the then 48 states of the Union, encircling the monument, were raised on February 22, 1922. The current configuration of the more durable aluminum flagpoles date to 1959, following the inclusion of Alaska and Hawaii into the Union as the 49th and 50th states. Let us now quickly look at the Washington Monument, which lies directly West of the Capitol. In fact, the Washington Monument lies on a straight line, precisely 900 West of the Capitol.

The Washington Monument(left) is the most important Presidential monument to the occultist, because it is an obelisk set inside a circle. What, you are probably saying, is an obelisk? An obelisk is a tall, four-sided stone pillar tapering toward a pyramidal top. The obelisk is critically important to the occultist because they believe that the spirit of the ancient Egyptian sun god, Ra, resided in the obelisk.

Thus, the obelisk represents the very presence of the sun god, whom the Bible calls Satan. There are four major obelisks that were erected by Freemasons in the 19th century. The first obelisk was brought to France from Thebes, Egypt, and was placed in Paris's Revolution Square the site of mass public guillotining during the Mason lead Bloody French Revolution. The second obelisk was brought to England from Alexandria, Egypt, and was placed next to the Thames river in London. The third obelisk was brought to America in 1881 from Alexandria, Egypt, and was placed in Central Park in New York City.

The fourth obelisk is the Washington Monument, built to commemorate our First President, George Washington(who was a Free Mason). In light of the symbols which we have just studied, which have been built into the layout of Government Center. The Washington Monument was constructed by Masons, according to Masonic tradition, as a symbol that this country was controlled by Freemasonry from the very beginning. The Washington Monument was constructed to honor the first Masonic President, was designed so that both the White House and the Capitol face toward it so that the leaders of both branches have to face the spirit of Lucifer thought to be residing in it. This is typical occultism.

One final interesting note. We reported earlier in this article that the Washington Monument obelisk was placed directly on a straight line, precisely 900 West of the Capitol. Thus, the inhabitants of the Capitol could face the obelisk daily. However, note that the Washington, D.C., obelisk does not lie in a straight line 900 South the White House. Why? Because it was lined so that it lies in a straight line 900

from the House of Understanding, the headquarters of FreeMasonry!! In the mind of the occultist, the true political Administrative power resides in this Freemasonry headquarters, not in the White House. This is why President Andrew Johnson considered himself to be the subordinate to Albert Pike, the leader of North American FreeMasonry!

Clearly, the power of leadership to drive this country toward the New World Order, leading the rest of the world, lies in FreeMasonry, not in the White House or the Congress. These symbols, built into the physical layout of Government Center in Washington, D.C., represent the extent of that power. Think of the many years these symbols have remained hidden from most people's knowledge; think of the millions of tourists which have walked on these streets during this time, without having any idea as to the existence of these symbols, not to mention their meaning! And, if you have ever driven a car in Washington D.C. area, you will now understand why these streets seem to be laid out so weird! Driving in Washington D.C. can be a nightmare. Now you know why.

I will challenge any one to try and disprove this information. The odds against this happening accidentally are so astronomical and ridiculous! Do you see irrefutable evidences of a conspiracy here? There is a small owl just to the left of the "1" which appears on the upper right hand corner of the Dollar Bill. But what does the owl symbolize? The owl is a symbol of wisdom. Owls can see in the dark. They can see what we cannot see. Likewise, members of the Illuminatiare privileged to information that is hidden from the general public.

The owl is a nocturnal bird of prey with strong talons. The owl has been associated with wisdom, books, Occult knowledge, shamanism and other spiritual matters. As mentioned, the owl is a bird of the night, so an association with the moon is also suggested. They have short tail feathers and are silent in flight, stealth like. They seem curious about things but are **happy to sit and wait until the time is right to obtain their goals (catch or conquer their prey).**

The demon goddess Lilith is represented throughout history as an owl. A study of the demon goddess of Lilith will reveal the dark secrets behind the owl of Bohemian grove.

Few magickal orders exist dedicated to the undercurrent of Lilith and deal in initiations specifically related to the Aracana of the first Mother. Two reputable organizations that progressively use initiations and magick associated with Lilith are the Ordo Antichristianus Illuminati and the Order of Phosphorus. Author Joshua Seraphim has written three texts associated with the egregore of Lilith entitled "Rite of Lilith," "Confessionis ex Lilitu," and the "Lamentations of Lilith."

Lilith appears as a succubus in Aleister Crowley's De Arte Magica. Lilith was also one of the middle names of Crowley's first child, Ma Ahathoor Hecate Sappho Jezebel Lilith Crowley (b. 1904, d.1906). She is sometimes identified with Babylon in Thelemic writings.

A Thelemic rite, based on an earlier German rite, offers the invocation of Lilith (warning: an article on how to summons Satan). Read here about the wicked witchcraft of Lilith, and how it relates to the OWL...



Lilith is the mythological first wife of Adam. She, like Adam, was created by God "from the dust of the earth. . . in the image of God He created them, male and female He created them" (Gen. 1:27) being the first reference to human life in the Bible. It would seem that Eve came later, fashioned from a rib taken from Adam while he slept: ". . . this is to be called Woman, for this was taken from Man". (Gen. 2:24) This strange anomaly can only be explained by assuming that there was a female human before Eve. Since only Eve is subsequently present in the Garden of Eden, her predecessor must have departed before Eve's arrival on the scene. One can only assume that Lilith's near total absence (aside from oblique references to "screech")

owls") from the Judeo/Christian Bible is a matter of prejudice on the part of the male patriarchal authors.

Semitic legend describes Lilith as having a "base" nature and a taste for biting Adam and drinking his blood. She had refused to submit to Adam's authority (and a preference for being "on top"), and in a fit of pique, she uttered the ineffable name of God and flew up into the air, only to be cast down by God into the desert wastes where she took up residence. (The only mention of Lilith by name in the standard Christian Bible is in Isaiah, where a passing reference is made about her living in the desert.) In modern mythology Lilith has become a symbol to many feminists of the independent woman, who refuses to submit to the control of men. While this is certainly an aspect of her egregore, there is a strong sexual component to Lilith's nature that must also be recognized. She is more than just an "uppity woman", she is the power of primal lust in female form. And also, she is Death, and this cannot be ignored when working with her magically.



Illuminati facts and history about the Secret Society

Their ideas were controversial and their members were considered so dangerous that the society was quickly banned. Some think members of the Illuminati are still active, working in secrecy trying to create a New World Order. The Illuminati Order still fascinates and frightens people, but who were these people really and what were their goals?



In this article, we examine facts and history about the Order of the Illuminati, one of the most dangerous secret societies that ever existed.

How and Why The Order Of The Illuminati Was Created

To understand why the Illuminati society was established, one must first understand how politics and religion influenced Europe in the 16th and 17th century. Our journey takes us back hundreds of years in time to Regensburg in Germany where the secret society was born. The Illuminati society was created on May 1, 1176 by Johann Adam Weishaupt, who was only 26 years at the time, but already a Professor.

He adopted the name of "Brother Spartacus" within the order. Weishaupt was fascinated with the current Renaissance ideals and scientific discoveries, such as Isaac Newton's breakthroughs in physics and Galileo Galilei's astronomical discoveries based in Copernicus previous theories and studies. People now knew that Earth was not the center of the Universe and our planet orbited the Sun and not the other way round. There were many secret societies in existence during this period and many felt there was a need to give people power to decide in important matters. The power and role of the authorities and Church were questioned. There was a need for a radical change in the society and Weishaupt thought he had the "perfect" solution.



Congress of Vienna, 1814-15

Many believe that the subversive goal of the Illuminati was to form a one world government. The Congress of Vienna was, according to these beliefs, brought about by the Illuminati who hoped to achieve their goal by forming a League of Nations. When Russia refused to join, however,

their plan was foiled creating, supposedly, a great deal of animosity towards the Russian powers within the Illuminati rank and file. Image credit: Freemason Info

Weishaupt lectured at the Ingolstadt University in Bayern and he was the only professor who was not a member of the Jesuit order. In 1773, Pope Clement XIV suppressed the Jesuits (also known as the Society of Jesus). This gave Weishaupt the opportunity to become a professor in canon law. The position had exclusively been held by a Jesuit up until that point. In his free time, Weishaupt spent hours discussing new ideas with member of other secret societies.

The Radical Agenda of The Illuminati

The Illuminati wanted to make fundamental changes in the society. Their goals were:

Abolition of all ordered governments

Abolition of private property

Abolition of inheritance

Abolition of patriotism

Abolition of the family (children should be raised by the society)

Abolition of religion

Creation of a world government



The greatest enemy of all, was religion that, according to Weishaupt prevented progresses in the society. The aim was to combat religion and foster rationalism in its place. Needless to say, that the Illuminati's ideas and goals were so controversial that the entire order and its members were soon considered a dangerous threat to the society.

The Illuminati Promoted Doctrines Of Equality And Freedom But Members Of The Order Were Under Constant Surveillance. Orders were given to put an end to the Illuminati. Authorities sent agents to infiltrate the society and collect sensitive information that could be used against the Order of the Illuminati.



Weishaupt and the Illuminati gained many followers across Europe

This was a challenging task because Illuminati's members were very cautious, secretive and never undertook unnecessary risks. When they wrote to each other they never mentioned the society's name – Illuminati. Instead they used a special sign that serves as a symbol of their society – a circle with a dot in the middle, a sign for the Shining Sun. All member used ancient Greek and Romans names as to hide their identity.



The all-seeing eye was a symbol used by the Illuminati.

Ironically, Weishaupt's agenda promoted free thinking and freedom, but his society certainly did not reflect these thoughts and the order was anything but democratic in nature. Weishaupt believed constant surveillance of the members created several advantages such as loyalty and

eliminated the risks of traitors. The actual workings of the order involved spies and counterspies. Each isolated cell of initiates answered to a supervisor, that none of the initiates knew. Weishaupt also set specific books and materials that all members had to read. Although Weishaupt's goal was "enlightenment" for its members and society as a whole, by its own rules and regulations it prevented free thought by its members.

The Illuminate Gained Many Followers and Must Be Banned

The Church and authorities started to become impatient. The Illuminati became more and more popular and the secret society gained many followers. Weishaupt wanted to create a large organization, but he had to work hard. He had to prevent that members of the Freemasons joined the Rosicrucian Order. Weishaupt had no respect for and disapproved of the Rosicrucian Order that engaged in worship of the occult and alchemy. "The thought that young men are trying to create gold and other nonsense is unacceptable to me," Weishaupt said. The Order of Illuminati existed for almost a decade before it was banned and eradicated by the authorities.



In 1784, writings from the Order were intercepted in Bavaria and the group was declared seditious banned.

Weishaupt lost his position at the university and fled Bavaria. Once Weishaupt left Bavaria the Order collapsed the Illuminati came to an end. In 1777, Weishaupt tried a second time to promote his ideologies. He joined the Masonic lodge "Theodor zum guten Rath" in Munich, but his Illuminati reforms were not welcome and rejected by the Freemasons. Knowing this, Weishaupt created a quasi-masonic society and recruited members from inside the fraternity. Weishaupt claimed that his system was "pure" masonry.

Weishaupt wrote four books on the Illuminati over a three-year period while in exile. They were A Complete History of the Persecutions of the Illuminati in Bavaria (1785), A Picture of Illuminism (1786), An Apology for the Illuminati (1786), and An Improved System of

Illuminism (1787). Weishaupt died in Gotha, Germany on November 18th, 1830. The society's influence is still felt today partly because of the profound association it formed with Freemasons.



The name "Vatican" was already in use in the time of the Roman Republic for a marshy area on the west bank of the Tiber across from the city of Rome. Under the Roman Empire, many villas were constructed there, after Agrippina the Elder (14 BC – 18 October AD 33) drained the area and laid out her gardens in the early 1st century AD. In AD 40, her son, Emperor Caligula (31 August AD 12–24 January AD 41; r. 37–41) built in her gardens a circus for charioteers (AD 40) that was later completed by Nero, the Circus Gaii et Neronis, usually called, simply, the Circus of Nero.

Even before the arrival of Christianity, it is supposed that this originally uninhabited part of Rome (the ager vaticanus) had long been considered sacred, or at least not available for habitation. A shrine dedicated to the Phrygian goddess Cybele and her consort Attis remained active long after the Constantinian Basilica of St. Peter was built nearby.

The particularly low quality of Vatican water, even after the reclamation of the area, was commented on by the poet Martial (40 – between 102 and 104 AD). Tacitus wrote, that in AD 69, the Year of the Four Emperors, when the northern army that brought Vitellius to power arrived in Rome, "a large proportion camped in the unhealthy districts of the Vatican, which resulted in many deaths among the common soldiery; and the Tiber being close by, the inability of the Gauls and Germans to bear the heat and the consequent greed with which they drank from the stream weakened their bodies, which were already an easy prey to disease".

The Vatican Obelisk was originally taken by Caligula from Heliopolis in Egypt to decorate the spina of his circus and is thus its last visible remnant. This area became the site of martyrdom of many Christians after the Great Fire of Rome in AD 64. Ancient tradition holds that it was in this circus that Saint Peter was crucified upside-down.

Opposite the circus was a cemetery separated by the Via Cornelia. Funeral monuments and mausoleums and small tombs as well as altars to pagan gods of all kinds of polytheistic religions were constructed lasting until before the construction of the Constantinian Basilica of St. Peter's in the first half of the 4th century. Remains of this ancient necropolis were brought to light sporadically during renovations by various popes throughout the centuries, increasing in frequency during the Renaissance until it was systematically excavated by orders of Pope Pius XII from 1939 to 1941.

The Constantinian basilica was built in 326 over what was believed to be the tomb of Saint Peter, buried in that cemetery. From then on, the area became more populated in connection with activity at the basilica. A palace was constructed nearby as early as the 5th century during the pontificate of Pope Symmachus (reigned 498–514).

The name Vatican city was first used in the Lateran Treaty, signed on 11 February 1929, which established the modern city-state. The name is taken from Vatican Hill, the geographic location of the state. "Vatican" is derived from the name of an Etruscan settlement, Vatica or Vaticum meaning garden, located in the general area the Romans called vaticanus ager, "Vatican territory".

The official Italian name of the city is Città del Vaticano or, more formally, Stato della Città del Vaticano, meaning "Vatican City State". Although the Holy See (which is distinct from the Vatican City) and the Catholic Church use Ecclesiastical Latin in official documents, the Vatican City officially uses Italian. The Latin name is Status Civitatis Vaticanæ; this is used in official documents by not just the Holy See, but in most official Church and Papal documents.







The Freemasons and the House of Rothschild

In 1789 Alexander Hamilton became the first Treasury Secretary of the United States. Hamilton was one of many Founding Fathers who were Freemasons. He had close relations with the Rothschild family which owns the Bank of England and leads the European Freemason movement. George Washington, Benjamin Franklin, John Jay, Ethan Allen, Samuel Adams, Patrick Henry, John Brown and Roger Sherman were all Masons.

Andrew Hamilton

Roger Livingston helped Sherman and Franklin write the Declaration of Independence. He gave George Washington his oaths of office while he was Grand Master of the New York Grand Lodge of Freemasons. Washington himself was Grand Master of the Virginia Lodge. Of the General Officers in the Revolutionary Army, thirty-three were Masons. This was highly symbolic since 33rd Degree Masons become Illuminated.

Populist founding fathers led by John Adams, Thomas Jefferson, James Madison and Thomas Painenone of whom were Masons- wanted to completely severe ties with the British Crown, but were overruled by the Masonic faction led by Washington, Hamilton and Grand Master of the St. Andrews Lodge in Boston General Joseph Warren, who wanted to "defy Parliament but remain loyal to the Crown". St. Andrews Lodge was the hub of New World Masonry and began issuing Knights Templar Degrees in 1769.

General Joseph Warren

All US Masonic lodges are to this day warranted by the British Crown, whom they serve as a global intelligence and counterrevolutionary subversion network. Their most recent initiative is the Masonic Child Identification Program (CHIP). According to Wikipedia, the CHIP programs allow parents the opportunity to create a kit of identifying materials for their child, free of charge. The kit contains a fingerprint card, a physical description, a video, computer disk, or DVD of the child, a dental imprint, and a DNA sample.

The First Continental Congress convened in Philadelphia in 1774 under the Presidency of Peyton Randolph, who succeeded Washington as Grand Master of the Virginia Lodge. The Second Continental Congress convened in 1775 under the Presidency of Freemason John Hancock. Peyton's brother William succeeded him as Virginia Lodge Grand Master and became the leading proponent of centralization and federalism at the First Constitutional Convention in 1787. The federalism at the heart of the US Constitution is identical to the federalism laid out in the Freemason's Anderson's Constitutions of 1723.

William Randolph became the nation's first Attorney General and Secretary of State under George Washington. His family returned to England loyal to the Crown. John Marshall, the nation's first Supreme Court Justice, was also a Mason. When Benjamin Franklin journeyed to France to seek financial help for American revolutionaries, his meetings took place at Rothschild banks. He brokered arms sales via German Mason Baron von Steuben. His Committees of Correspondence operated through Freemason channels and paralleled a British spy network. In 1776 Franklin became de facto Ambassador to France.

In 1779 he became Grand Master of the French Neuf Soeurs (Nine Sisters) Lodge, to which John Paul Jones and Voltaire belonged. Franklin was also a member of the more secretive Royal Lodge of Commanders of the Temple West of Carcasonne, whose members included Frederick Prince of Whales. While Franklin preached temperance in the US, he cavorted wildly with his Lodge brothers in Europe. Franklin served as Postmaster General from the 1750's to 1775 – a role traditionally relegated to British spies. With Rothschild financing Alexander Hamilton founded two New York banks, including Bank of

New York. He died in a gun battle with Aaron Burr, who founded Bank of Manhattan with Kuhn Loeb financing.

Hamilton exemplified the contempt which the Eight Families hold towards common people, once stating: "All communities divide themselves into the few and the many. The first are the rich and the well born, the others the mass of the people...The people are turbulent and changing; they seldom judge and determine right. Give therefore to the first class a distinct, permanent share of government. They will check the unsteadiness of the second." Hamilton was only the first in a series of Eight Families cronies to hold the key position of Treasury Secretary.

In recent times Kennedy Treasury Secretary Douglas Dillon came from Dillon Read (now part of UBS Warburg). Nixon Treasury Secretaries David Kennedy and William Simon came from Continental Illinois Bank (now part of Bank of America) and Salomon Brothers (now part of Citigroup), respectively. Carter Treasury Secretary Michael Blumenthal came from Goldman Sachs, Reagan Treasury Secretary Donald Regan came from Merrill Lynch (now part of Bank of America), Bush Sr. Treasury Secretary Nicholas Brady came from Dillon Read (UBS Warburg) and both Clinton Treasury Secretary Robert Rubin and Bush Jr. Treasury Secretary Henry Paulson came from Goldman Sachs.

Obama Treasury Secretary Tim Geithner worked at Kissinger Associates and the New York Fed. Thomas Jefferson argued that the United States needed a publicly-owned central bank so that European monarchs and aristocrats could not use the printing of money to control the affairs of the new nation. Jefferson extolled: "A country which expects to remain ignorant and free...expects that which has never been and that which will never be. There is scarcely a King in a hundred who would not, if he could, follow the example of Pharaoh – get first all the people's money, then all their lands and then make them and their children servants forever...banking establishments are more dangerous than standing armies. Already they have raised up a money aristocracy."

Jefferson watched as the Euro-banking conspiracy to control the United States unfolded, weighing in: "Single acts of tyranny may be ascribed to the accidental opinion of the day, but a series of oppressions begun at a distinguished period, unalterable through every change of ministers, too plainly prove a deliberate, systematic plan of reducing us to slavery". But the Rothschild-sponsored Hamilton's arguments for a private US central bank carried the day. In 1791 the Bank of the United States (BUS) was founded, with the Rothschilds as main owners. The bank's charter was to run out in 1811. Public opinion ran in favor of revoking the charter and replacing it with a Jeffersonian public central bank. The debate was postponed as the nation was plunged by the Euro-bankers into the War of 1812. Amidst a climate of fear and economic hardship, Hamilton's bank got its charter renewed in 1816.

Old Hickory, Honest Abe & Camelot

In 1828 Andrew Jackson took a run at the US Presidency. Throughout his campaign he railed against the international bankers who controlled the BUS. Jackson ranted, "You are a den of vipers. I intend to expose you and by Eternal God I will rout you out. If the people understood the rank injustices of our money and banking system there would be a revolution before morning." Jackson won the election and revoked the bank's charter stating: "The Act seems to be predicated on an erroneous idea that the present

shareholders have a prescriptive right to not only the favor, but the bounty of the government...for their benefit does this Act exclude the whole American people from competition in the purchase of this monopoly.

"Present stockholders and those inheriting their rights as successors be established a privileged order, clothed both with great political power and enjoying immense pecuniary advantages from their connection with government. "Should its influence be concentrated under the operation of such an Act as this, in the hands of a self-elected directory whose interests are identified with those of the foreign stockholders, will there not be cause to tremble for the independence of our country in war... controlling our currency, receiving our public monies and holding thousands of our citizens independence, it would be more formidable and dangerous than the naval and military power of the enemy.

"It is to be regretted that the rich and powerful too often bend the acts of government for selfish purposes... to make the rich richer and more powerful. Many of our rich men have not been content with equal protection and equal benefits, but have besought us to make them richer by acts of Congress. I have done my duty to this country." By 1861 the US was \$100 million in debt. New President Abraham Lincoln snubbed the Euro-bankers again, issuing Lincoln Greenbacks to pay Union Army bills.

The Rothschild-controlled Times of London wrote:

"If that mischievous policy, which had its origins in the North American Republic, should become indurated down to a fixture, then that Government will furnish its own money without cost. It will pay off its debts and be without debt. It will have all the money necessary to carry on its commerce. It will become prosperous beyond precedent in the history of the civilized governments of the world. The brains and the wealth of all countries will go to North America. That government must be destroyed, or it will destroy every monarchy on the globe." The Euro-banker-written Hazard Circular was exposed and circulated throughout the country by angry populists.

It stated:

"The great debt that capitalists will see is made out of the war and must be used to control the valve of money. To accomplish this government bonds must be used as a banking basis. We are now awaiting Secretary of Treasury Salmon Chase to make that recommendation. It will not allow Greenbacks to circulate as money as we cannot control that. We control bonds and through them banking issues".

The 1863 National Banking Act reinstated a private US central bank and Chase's war bonds were issued. Lincoln was re-elected the next year, vowing to repeal the act after he took his January 1865 oaths of office. Before he could act, he was assassinated at the Ford Theatre by John Wilkes Booth. Booth had major connections to the international bankers. His granddaughter wrote This One Mad Act, which details Booth's contact with "mysterious Europeans" just before the Lincoln assassination. Following the Lincoln hit, Booth was whisked away by members of a secret society known as Knights of the Golden Circle (KGC). KGC had close ties to the French Society of Seasons, which produced Karl Marx.

KGC had fomented much of the tension that caused the Civil War and President Lincoln had specifically targeted the group. Booth was a KGC member and was connected through Confederate Secretary of State Judah Benjamin to the House of Rothschild. Benjamin fled to England after the Civil War. Nearly a century after Lincoln was assassinated for issuing Greenbacks,

President John F. Kennedy found himself in the Eight Families' crosshairs. Kennedy had announced a crackdown on off-shore tax havens and proposed increases in tax rates on large oil and mining companies. He supported eliminating tax loopholes which benefit the super-rich. His economic policies were publicly attacked by Fortune magazine, the Wall Street Journal and both David and Nelson Rockefeller.

Even Kennedy's own Treasury Secretary Douglas Dillon, who came from the UBS Warburg-controlled Dillon Read investment bank, voiced opposition to the JFK proposals. Kennedy's fate was sealed in June 1963 when he authorized the issuance of more than \$4 billion in United States Notes by his Treasury Department in an attempt to circumvent the high interest rate usury of the private Federal Reserve international banker crowd. The wife of Lee Harvey Oswald, who was conveniently gunned down by Jack Ruby before Ruby himself was shot, told author A. J. Weberman in 1994:

"The answer to the Kennedy assassination is with the Federal Reserve Bank. Don't underestimate that. It's wrong to blame it on Angleton and the CIA per se only. This is only one finger on the same hand. The people who supply the money are above the CIA". Fueled by incoming President Lyndon Johnson's immediate escalation of the Vietnam War, the US sank further into debt. Its citizens were terrorized into silence. If they could kill the President they could kill anyone.

The House of Rothschild

The Dutch House of Orange founded the Bank of Amsterdam in 1609 as the world's first central bank. Prince William of Orange married into the English House of Windsor, taking King James II's daughter Mary as his bride.

The Orange Order Brotherhood, which recently fomented Northern Ireland Protestant violence, put William III on the English throne where he ruled both Holland and Britain. In 1694 William III teamed up with the UK aristocracy to launch the private Bank of England.

The Old Lady of Threadneedle Street- as the Bank of England is known- is surrounded by thirty foot walls. Three floors beneath it the third largest stock of gold bullion in the world is stored. The Rothschilds and their inbred Eight Families partners gradually came to control the Bank of England. The daily London gold "fixing" occurred at the N. M. Rothschild Bank until 2004.

As Bank of England Deputy Governor George Blunden put it:

"Fear is what makes the bank's powers so acceptable. The bank is able to exert its influence when people are dependent on us and fear losing their privileges or when they are frightened." [16] Mayer Amschel Rothschild sold the British government German Hessian mercenaries to fight against American Revolutionaries, diverting the proceeds to his brother Nathan in London, where N.M. (Nathan and Mayer) Rothschild & Sons was established. Mayer was a serious student of Cabala and launched his fortune on money embezzled from William IX- royal administrator of the Hesse-Kassel region and a prominent Freemason. Rothschild-controlled Barings bankrolled the Chinese opium and African slave trades. It financed the Louisiana Purchase.

When several states defaulted on its loans, Barings bribed Daniel Webster to make speeches stressing the virtues of loan repayment. The states held their ground, so the House of Rothschild cut off the money spigot in 1842, plunging the US into a deep depression. It was often said that the wealth of the Rothschilds depended on the bankruptcy of nations.

Mayer Amschel Rothschild once said:

"I care not who controls a nation's political affairs, so long as I control its currency".

War didn't hurt the family fortune either. The House of Rothschild financed the Prussian War, the Crimean War and the British attempt to seize the Suez Canal from the French. Nathan Rothschild made a huge financial bet on Napoleon at the Battle of Waterloo, while also funding the Duke of Wellington's peninsular campaign against Napoleon. Both the Mexican War and the Civil War were goldmines for the family.

Nathan Rothschild

One Rothschild family biography mentions a London meeting where an "International Banking Syndicate" decided to pit the American North against the South as part of a "divide and conquer" strategy.

German Chancellor Otto von Bismarck once stated:

"The division of the United States into federations of equal force was decided long before the Civil War. These bankers were afraid that the United States... would upset their financial domination over the world. The voice of the Rothschilds prevailed." Rothschild biographer Derek Wilson says the family was the official European banker to the US government and strong supporters of the Bank of the United States. [17] Family biographer Niall Ferguson notes a "substantial and unexplained gap" in private Rothschild correspondence between 1854-1860. He says all copies of outgoing letters written by the London Rothschilds during this Civil War period "were destroyed at the orders of successive partners". [18]

French and British troops had, at the height of the Civil War, encircled the US. The British sent 11,000 troops to Crown-controlled Canada, which gave safe harbor to Confederate agents. France's Napoleon III installed Austrian Hapsburg family member Archduke Maximilian as his puppet emperor in Mexico, where French troops massed on the Texas border. Only an 11th-hour deployment of two Russian warship fleets by US ally Czar Alexander II in 1863 saved the United States from re-colonization. [19]

That same year the Chicago Tribune blasted:

"Belmont (August Belmont was a US Rothschild agent and had a Triple Crown horse race named in his honor) and the Rothschilds...who have been buying up Confederate war bonds."

Salmon Rothschild said of a deceased President Lincoln:

"He rejects all forms of compromise. He has the appearance of a peasant and can only tell barroom stories."

Baron Jacob Rothschild was equally flattering towards the US citizenry.

He once commented to US Minister to Belgium Henry Sanford on the over half a million Americans who died during the Civil War: "When your patient is desperately sick, you try desperate measures, even to bloodletting." Salmon and Jacob were merely carrying forth a family tradition. A few generations earlier Mayer Amschel Rothschild bragged of his investment strategy, "When the streets of Paris are running in blood, I buy". [20] Mayer Rothschild's sons were known as the Frankfurt Five. The eldest – Amschel – ran the family's Frankfurt bank with his father, while Nathan ran London operations.

Youngest son Jacob set up shop in Paris, while Salomon ran the Vienna branch and Karl was off to Naples. Author Frederick Morton estimates that by 1850 the Rothschilds were worth over \$10 billion.

[21] Some researchers believe that their fortune today exceeds \$100 trillion. The Warburgs, Kuhn Loebs, Goldman Sachs, Schiffs and Rothschilds have intermarried into one big happy banking family. The Warburg family- which controls Deutsche Bank and BNP- tied up with the Rothschilds in 1814 in Hamburg, while Kuhn Loeb powerhouse Jacob Schiff shared quarters with Rothschilds in 1785.

Schiff immigrated to America in 1865. He joined forces with Abraham Kuhn and married Solomon Loeb's daughter. Loeb and Kuhn married each others sisters and the Kuhn Loeb dynasty was consummated. Felix Warburg married Jacob Schiff's daughter. Two Goldman daughters married two sons of the Sachs family, creating Goldman Sachs. In 1806 Nathan Rothschild married the oldest daughter of Levi Barent Cohen, a leading financier in London. [22] Thus, Merrill Lynch super-bull Abby Joseph Cohen and Clinton Secretary of Defense William Cohen are likely descended from Rothschilds.

Today the Rothschild's control a far-flung financial empire, which includes majority stakes in most world central banks. The Edmond de Rothschild clan owns the Banque Privee SA in Lugano, Switzerland and the Rothschild Bank AG of Zurich. The family of Jacob Lord Rothschild owns the powerful Rothschild Italia in Milan.

They are founding members of the exclusive \$10 trillion Club of the Isles – which controls corporate giants Royal Dutch Shell, Imperial Chemical Industries, Lloyds of London, Unilever, Barclays, Lonrho, Rio Tinto Zinc, BHP Billiton and Anglo American DeBeers. It dominates the world supply of petroleum, gold, diamonds, and many other vital raw materials. [23] The Club of the Isles provides capital for George Soros' Quantum Fund NV – which made substantial financial gains in 1998-99 following the collapse of currencies of Thailand, Indonesia and Russia. Soros was a major shareholder at George W. Bush's Harken Energy.

The Club of Isles is led by the Rothschilds and includes Queen Elizabeth II and other wealthy European aristocrats and Nobility. [24] Perhaps the largest repository for Rothschild wealth today is Rothschilds Continuation Holdings AG – a secretive Swiss-based bank holding company. By the late 1990s scions of the Rothschild global empire were Barons Guy and Elie de Rothschild in France and Lord Jacob and Sir Evelyn Rothschild in Britain. [25]







Judith Ann Schiff, Chief Research Archivist at the Yale University Library, has written: "The names of its members weren't kept secret—that was an innovation of the 1970s—but its meetings and practices were." While resourceful researchers could assemble member data from these original sources, in 1985, an anonymous source leaked rosters to Antony C. Sutton. This membership information was kept privately for over 15 years, as Sutton feared that the photocopied pages could somehow identify the member who leaked it. He wrote a book on the group, America's Secret Establishment: An Introduction to the Order of Skull and Bones. The information was finally reformatted as an appendix in the book Fleshing out Skull and Bones, a compilation edited by Kris Millegan and published in 2003.

Among prominent alumni are former President and Chief Justice William Howard Taft (a founder's son); former **Presidents and father and son George H. W. Bush and George W. Bush**; Supreme Court Justices Morrison R. Waite and Potter Stewart; James Jesus Angleton, "mother of the Central Intelligence Agency"; Henry Stimson, U.S. Secretary of War (1940-1945); U.S. Secretary of Defense (1951-1953) Robert A. Lovett, William B. Washburn, Governor of Massachusetts; and Henry Luce, founder and publisher of Time, Life, Fortune, and Sports Illustrated magazines.

John Kerry, former U.S. Secretary of State and former U.S. Senator; Stephen A. Schwarzman, founder of Blackstone Group; Austan Goolsbee, Chairman of Barack Obama's Council of Economic Advisers; Harold Stanley, co-founder of Morgan Stanley; and Frederick W. Smith, founder of FedEx, are all reported to be members. In the 2004 U.S. Presidential election, both the Democratic and Republican nominees were alumni. George W. Bush wrote in his autobiography, "[In my] senior year I joined Skull and Bones, a secret society; so secret, I can't say anything more." When asked what it meant that he and Bush were both Bonesmen, former Presidential candidate John Kerry said, "Not much, because it's a secret."



The Judeo-Masonic Conspiracy

The bloodlines of the Illuminati



Most prominent members of the Rothschild family

I would like to start clarifying that by "bloodlines of the Illuminati", I am not referring to Weishaupt's original order, but to those families that funded Weishaupt and who would later be also known as the "Illuminati". Mayer Amschel Rothschild successfully kept the fortune in the family through endogamy (with carefully arranged marriages between second and first cousins and other members of the family). He had 5 sons:

The first born was Amschel Mayer Rothschild, in 1773. On the death of his father in 1812, he succeeded as head of the bank at Frankfurt-am-Main (Germany), and died childless in 1855. [1]

The second was Salomon Mayer Rothschild, born in 1774. He was sent to Vienna (Austria) in 1820 to formalize the family's existing involvements in financing Austrian government projects. His bank, the S M von Rothschild, financed various government undertakings where large amounts of capital had to be

raised. He made connections amongst the country's aristocracy and its political elite, and in recognition of his services he was made part of the Austrian nobility when awarded the hereditary title "Freiherr" (Baron) in 1822. In 1824 he married his own niece, the daughter of his brother Jacob. In 1843, he became the first Jew to ever be given honorary Austrian citizenship. Under his control the Viennese bank was highly successful, but the concentration of wealth in the hands of a few members of the elite resulted in a growing civil unrest in the country, a national anti-Rothschild sentiment, and ultimate in the involvement of Austria in the revolutions of 1848; after which Solomon left the business in the hands of his son, Anselm Salomon, and retired to Paris; where he died in 1855. [2]

The third born, in 1777, was Nathan Mayer Rothschild. In 1798 he was sent to England, and began to deal on the London stock exchange in financial instruments such as foreign bills of exchange and government securities. From 1811 he undertook the transfer of money to pay Wellington's troops (against Napoleon). Nathan's four brothers helped to co-ordinate the activities across the continent, and the family developed a network of agents, shippers and couriers to transport gold and information across Europe. This private intelligence service enabled Nathan to receive in London the news of Wellington's victory at the Battle of Waterloo a full day ahead of the government's official messengers (which he allegedly used to deceive other investors in the London Stock Exchange, making him a fortune; though Rothschild researchers, and others, deny these allegations).

In 1818 he arranged a £5 million loan to the Prussian government and the issuing of bonds for government loans formed a mainstay of his bank's business. He gained a position of such power in the City of London that by 1825/6 that he was able to supply coins to the Bank of England. He was also known for his role in the abolition of the slave trade; however, records from the National Archives examined in 2009 show that Nathan financially benefited from slavery. In 1869, his grandson became a director of the Bank of England, a post he held for 20 years. The Rothschild bank also funded Cecil Rhodes in the development of the British South Africa Company and the Rothschild family administered Rhodes's estate after his death in 1902, and helped to set up the Rhodes Scholarship scheme [3] (which many presidents, UN key figures, politicians and government officials worldwide would receive). [4]

The fourth born was Calmann Mayer Rothschild, in 1788. The 1821 occupation of Naples by the Austrian army provided the opportunity for Calmann (Carl) to set up his business in the Kingdom. As such, Carl was sent to Naples where he established C M de Rothschild & Figli to operate as a satellite office to the Rothschild banking family in Germany. He established a good working relationship with Luigi de' Medici, the "Direttore della Segreteria di Azienda del Regno di Napoli" (Finance Minister), and his operation became the dominant banking house in Naples. In 1829, Carl was appointed consul-general of Sicily at Frankfurt and in January 1832 the Jewish banker was given a ribbon and star of the Sacred Military Constantinian Order of Saint George at a ceremony with the new Roman Catholic Pope, Gregory XVI. [5]

Jacob (James) Mayer Rothschild was the last born in 1792, but I've already explained his success in Paris in the previous chapter. However, it's worth mentioning that many Rothschilds were, and are, supporters of the State of Israel, although others oppose it. Either way, James' grandson, Edmond Benjamin James de

Rothschild, was a strong supporter of Zionism, and his generous donations lent significant support to the movement during its early years which helped lead to the establishment of the State of Israel. [6] He was also a patron of the first settlement in Palestine at Rishon-LeZion, and bought from Ottoman landlords many parts of the land which now makes up present-day Israel. In 1917 Walter Rothschild was the addressee of the Balfour Declaration, which committed the British government to the establishment in Palestine of a national home for the Jewish people. James A. de Rothschild financed the Knesset building as a gift to the State of Israel. The Supreme Court of Israel building was donated to Israel by Dorothy de Rothschild; [7] Outside the President's Chamber is displayed the letter Mrs Rothschild wrote to Prime Minister Shimon Peres expressing her intention to donate a new building for the Supreme Court. [8]

After amassing huge fortunes, the name Rothschild became synonymous with extravagance and great wealth. By the end of the century, the family owned, or had built, at the lowest estimates, over 41 palaces, of a scale and luxury perhaps unparalleled even by the richest Royal families. [9] The British Prime Minister Lloyd George claimed, in 1909, that Lord Nathan Rothschild was the most powerful man in Britain. [10] The business magazine referred to Mayer Amschel Rothschild as the "founding father of international finance", and Forbes magazines as the "20th most influential businessmen of all times". [1]

From the mid 19th century, many people had their eyes on the Rothschilds and their activities. Suspicion and an anti-Rothschild sentiment spread throughout Europe. It was time to keep a low public profile and to put in place a network of frontmen to take care of their businesses. By the later 19th century, almost all Rothschilds had started to marry outside the family, usually into the aristocracy or other financial dynasties, like the: Warburg, Oppenheim, House of Bonaparte, Wellington, Guinness, House of Borghese, Ephrussi, Walpole, Wodehouse, and many others.

The Conquest of the new world

Once the most powerful European monarchies were under control -with the help of other bankers like Lennap and Lawatz, which allowed the Rothschild family to obtain interests and speculate with their wealth and control throughout the whole of Europe [1]-; And with the Catholic Church eating from their hand —as the Rothschilds allegedly managed their financial operations worldwide since 1823 [2][*]- the Rothschild family set their eyes in the New World again.

In 1811 the charter for the first Bank of the United States was due, and the congress had already voted against it. However, Nathan would not give up that easy, and issued an ultimatum to the former colonies: "Either the application for the renewal of the charter is granted, or the United States will find itself involved in a most disastrous war." Andrew Jackson (by then President of the United States) did not believe the power of the international moneylenders could extend so far, so he replied: "I intend to rout you out, and by the Eternal God, I will rout you out!" Which resulted in Nathan issuing the following orders to the British government: "Teach these impudent Americans a lesson. Bring them back to Colonial status." The British Government then launched the War of 1812 against the United States. During 1815, in what would be one of Nathan's most famous quotes, he said: "I care not what puppet is placed upon the throne of England to rule the Empire on which the sun never sets. The man that controls Britain's money supply controls the British Empire." [3] He achieved his objective, and the U.S. Congress granted the renewal of the Charter in 1816.

Abraham Lincoln was elected President of the United States in 1860. Being short of money to finance the North's war effort of the American Civil War, he went to the bankers of New York, who agreed to lend him money at interest rates varying from 24 to 36 percent. Lincoln refused, knowing perfectly well that this was usury and that it would lead the United States to ruin. So, in full conformity with the provisions of the U.S. Constitution, Lincoln issues \$450 million of debt-free "Greenbacks". Lincoln called these Greenbacks "the greatest blessing the American people have ever had." A blessing for all, except for the bankers, since it was putting an end to their racket, to the stealing of the nation's credit and issuing interest-bearing money.

The bankers did everything possible to destroy these Greenbacks and sabotage Lincoln's work. First, in order to cast discredit on the Greenbacks, the bankers persuaded Congress to vote, in February of 1862, the "Exception Clause", which said that the Greenbacks could not be used to pay the interest on the national debt, nor to pay taxes, excises, or import duties. Then, in 1863, having financed the election of enough Senators and Representatives, the bankers got the Congress to revoke the Greenback Law in 1863, and enact in its place the National Banking Act; which issued interest-bearing by privately-owned banks. This Act also provided that the Greenbacks should be retired from circulation as soon as they came back to the Treasury in payment of taxes. Lincoln heatedly protested, but his most urgent objective was to win the war and save the Union, which obliged him to put off till after the war the veto he was planning

against this Act and the action he was to take against the bankers. Lincoln nevertheless declared: "I have two great enemies, the Southern army in front of me and the bankers in the rear. And of the two, the bankers are my greatest foe."

Lincoln was re-elected President in 1864, and he made it quite clear that he would attack the power of the bankers, once the war was over. The war ended on April 9, 1865, but Lincoln was assassinated five days later, on April 14.

Lincoln inspired other politicians to follow his examples (like presidential candidate William Jennings Bryan); but the banker were determined to end with the problem once and for all. So, In 1910, the 6 most influential bankers in the US attended a secret meeting In Jekyll Island as J P Morgan's guests. For the next week, Nelson Aldrich Rockefeller and Frank A. Vanderlip (From two Rockefeller's banks), Henry P. Davidson and Charles D. Norton (from two J.P. Morgan's banks), Paul Warburg, and assistant treasury secretary A. P. Andrew planned the new central banking act. [4] Just before Christmas 1913, taking advantage of the fact that most congressmen were on holiday, the U.S. Congress passed the Federal Reserve Act, which President Woodrow Wilson signed. This act took away from Congress the power to create money, and handed over this power to the Federal Reserve Corporation, owned by the bankers. One of the rare Congressmen who understood against this Act was Representative Charles A. Lindbergh Sr. (father of the famous aviator Charles Lindbergh), who said: "This Act establishes the most gigantic trust on earth. When the President [Woodrow Wilson] signs this bill, the invisible government of the Monetary Power will be legalized... The worst legislative crime of the ages is perpetrated by this banking and currency bill."

The Illuminati in America

My conclusion that the American Founding Fathers -and in fact most revolutionaries since- followed the Illuminati's revolutionary philosophy is confirmed by Dr. James Billington (librarian of the US

Congress), which stated: "The revolutionary ideology of the 18th and 19th century ... was shaped not so much by the ... rationalism of the French Enlightenment (as is generally believed) ... as by the occultism and pro-romanticism of Germany ..." [1] However, this in no proof that the Founding Fathers, nor the American freemasons, were successfully infiltrated by the Illuminati.

Many believe that the Illuminati reached America through the Freemasons, and there is no doubt that Washington also believed the doctrines of the Illuminati were present there; as we saw in his letter to Reverend G. W. Snyder (see chapter 3: The American Revolution). In response to this letter, Reverend Snyder sent Washington a copy of the book "Proofs of a conspiracy", in which John Robison exposes Freemasonry as being infiltrated by the Illuminati. [2] Washington replied back to the Reverend, in a letter sent 15 months before his death in 1799, and cleared his involvement with Freemasonry by saying: "... to correct an error you have run into, of my Presiding over the English lodges in this Country. The fact is, I preside over none, nor have I been in one more than once or twice, within the last thirty years." [3] Washington also told the Reverend that he didn't share his opinion about the Illuminati's present in American through Freemasonry; instead, he was convinced that the Illuminati reached America through the Jacobins (the radical French group that launched the French Revolution).

Many writers and historians agree with Washington and have concluded that the power behind the Jacobin Club was in fact the Illuminati. In this respect, I have already shown that the connection between Weishaupt and Robespierre -a key figure in the creation of the Jacobin Club- is an historical fact (see chapter 4: Adam Weishaupt and the Bavarian Illuminati). In regards to the Illuminati in America, it is well documented that many Jacobins went there, and tried to stir a second revolution through various groups, known as the democratic clubs. After overthrowing King Louis XVI in France, the Jacobins sent an ambassador to America, Edmond-Charles Genêt, to build support for the French Revolution. [4] Washington preferred to keep America neutral. In fact all the Founding Fathers —except Franklin and Jefferson-were appalled by the French Revolution, for it was reckless and bloody. But Genêt was determined to involve America, even if it meant overthrowing Washington and his newly created government. A proof of the extent to which Genêt would go can be found in a letter from John Adams to Thomas Jefferson, in which he says: "You certainly neverfelt the terrorism excited by Genêt in 1793. When 10,000 people in the streets of Philadelphia, day after day, threaten to drag Washington out of his house and affect a revolution in the government, or compel it to declare war in favour of the French Revolution." [5]

But Jefferson was a firm supporter of the Jacobins, the Illuminati and Genêt; and was not concern about the bloodbath in France, at the contrary, in his own words, he would prefer to see half of the earth desolated than seeing the French Revolution fail. [6] But even then, we would have problems associating Jefferson to any secret society; which is actually the opposite case than with Franklin —which was confirmed to belong to far too many-. Jefferson's membership to any secret society could never be proved, and it is an issue that is still widely debated to this day. The only way to irrefutably confirm if an historical figure is a freemason is through the membership records of the lodge he was initiated in, and it is a fact that Jefferson was not initiated in any American lodge. However, what is not clear is if he was initiated into the Grand Orient of France -to which Franking and other key Jacobin and French

revolutionary figures also belonged to-during his role as the American ambassador in France from 1785 to 1789. [7] As a matter of fact, Jefferson offered his residence in France as a meeting place for the French rebels, [8] and was reported to have attended meetings at the Lodge of the Nine Sisters in Paris, part of the Grand Orient of France; [9] the same lodge, as we already saw, that was effectively infiltrated by the Illuminati, and the starting point for the French Revolution.

So it's clear to me that Washington was definitely not an agent of the Illuminati, though he supported Weishaupt's philosophy; and, even though he was deceived to allow the central bank by Alexander Hamilton (on the payroll of the bankers), it was clearly not in his original plans to have a central bank; which also clears him from being a Rothschild agent. On the other hand, Jefferson surely supported Jacobins—and therefore, of the Illuminati—, though he opposed the Rothschild's attempt to create a central bank in America; which I'm afraid also clears him from the banker's conspiracy, though it cannot be confirmed if he was a member of the Illuminati—(as his membership to any secret society cannot be verified).
